Legal Update

- Administration and Budget Update/Carri's List
 - a. Highlights of Resolutions

Ms. Brown provided highlights of resolutions.

The IT Department proposed the approval of the social media policy following its vetting among a work group and the Data Board. All elected officials and department heads had opportunity to review the policy and provide input and feedback.

The Engineer proposed approval of the annual highway mileage certification for the Ohio Department of Transportation and the purchase of equipment under the state purchasing program.

The Clerk of Courts proposed an amendment to the current lease for the Title Department in Pickerington to reflect the new owner of the building that is leased. The amendment has been approved to form by the County Prosecutor.

There were multiple financial resolutions to approve, such as:

- Account to account transfers of appropriations to allow for proper classification of expenditures for the Clerk of Courts Legal Department;
- Appropriations from unappropriated funds for EMA, FCFACF, REA, and Adult Community Corrections special revenue funds; and
- The traditional bill list and/or "then and now" related approvals.
- b. Administrative Approvals & Budget Update

The review packet contained a list of administrative approvals for the week. Ms. Brown asked if there were questions, and there were none.

Ms. Brown reported that there were no budget updates at this time.

c. Jail and Public Safety facility Update

Commissioner Davis reported that he had just met with Ms. Brown and Mr. Keller to discuss the jail construction. The project is on time and is still operating within the Guaranteed Maximum Price (GMP). The pilings will be completed this month.

Ms. Brown reported that Mr. Keller holds regular meetings with Granger, and Granger continues to progress very well. We continue to monitor the project.

The review packet contained Granger's January report. There were no problems to report with the project. Ms. Brown pointed out the "dashboard" elements of the Granger report.

At the end of last week, the jail population was 215. Last night, it was 207.

d. Roundtable - February 11th - Debriefing

Ms. Brown reported that the Board of County Commissioners hosted a quarterly roundtable for elected officials and department heads on February 11. Participants indicated that the content of the agenda was relevant and helpful.

We encourage all to review the checklist for follow up actions to be taken.

The slide show for the records center planning was sent to all elected officials and department heads. We will hear more about the timekeeping work group, and the resolution for the policy manual update is on schedule for February 23.
