REGULAR MEETING #06-27 FAIRFIELD COUNTY COMMISSIONERS' OFFICE JUNE 27, 2006

PUBLIC HEARING - FY2006 CDBG HEARING #2

The Board of Commissioners convened the second public hearing on the FY2006 CDBG program. Present at this hearing were Judith Shupe, Mike Kiger, Jon Myers, Brooks Davis, James Mako, Ed Pool, Jim Laws...... and Jackie Long. Commissioner Shupe read the attached prepared statement to open the hearing and invited comments on the proposed allocations. She noted that, as always, the county had more applications than funds available. The Commissioners prioritize projects and try to spread the dollars equitably around the county. She encouraged townships and villages that were not funded to re-apply. Mr. Davis concurred with this statement, adding that the Village of Pleasantville has applied for three or four consecutive years for the Municipal Building Improvements which will be awarded FY2006 funding. The ratio of applications to funds is nearly always three or four to one, he noted, and while the need for funds continues to rise, CDBG funds have been cut nationwide. In response to a question by Commissioner Myers, Mr. Davis explained that projects that receive FY2006 funds must be completed by December 31, 2007. Commissioner Myers asked if any of the projects that have been awarded funding have a problem with this deadline and all responded they did not. Mr. Pool, Rushcreek Township Trustee, thanked the Commissioners for sticking to their word in funding projects that have applied in multiple years. Rushville Mayor Jim Laws stated that, if one of the awarded projects for some reason cannot proceed, Rushville would request that any available funds be reallocated to them. The village is in the process of revamping its wastewater system and extending lines to a new school. Commissioner Shupe responded that the Commissioners have in the past reallocated funds when they become available. The Village of Pleasantville representative thanked the Board for allocating funds this year. With no further comment to come before the Board, the hearing was adjourned at 9:45 a.m.

INTRODUCTION TO STATE JFS ACCREDITATION TEAM

The Board of Commissioners met briefly with Job and Family Services Director Michael Orlando and Warren Brown of the state JFS accreditation team at 10:15 a.m. Mr. Brown introduced himself as Team Leader of the Council of Accreditation, which examines agencies against universal standards of accreditation. Preliminary results of the accreditation process indicate that Fairfield County's Job and Family Services has a unique staff providing quality service in an atmosphere in which it is clear that the PAGE 7 - MINUTES - JUNE 27, 2006

consumer is the priority. The well-trained staff clearly respects the consumers, he stated. While the exit interview is scheduled for Wednesday morning, Mr. Brown stated he anticipates there will be no compliance issues to which the county will need to respond. After the exit interview, the preliminary report will be forwarded to New York for final review and comment and returned to Mr. Orlando in about 45 days. He estimated that final accreditation would be within three months. The distinction of accreditation tells everyone that the agency is a quality operation, he concluded. Commissioner Myers asked if the accreditation process was a federal program. Mr. Brown explained that it is actually a private, non-profit program that provides accreditation review for human

services agencies based on nationally standardized service delivery benchmarks. In response to Commissioner Myers, Mr. Brown noted that accreditation helps an agency in applying for grants and reimbursement dollars and puts an agency in an elite group at the national level. The accreditation should be renewed about every four years, he added. Mr. Brown asked several questions of the Commissioners in reference to the Board's process in measuring the effectiveness of the agency in following its strategic plan. The Commissioners explained that quarterly meetings, monthly written reports and monthly department heads meetings are all employed to provide them with information on the agency's progress. He asked about the process by which emergencies are handled. The Commissioners indicated that, upon addressing the situation, Mr. Orlando contacts the President of the Board of Commissioners to notify the Board of the situation and provides frequent updates on any ongoing situations until the issue is resolved. The Commissioners added that the agency is extremely professional in its handling of any situation. Mr. Brown indicated that it is evident that the Commissioners have their fingers on the pulse of providing human services and thanked them for their time.

REVIEW SESSION

The Board of Commissioners met to review correspondence and pending and future agenda items at 10:30 a.m. Present at this review session were Judith Shupe, Mike Kiger, Jon Myers, Julia Hilty and Jackie Long.

MEETING WITH AUNDREA CORDLE/HUMAN RESOURCES UPDATE

The Board of Commissioners met with Human Resources Director Aundrea Cordle for a human resources update at 11:00 a.m. Present at this meeting were Judith Shupe, Mike Kiger, Jon Myers, Aunie Cordle and Jackie Long. Ms. Cordle updated the Board on current health insurance trends. Fairfield County employees are being very good consumers of the health benefits, she stated, utilizing generic prescriptions and avoiding emergency room visits in favor of doctor's office appointments whenever possible. The process of gathering RFP's for medical, vision, prescription and life insurance is underway, she explained. Additionally, the Franklin County Commissioners have approved a recommendation to utilize the UHC Health Risk Assessment tool through which county employees who participate in an on-line wellness assessment will receive a \$25 gift card. There is a potential for this program to be implemented for all participating counties.

MEETING WITH JUDGE PATRICK HARRIS

The Board of Commissioners met with Fairfield County Municipal Court Presiding Judge Patrick Harris at 11:45 a.m. regarding personnel. Present at this meeting were Judith Shupe, Mike Kiger, Jon Myers, Judge Harris, Municipal Court Administrator Micki Humes, Aundrea Cordle and Jackie Long. The meeting was scheduled to discuss funding of a municipal court probation officer position, for which the city will soon be seeking a replacement in light of a recent resignation. Judge Harris opened the meeting by stating that the County Commissioners are probably under no statutory obligation to fund the municipal court probation officer position which the county has funded since 1999. In fact, the responsibility may lie with the townships. Additionally, the PAGE 8 - MINUTES - JUNE 27, 2006

city agrees with county personnel that the situation of having a city employee paid by the county and operating under county policies needs rectified. Judge Harris suggested that the Commissioners could make an allocation to the city sufficient to cover salary only (around \$32,000) and the city could fund the benefits. Currently, the county pays out about \$56,000 annually to fund the position and associated benefits, he explained. Discussion followed as to when it would be best to make such a change. Judge Harris asked if the change could wait until the beginning of the calendar year. Ms. Cordle suggested that it would be best to make the change when the new probation officer is hired, rather than making changes to benefits during an employee's tenure. Judge Harris stated this could be accomplished, but will necessitate some immediate work by his staff to leverage the city's share of funding. A follow-up meeting for July 6 was scheduled at which Judge Harris and Ms. Humes will have additional information

regarding possible funding through the Municipal Clerk of Courts and the townships' responsibilities.

WORK SESSION

The Commissioners met for working lunch at 12:15 p.m. at which they discussed imminent litigation with the Board of Elections and the most recent budget request for 2006 submitted by the board. Present at this work session were Judith Shupe, Mike Kiger, Jon Myers, Aunie Cordle, Staci Knisley and Jackie Long. In reviewing the budget, the Board felt that additional detail was needed on some of the line items and contacted Board of Elections Member John Dolske, who had prepared the budget. Mr. Dolske agreed to provide the back-up materials later this week. Mr. Dolske's letter had given the Commissioners a date of July 11 by which to provide the necessary funds, after which the Board of Elections will file a lawsuit if the funds are not awarded. While the Commissioners felt that some additional allocation may be necessary, they expressed concern with some of the policies and practices of the office. The Board agreed that further discussions with Attorney Marc Fishel were in order and requested that the Clerk set up a meeting for later this week.
