Commissioner Davis stated that he would like the energy audit to show which projects will "give us the biggest bang for the buck." He stated that if there is a significant return on investment then going forward would probably be the best thing to do.

Mr. Vogel stated that some companies involved with energy audits will give a rebate back. He stated that the kitchen equipment at the jail needs to be updated. He stated that too much money is being spent on repairs and that new items should be purchased.

Ms. Knisley stated that more money would need to be put into the Sheriff's budget.

Commissioner Shupe asked whether more money needs to be appropriated into Capital Improvements.

Mr. Vogel stated "not yet."
