Lawrence Stinnett – On September 10, 2014, at the Green Gourmet Foods factory in Baltimore, Ohio, Lawrence Stinnett raped 2 women. Stinnett and the victims were employed at the factory. In March, 2015, a jury found Stinnett guilty of 2 counts of rape, 3 counts of kidnapping, and 3 counts of Gross Sexual Imposition, and in April, 2015, he was sentenced to 34 years in prison. Stinnett was classified as a Tier III sex offender which requires lifetime sex offender registration.

Clifford Howard – In late 2014, Clifford Howard, age 70, sexually molested a 6 year old girl. In March, 2015, in order to prevent the young child from having to testify, the Fairfield County Prosecutor’s Office allowed Clifford Howard to enter a plea of guilty to Gross Sexual Imposition, Sexual Battery, and Pandering Obscenity. He was sentenced to 10 years in prison. Howard was classified as a Tier III sex offender which requires lifetime sex offender registration.

David Pyles – During a time span from December 1, 2013 to December 1, 2014, David Pyles repeatedly sexually assaulted a girl who was 11 years old through most of the abuse. In March, 2015, in a trial to the Court, the Court found David Pyles guilty of 2 counts of rape, 2 counts of sexual battery, and 3 counts of Gross Sexual Imposition. Pyles was sentenced to 26 years in prison. Pyles was classified as a Tier III sex offender which requires lifetime sex offender registration.

Shonn Crist – During 2013 and early 2014, Shonn Crist repeatedly sexually assaulted a teenage girl. In October, 2015, a jury found Shonn Crist guilty of 3 counts of sexual battery and 1 count of rape by force or threat of force. Shonn Crist was sentenced to 11 years in prison. Crist was classified as a Tier III sex offender which requires lifetime sex offender registration.

In July, 2015, Zachary Marcum entered a plea of guilty to 3 counts of rape and was sentenced to 30 years in prison. Marcum was classified as a Tier III sex offender which requires lifetime sex offender registration.
