## **MEETING NOTES**

Attendees: Kent Huston (Chair); James Mako (RPC); Peggy Portier (Safe Routes to School) Jonett Haberfield (Visit Fairfield County); Terry Fischer (Bike Buckeye Lake), Robin Duffee (Violet Township)

- Kent Huston called the meeting to order at 2:30 PM. A motion was made by Terry Fisher and seconded by Peggy Portier to approve the minutes of the July 19, 2021 meeting minutes. Motion passed
- 2. Chairman's Report

Kent Huston welcomed everyone and introductions of the attendees was made. Mr. Huston reminded the group that the ATC is a recommending body and reiterated the importance of the committee.

- 3. Subdivision Review
  - <u>Magnolia Reserve</u> Mr. Mako gave an overview of the Magnolia Reserve Subdivision Preliminary Plan. The Subdivision is located in Violet Township west of Pickerington Road. The subdivision has conditional approval of the preliminary plan. The development has 33 lots and will have sidewalks unlike Cansada Estates. The ATC is recommending the developer to grant an multi use path easement along Pickerington Road.
  - Soring Creek Section 3 Phase 3B Subdivision Final Plat Mr. Mako gave an overview of the Spring Creek Section 3 Phase 3B final plat. The Subdivision is located in Violet Township west of Pickerington Road. This development will include a 8' multi use path along the south and east portion of the subdivision along Glencrest Drive and will connect to Pickerington Road. The ATC is recommending the developer to grant an multi use path easement and provide grading along Pickerington Road.
  - Mr. Mako gave an overview of the Reserves at Farm Creek Preliminary Plan. The Subdivision is located in Greenfield Township west of Carroll Southern Road and will have 38 lots. The subdivision has several issues that need to be worked out before RPC can move forward. The ATC is recommending sidewalks be constructed throughout the subdivision.

4. Membership Update- Mr. Mako updated the committee on the full RPC taking action to approve Robin Duffee as a full member of the Active Transportation Subcommittee.

## 5. Other Business

Mr. Mako began a discussion on updating the Rolling Forward plan. Right now, RPC does not have the staff in place to undertake an update. There may be time in 2022 to begin at updating the plan. Mr. Fisher requested that the existing plan should be reviewed during the regular ATC meeting and see what sections need updating. Mr. Mako mentioned that refining the corridors in the existing plan should be the focus of any updates. A general discussion was held on how and when to update the plan. It was agreed that this discussion should continue.
