Bids will be received for the demolition of existing mechanical spiral screen, screen appurtenances, and other existing features as shown on drawings, furnishing and installation of new center flow band screen, construction of buried and exposed piping system, and associated site work, to support portable sludge dewatering trailer (trailer is not part of this contract) to be located between the Sludge Pump Building and Blower Building No. 2 and Electrical power supply as shown on drawings to support sludge dewatering trailer and all related improvements shown on the drawings and as specified.

Failure to submit bid proposals in conformance with the Contract Documents will result in a nonresponsive bid.

Bids shall be accompanied by a Certified Check or Bid Bond in the amount of 10% of the Total Bid as a guarantee that if the Bid is accepted, a Contract will be entered into.

A Performance and Payment Bond must be furnished by the Bidder who is awarded the Contract for the full amount of the Contract to guarantee his/her faithful performance of the Contract.

Contracts for Work under these Bids will obligate the Contractor to comply with federal, state and local laws, statutes and ordinances, including licensing of Contractors, state wage rates, and non-discriminating hiring practices.

The Board of Fairfield County Commissioners may reject any or all of the bids on any basis and without disclosure of a reason. The failure to make such a disclosure shall not result in accrual of any right, claim, or cause of action by any unsuccessful bidder against the Board of Fairfield County Commissioners.

The estimated cost of construction for the work outlined in the plans and specification for the Contract is \$430,000.

The deadline for submission of Bids at the above-noted address for the Board of County Commissioners is **10:30 am on September 4, 2015**, promptly after which all Bids will be opened and read aloud.
