#### **Welcome**

Commissioner Levacy opened the meeting by welcoming everyone in attendance.

#### Listen and Learn – Utilities and Development

Tony Vogel spoke about current and completed projects, and future plans for the Fairfield County Utilities Department. He also spoke about staff, open staff positions, and the nine facilities operated by the department. The department produced 750M gallons of water per day in 2023 and treated 980M gallons of water. He spoke about department revenues and American Recovery Act projects. The lift station was moved at the county airport. Mr. Vogel outlined the planned and proposed projects in Violet Township and spoke about assisting additional townships and villages with development of water and sewer infrastructure.

Commissioner Fix spoke about Mr. Vogel's participation in meetings with county villages and townships and stated his appreciation for his guidance on water and wastewater concerns.

Commissioner Davis thanked Mr. Vogel for his presentation.

Commissioner Levacy asked about positions filled by Fairfield County Workforce Center students and the need for the water and wastewater training at the center.

Mr. Vogel stated that students had been hired that had participated in the Workforce Center classes.

Mr. Szabrak stated that the Water/Wastewater lab at the Workforce Center is being expanded.

Ralph Hedrick, Amanda Township Trustee, presented a resolution to the Commissioners which urges the county to prohibit large scale solar and wind farms from being constructed.

Beth Cotrell of Amanda Township thanked the township trustees for approving their resolution. She stated that the vast majority of those who spoke at the evening meeting in Amanda last year were opposed to the development of solar farms. She offered her concerns for loss in property value, damage to the land, and construction issues.

Doug Leith, Walnut Township Trustee, offered his concerns for industrial solar energy farms. He stated there have been some who voice support for the jobs created by these projects but added that most are not residents of the county. He also stated his concerns for farmland drainage and spoke about zoning requirements for landowners.

Judy Stemen of Lancaster expressed concerns for the implementation of artificial intelligence and spoke about changing liberties and freedoms.

Sherry Pymer of Walnut Township thanked Auditor Brown for assistance with the homestead exemption tax. She met with a farmer recently who was approached by a representative from Microsoft who was interested in developing their land. She urged the commissioners to not wait any longer to create exclusionary zones.

Stephanie Taylor with Habitat for Humanity of Southeast Ohio provided an update on projects which are approaching conclusion. She shared a story of one of the recipients whose life has been positively impacted by the services provided by Habitat for Humanity.

Don Keller, Liberty Township Trustee, offered his concerns for the increase in development in Liberty Township. He asked the Commissioners for assistance in answering the questions and concerns of township residents.

## Regional Planning Commission to Hold Public Meeting to Vote on County Comprehensive Plan

**LANCASTER, OH** — The Comprehensive Plan, which will serve as a guide for Fairfield County to manage growth in a strategic and thoughtful way, will be considered by the Regional Planning Commission (RPC) at a public meeting on March 5, 2024, at 6 p.m. The meeting will be held at the Fairfield County Workforce Center located at 4465 Coonpath Road NW, Carroll.

At that meeting, the RPC will vote on recommending the Comprehensive Plan to the Fairfield County Commissioners for their consideration. If approved, it will then be sent to the Fairfield County Commissioners to consider in a public meeting on March 19, 2024, at 9 a.m. at the Fairfield County Courthouse, 3<sup>rd</sup> Floor, Commissioners' Hearing Room.

The plan development process started in October of 2022, engaging a steering committee of 36 community leaders. Planning NEXT, a professional community planning company, was hired by the committee to oversee the planning process. The company conducted a series of more than 30 stakeholder interviews that included township trustees of every township in the county, leaders of villages and cities and other community leaders and hosted a public meeting at the beginning of the process, followed by multiple opportunities for in-person and online feedback.

After a public meeting in September, Fairfield County Commissioners determined additional opportunities for public input were necessary, and subsequently conducted meetings with local township and municipal leaders and citizens to obtain additional input. Accordingly, several changes have been made to the plan to address concerns and ideas raised in these meetings.

# Fairfield County Commissioners to Consider Comprehensive Plan if Recommended at Upcoming Regional Planning Commission Meeting

**LANCASTER, OH** — The Fairfield County Board of Commissioners will consider the Fairfield County Comprehensive Plan should it be approved and recommended to the Commissioners during an upcoming public meeting of the Regional Planning Commission. The meeting is scheduled for March 5, 2024, at 6 p.m. at the Fairfield County Workforce Center located at 4465 Coonpath Road NW, Carroll.

If approved, the Comprehensive Plan will be recommended to the Fairfield County Commissioners to consider in a public meeting on March 19, 2024, at 9 a.m. at the Fairfield County Courthouse, 3<sup>rd</sup> Floor, Commissioners' Hearing Room.

After nearly a year of conducting planning sessions and soliciting public input and feedback, Fairfield County Commissioners paused their adoption of the Comprehensive Plan after a September 2023 public hearing to allow more time and discussion prior to finalizing it.

"After that meeting, the Commissioners determined additional communication with townships, villages and residents was necessary to ensure all perspectives and concerns were considered in the planning process," said Fairfield County Commissioner Jeff Fix. "We are grateful to the community for the work that has been done over the past few months, and believe this plan helps us determine how to plan for future growth in a thoughtful, strategic way."

Over the past five months, Commissioner Fix and Planning NEXT, the professional community planning company engaged to develop the plan, held 26 meetings across the county in every township and every village with trustees, mayors and other local leaders, who were encouraged to participate in working sessions for their specific community to help solidify the plan. In addition, meetings with the Fairfield County Farm Bureau and Fairfield County School Superintendents were held to gather additional feedback.

Once approved, the Comprehensive Plan is intended to be Fairfield County's plan to manage growth, land use, and development, and is being developed to serve as a basis for considering a variety of growth- and service-related policies, programs, regulations, and capital expenditures. The plan is a resource for local jurisdictions (townships, villages, cities) to use in managing growth and investments in their own communities. The plan is not a mandate and does not replace local zoning, but it can serve as a resource to consider code and zoning map amendments to further guide development in each community. The plan has been funded and administered by the Fairfield County Commissioners at the request of local trustees, mayors and other leaders.

"Numerous changes have been made to the plan based on the feedback we received during our meetings with local leaders," said Fix. "When we started on this journey a year ago, it was with the hope that it would be used as a guide to manage the development that is coming so we could be proactive rather than reactive."

If adopted, the Comprehensive Plan will replace all previously adopted comprehensive and land use plans for Fairfield County and can be adopted by local jurisdictions to serve as their policy document for making future zoning and service decisions based on what their communities want and need.


#### Fairfield County Auditor Updates CAUV & Solar Map

# Fairfield County courthouse under wraps for roofing work as part of major renovation

LANCASTER - The Fairfield County Courthouse certainly looks a little different now.

That's because it's shrouded in scaffolding as workers work on the roof of the building that dates back to 1872..

"We're putting in a 2-inch insulation layer and then a water-tight membrane made out of vinyl that would give us a 30-year warranty on the roof of the courthouse," facilities manager Jon Kochis said. "It's something that was the key piece in finishing the restoration of the courthouse and extending the life of the building."

The work is part of a \$6 million renovation project that also includes the adjacent Hall of Justice and a building at the Liberty Center. The courthouse roof work is set for an April completion and that part of the total renovation cost is about \$600,000.

Workers previously treated the courthouse's sandstone exterior, did flooring work, installed new windows and doors and replaced the heating and cooling system. Kochis said replacing the doors and windows and heating and cooling systems in the courthouse and Hall of Justice will lead to annual savings of around \$400,000 in energy costs.

As another way to save energy costs, the county installed a solar field at the Liberty Center building.

"I really think we've combined a number of different goals," Kochis said of the entire renovation project. "Energy efficiency, reducing costs and maintaining the historic value. Interestingly, this is our second courthouse. The first courthouse was built right in the intersection of Main and Broad (streets)."

# Stivers: Accessible and attainable housing for Ohioans is essential

In the wake of last week's 2024 Ohio Chamber Housing Summit, we continue to focus on the issue of housing for all Ohioans. Every Ohioan should have access to safe, affordable housing, and this goal can only be accomplished if we work together.

In the Ohio Chamber's Blueprint for Ohio's Economic Future, a report that analyzes Ohio's economic outlook and compares it to other states, we identified six key areas for improvement, including "Sense of Place." This area refers to the components and resources that make a community a desirable place in which to live, work and visit. To achieve this desirability, housing access and affordability remain top factors.

Generally, housing that is considered "affordable" translates to people or families that do not spend over 30% of their income on rent or a mortgage plus utilities. According to the National Low Income Housing Coalition, to afford a two-bedroom home in Ohio without spending more than 30% of your income on rent, you would need an annual household income of \$39,702. That puts nearly 52,000 Franklin County households, and 80,000 Central Ohio households, in a housing-cost-burdened status.

Additionally, housing production remains a challenge due to land availability, zoning, density restrictions, regulations, construction costs and a lack of skilled workers— the last of which has only worsened since the pandemic. The National Association of Home Builders found that in 2019, the median price to build a single-family home in the U.S. was over \$296,000. With the growing lack of resources and funding for residential development, the working Ohioan's ability to own affordable housing remains nearly unattainable.

This lack of affordability continues to concern lowest-income and moderate-income renters across the state. In 2020, only 3 out of the 10 most common jobs in Ohio paid an hourly rate necessary for a worker to afford a modest, two-bedroom apartment. This shortage of affordable rental housing leaves nearly 400,000 Ohio households "rent-burdened," meaning

they spend over half of their income on rent. Severely cost-burdened households are more likely than other renters to sacrifice necessities like food and healthcare to pay the rent, which can lead to unstable housing situations like evictions.

While there may be no simple solutions to the housing shortage and increased demand, the Blueprint recommends dedicating efforts to increase home ownership and provide affordable rent. Policymakers must focus on innovative housing solutions that not only expand housing supply but also expand home ownership to build generational wealth. Public policy solutions should also include incentives to encourage zoning reform, expand the use of historical tax credits and other financing tools to increase housing supply, and tax policy solutions to assist older Ohioans who want to age in place.

We look forward to working with policymakers and housing experts to discuss these issues. We must continue these conversations and continue to prioritize housing and fulfill the Sense of Place priorities in the Ohio Chamber's Blueprint.

#### **Board of Revision Online Case Files Are Available**

Board of Revision Online Case Files provide information about real property valuation complaints. We created online access to address an anticipated increase in public records requests due to legislative changes. A collection of public records, including complaints, counter complaints, and exhibits, has been online since December of 2021. With online access, all requests have been answered on the same day. Data are updated every day.

The deadline to file a complaint with the Board of Revision is April 1 this year because March 31 is a Sunday. We have been conducting outreach so that people know of their options to file BOR complaints.

#### Summary of Board of Health Apportionments

We have conducted detailed presentations about the calculation of apportionments (shares of costs) for the Board of Health and the entities who participate in the General Health District. Here are some key points of the process:

- The *Board of Health* evaluates its prospective resources and expenses. The member political subdivisions evaluate and determine the need for resources. The District Advisory Council reviews and approves contracts (such as with the City of Lancaster) and evaluates the budget.
- The County Auditor is the chief appraiser for the real estate valuations of the political subdivisions. A video about the role of the county appraiser is found here: https://www.co.fairfield.oh.us/auditor/

For the apportionment calculations, the percentage of each political subdivision's share of the aggregate valuation is calculated. (Tax Year 2022 applies to Fiscal Year 2024 and so forth.)

- The percentage share for each political subdivision is applied to the need presented. This calculation provides the share or allocation from political subdivisions. This resulting calculation is referred to as an apportionment.
- Deductions of apportionments are made at the time of real estate tax property settlements. The apportionments are provided to the Board of Health for operations.

#### Legal Level of Control for Budgeting Results in Efficiency & Flexibility

The legal level of control for budgeting is the level at which spending in excess of budgeted amounts would be a violation of law. This is the level at which the legislative body appropriates. In Fairfield County, this level is known as a major category of expenditures. Common examples of major categories are salaries, benefits, supplies, contractual services, and equipment. Within these examples are multiple objects (sometimes called accounts or line items) – these are "non-major" categories. The Commissioners approve transfers of appropriations from a major category to another major category, as that is the legal level of control. The County Auditor approves non-major changes, which are at the object or account level. This approach allows for greater speed, efficiency, and flexibility at departmental levels.

#### Walnut Township Fire Protection Ballot Issue

- Walnut Township is placing a 2.6 mill *additional* levy on the ballot March 19<sup>th</sup>, 2024. This *additional* levy is for fire protection and is *continuing*. Collections for the *additional* levy, if passed, will begin in 2025.
- Walnut Township has a *current* fire protection millage, passed at 9 mills. This millage is continuing. With the *current* millage, reduction factors are applied. In other words, a difference exists between rates as authorized by the voters and the actual mills charged. An "*effective millage rate*" reflects how original voted mills are decreased to account for increasing prices in the real estate market. While passed at 9 mills, the current millage is collected at approximately 5.5 mills. The *current* millage provides an estimated \$2,155,000 annually. For a property owner with a home valued at \$100,000, the annual tax for the *current* millage is about \$192. For a property owner with a home valued at \$300,000, the annual tax for the current millage is about \$576.
- For a property owner with a home valued at \$100,000, the annual tax for the *additional* levy proposed on the ballot March 19<sup>th</sup>, 2024, would be \$91. For a property owner with a home valued at \$300,000, the annual tax for the additional levy would be \$273.
- If voters pass the proposed *additional* levy, an estimated additional \$913,166 will be collected annually.

- We received word about some omitted files at the state level for oil and gas property tax payments across all counties. The state will adjust the next file they create, as is the normal process. Thanks to Bev and team for reaching out to the Treasurer in case there are questions about tender pay. Thanks to the REA and Financial Systems team for their collaboration in ensuring proper adjustments within the mechanisms that are in place to manage them.
- Thanks to Nick Dilley for providing great Tips and Tricks for GIS users.
- There have been several questions posed about tax exempt properties, or properties anticipated to be tax exempt, and Carri verified early in the week that there is a "look back" process with the Department of Taxation approvals.

- Carri has been attending CAAO meetings about property tax reform. There are several proposals
  before the legislature at this time. We are discussing them in a variety of meetings. Locally, we favor
  improvements to the Homestead program and a fixed amount for the owner occupancy credit
  (providing a larger percentage of a credit for those with relatively lower market values). There also has
  been discussion about communicating about a percentage, as opposed to millage, with property taxes.
- There was a **Destination Downtown** Board meeting on Tuesday. We have been promoting events at the office, and there have been several residents to appreciate the materials provided. We have also been providing updates from the **Heritage Association**.

Thanks to Joanna Vanderbilt and Michele Poston for providing good customer service about the Homestead program. This topic is by far the one with the most questions and calls at this time.

- During the week, several training opportunities were available. One was an Association of Government Accountants webinar. Linda Miller, a former Olympic athlete, spoke about leadership and the importance of knowing your values and being clear in communicating about them. She shared lessons, many of which confirmed what we talked about on February 7<sup>th</sup> at the CAAO conference. She also talked about the importance of empathy in the face of disappointment. Thank you for the prompt submission of the fourth quarter report on your Combined Education & Recycling contract. This letter confirms closure of the 2023 contract.

Attached is a final financial statement. Please review it carefully and make the necessary changes to your records.

The following changes were made to your report.

- 1. <u>Salaries</u> The amount submitted was \$106,390.01. The amount allowed was \$107,120.40. The additional amount of \$730.30 for Michael Campbell. His original salary calculation form was revised and resubmitted.
- 2. <u>Supplies</u> The amount submitted was \$7,704.98. The amount allowed was \$7,543.65. The difference of \$161.33 was for paint used in the recycling center. That expense was not covered under the contract as it is a building maintenance supply.
- 3. <u>Equipment Purchase</u> The amount submitted was \$4,097.05. The amount allowed was \$4,097.50. The difference was a transposition of numbers during input.
- 4. <u>Print/Advertising</u> The amount submitted was \$906.14. The amount allowed was \$662.38. Invoices for a banner and a tablecloth in the amount of \$243.76 were moved out of this line item and into the Awards/Promotion line item.
- 5. <u>Awards/Promotions</u> The amount originally submitted was \$4,966.71. The amount allowed was \$\$5,210.47. The additional amount of \$243.76 is the amount mentioned in #4 (above). The balance left in this line item at the end of the third quarter was \$4,973.52; therefore, that is the amount allowed in this line item. That left \$206.81 unpaid in that line item. (see #6 below)
- 6. <u>Contingencies</u> The amount of \$0.00 was submitted. The amount of \$200.00 was available in this item and was then used toward the unpaid balance in Awards/Promotions.

Programmatically, the report documents activity fulfilling contractual commitments for 2023. There was activity through the year to reach all five audiences using each of the strategies in the county's outreach plan.

The 2023 contract total was \$1,175,011.60 and the entire amount was previously advanced to your office. Approved expenditures total \$1,1069,129.95. The unspent amount of \$105,881.65 is due back to the district by March 15, 2024. An invoice is attached for your convenience.



## Eastern Cottontail Solar - EDF Renewables North America

EDF Renewables North America (EDFR) is developing the Eastern Cottontail Solar Project<sup>1</sup>, located in Fairfield County, Ohio. With over 35 years of experience, EDFR delivers large-scale commercial wind, solar and battery storage projects for corporates and utilities; small-scale customized solar and battery storage, smart EV charging, microgrids, and energy management systems as well as technical and operational support to maximize the performance of renewable energy projects.<sup>2</sup>

### EDFR - Fox Squirrel Solar Project in Madison County, OH

Fox Squirrel Solar is a 577-megawatt (MW) utility-scale solar project located in Madison County, OH, owned by EDFR.<sup>3</sup> After being one of the first solar projects to receive an approved Certificate of Environmental Compatibility and Public Need Application from the Ohio Power Siting Board (OPSB) in July of 2021, the project began construction shortly thereafter in mid-2022. Construction of Fox Squirrel is slated to be completed by 2024, when it will be one of Ohio's largest clean energy generating sources.



February 2024

At the end of 2023, Fox Squirrel Solar achieved a major construction milestone by completing Phase I of the project, which is now providing 150 MWs of clean energy to the state of Ohio. At the height of Phase I construction, over 650 local workers were onsite, installing 8,000 panels per day! Through considerate and proactive planning, many project initiatives have become state-recognized "best practices", to include safety management and vegetative management practices.

### EDFR - Domestic Panel Manufacture Procurement: Canadian Solar

In August of 2023, EDFR North America signed a multi-year solar module (panel) supply agreement to deliver up to 7 gigawatts (GW) of high efficiency solar modules that will allow for an increase in energy production throughout the life of the project. These panels will support EDFR's efforts in providing clean, renewable, and reliable energy to the local transmission grid. The modules will be manufactured in Mesquite, TX, as previously announced by Canadian Solar, in June 2023. The facility will not only provide skilled labor for Americans but will also be a domestic provider of solar modules for projects across the United States. Partnering with a domestic solar module manufacturer will minimize the risk of supply chain fluctuations that have been seen across the industry.

### EDF - Partnering with SOLARCYCLE for Recycling Old or Used Solar Modules

In November of 2023, EDFR signed an agreement with SOLARCYCLE<sup>4</sup>, a technology-based solar recycling company that specializes in recycling damaged or broken solar panels during the construction process or while the facility is in operations. They provide recycling services for projects at grid-scale (such as Eastern Cottontail Solar)<sup>5</sup>, distribution-scale (community solar)<sup>6</sup>, and onsite solar sites (rooftop or ground-mounted solar arrays).<sup>7</sup>

Many components of the solar modules anticipated to be used for Eastern Cottontail Solar, can be reused or recycled at the project's end-of-life. The metal, glass and wiring components, as well as the silicon cells, can be melted down by specialty recycling companies such as SOLARCYCLE.<sup>8</sup> Should the panel not be eligible to be refurbished or repurposed, the majority of the components can be recycled.





Partnering with SOLARCYCLE is part of EDFR's commitment to provide responsible end-of-life management for used or damaged solar panels. With the technology provided by SOLARCYCLE, up to 95% of the materials within a solar panel, such as silver, copper, aluminum, and glass, can be recycled and reused. The materials recycled from solar panels through SOLARCYLCE's process can be refurbished and incorporated in the next round of manufactured solar panels. This helps EDFR close the loop on the life of the solar panels






MCJDC Youth & Staff Share Their Gifts, Talents, & Unique Skills

Giving has been shown scientifically to reduce stress, heal trauma, improve mood and yield a dose of happy brain chemicals. Studies have linked volunteerism (a popular form of altruism) to happiness, better physical health, and increased mental health.

According to one recent study which followed a group of mothers over 30 years. Over the three decades, 52 percent of the women who rarely or never volunteered experienced a significant illness, while only 36 percent of women who routinely volunteered experienced a major illness. In another study, scientists found that older adults who participated in a volunteer organization had lower depression rates, less anxiety, and an increased will to live. Another study found that adults aged 55 and older who consistently volunteered had a 44 percent decrease in mortality rates. The proof is in the giving! We made homemade apple pies with buttermilk crust from scratch. We used a buttermilk pie crust recipe and then filled our pies with apple pie filling and extra fall spices to make it extra delicious! The crust was amazing and the youth loved the hands-on experience. We also talked about how to make better food choices and learned about the dangers of processed foods on the body and mind.

#### Buttermilk Pie Crust \*\*\*\*

#### Ingredients

- 2 ½ cups all-purpose flour (200 grams)
- 1 tablespoon granulated sugar, optional
- · 1 teaspoon salt
- · 1 cup unsaited butter , cold and cut into cubes (226 grams) · ½ cup cold buttermilk (120 ml)

#### Instructions

- 1. Combine the flour, sugar (if using), and salt in a bowl. Add the cubed butter and toss to coat.
- 2. Use a pastry blender or two knives to cut the butter into the dry ingredients until butter is the size of peas
- 3. Add butternilk and use a spoon and then your hands to stir the mixture until it comes together into a ball. If mixture is too dry, add additional buttermilk a teaspoon at a time.
- 4. Divide the dough in two and flatten into disks. Wrap each disk in plastic wrap and chill in the fridge for at least 1 hour and up to 5 days. Dough can also be frozen (double-wrapped) for up to 2 months.
- 5. When ready to roll out, let the dough rest at room temperature for five minutes. On a lightly floured surface, use a rolling pin to roll out the dough into a rough 13 inch circle. Dough should be about 1/4 inch thick. Transfer dough to 9inch pie dish. Fill pie with desired filling.
- 6. Repeat with the second disk of dough. Cut dough and make a lattice over the filling, or leave the circle intact and cover the filling completely, cutting a few vents with a sharp knife.
- 7. Fold the edges of the top and bottom crusts together and use your index fingers and thumb to pinch into a pattern Brush with egg wash and sprinkle with sanding sugar, if desired
- 8. Bake pie according to the instructions in your specific pie recipe. Different fillings will require different temperatures and time.

#### Notes NOTES

Makes enough dough for one 9-inch double pie crust.

#### **Welcome**

Commissioner Levacy opened the meeting by welcoming everyone in attendance.

#### Listen and Learn – Soil & Water Conservation District

Nikki Drake introduced herself and spoke about the handouts she provided which are available in the minutes. She also spoke about a workshop on logging timber best practices and added that Carrie Brown, from the OSU Extension spoke about the Spotted Lanternfly from China that is destroying trees and bushes in North America. Ms. Drake also spoke about their annual tree sale and added that the annual drug collection event will be in Walnut Township. The Soil & Water Conservation District's annual report and newsletter are both on their website.

Commissioner Fix stated that the annual report speaks about the nineteen Land Use Plan meetings attended by Ms. Drake and her team. He added his appreciation for Ms. Drake, Mr. Chad Lucht, and the team, participating in the meetings.

Commissioner Levacy asked if there is a treatment for the Spotted Lanternfly.

Commissioner Fix asked if the trees are harmed or killed by the invasive species.

Ms. Drake stated that the Spotted Lanternfly sucks the sap from the tree and causes a great deal of damage and that the greatest concern is vineyards, since they will not survive the damage. She added that OSU extension can assist with identifying the Spotted Lanternfly.

Ms. Cordle thanked Ms. Drake and Mr. Ferbrache for their work on the Memorandum of Understanding (MOU) with the Ohio Department of Agriculture. She also stated her appreciation for Mr. Vogel and Mr. Szabrak for their assistance in the process.

Mr. Vogel added that the MOU would provide for utility access when the property goes into land preservation.

Ms. Drake stated that fifth grade teachers may request tree saplings for students.

Commissioner Fix stated that the county is working on land preservation so that a landowner can preserve their land even if a neighbor wishes to develop. He added that the county wants to partner and asked Ms. Drake if she agreed with what the county is doing with the state.

Ms. Drake stated that the Soil & Water Conservation District is doing this with the Commissioners and will work through that process.

#### **Ohio Transit Risk Pool Recognizes Lancaster-Fairfield Public Transit**

Ohio Transit Risk Pool CEO, Barbara Rhodes, presented an award to LFPT for having the lowest cost of risk in the entire pool and added that LFPT competed against counties such as Delaware, Licking, and Allen.

LFPT Director, Chasilyn Carter, thanked Ms. Rhodes and the Ohio Transit Risk Pool and added that safety is the LFPT's priority.

Commissioner Davis thanked Ms. Rhodes and Ms. Carter and asked if there was anything the county should do prior to July 1<sup>st</sup> to maintain the relationship with the Ohio Transit Risk Pool.

Ms. Rhodes stated there are meetings being added to discuss possible implications of the transition. She added that she has previously worked with agencies who are transferring governance and further added that the LFPT has had a clean audit every year.

Commissioner Levacy stated that it is difficult for a city to operate a county transit agency and that the county will have the opportunity to leverage workforce relationships. He added that the city and county have been working together on the transition and have the same goals for LFPT.

Ms. Rhodes stated that the City of Lancaster should be commended and added that the Ohio Transit Risk Pool is excited to help. She added there is staff that works for the Ohio Transit Risk Pool under an ODOT grant

#### Floodplain Regulations Update/Hearing – Regional Planning Commission (RPC)

Holly Mattei explained the requirement to hold public hearings to amend floodplain regulations. She spoke about the slight changes to the floodplain maps in the Pickerington area and in an unincorporated area of the county. She added that the Ohio Department of Natural Resources reviewed the model with RPC and provided a timeline for updating the maps. Ms. Mattei stated there would be an additional public hearing on February 27<sup>th</sup> and added that the hearings will help ensure the county does not lose national floodplain insurance.

Commissioner Davis asked who must carry floodplain insurance and if there are different levels of flood risks on properties. He also asked if any area had been added to a floodplain map that was not previously in a floodplain.

Ms. Mattei stated that properties with mortgages must carry floodplain insurance. She explained that 100 year floodplains indicate that the area is likely to only flood once in 100 years and that these areas see considerable construction. Areas that do not require flood insurance are 500 year floodplains and these areas are likely to only flood once every 500 years. Studies have been completed to show where water is flowing.

Commissioner Fix stated his appreciation for the participation of Ms. Mattei, Ms. Saleh, and Mr. Hillberry at the Land Use Plan meetings.

Ms. Mattei stated that RPC is in the process of getting their CDBG projects and will be sending out a press release. She added that RPC will be back in front of the Commission on March 5<sup>th</sup> for a CDBG public hearing.

Commissioner Fix asked if floodplain hearings are held yearly.

Ms. Mattei stated that the floodplain maps were last updated in 2012. She stated the 2012 maps had many changes, unlike the ones presented today.

Ms. Pymer stated that the floodplain maps were discussed at the Walnut Township Trustee meeting.

Ms. Mattei explained that the Walnut Township discussion was unrelated to the floodplain maps being discussed and added that that the Walnut Township discussion was being held until the floodplain maps, which are a FEMA requirement, are finalized.

Commissioner Levacy asked if there was anyone in favor or who opposed the updated Floodplain Regulations. There was no one in favor or in opposition of the proposed Floodplain Regulations.

Commissioner Levacy adjourned the Floodplain Regulations Update/Hearing at 9:36 a.m.

#### Legal Update

Amy Brown-Thompson stated that the Board of Elections was named in a time sensitive Ohio Supreme Court lawsuit regarding the Mayor of Buckeye Lake.

Commissioner Davis asked about the objective of the suit.

Ms. Brown-Thompson stated that the objective is to stop the recall election and she thanked the departments that have been extremely patient through the process.

#### Week in Review

#### Sheriff's Office Perimeter Fencing

We have received artist renderings for two options of perimeter fencing. A rough budget for the options, assuming normal conditions, is \$995,000 for the full 6' height wall and \$965,000 for the 44'' masonry wall with 3' black picket fence on top. The isn't a

significant difference in the cost due to the cost of installing the piers that both options utilize.

Commissioner Davis inquired as to the aesthetics of the back of the fence wall.

Mr. Kochis stated that the inside of the fence is brick and that there could be a cost reduction to change the inside.

Commissioner Davis spoke about the Sheriff's Office's vehicles and staff vehicles that would be in the lot surrounded by the fence and added that in former conversations regarding the jail, we stated that we would not make the facility look like a prison. He added that the fence would be on the back side of the facility, on the Wheeling Street side. The Commissioner spoke with Mr. Kochis regarding the posted "no trespassing" signs.

Mr. Kochis stated that everything from delivery drivers to pedestrian traffic is seen cutting through the lot from Wheeling Street to Lincoln Ave.

Commissioner Davis stated that security became a concern when individuals were seen putting on shows for incarcerated individuals.

Mr. Kochis added that there were communications taking place between incarcerated persons and people on the outside of the facility. Window treatments were applied that prevent individuals from seeing into or out of the facility.

Commissioner Fix asked about fence gates.

Mr. Kochis stated there will be four gates plus a secure wrought iron gate, all included in the cost. He added that there will be access control and a lot of other built in costs outside of the cost of the brick.

Commissioner Davis asked about the contingency and the 2024 budgeted amount for the fence. He also asked about the risk of additional costs and the anticipated completion date.

Mr. Kochis stated that \$745,000 was budgeted for the project and that there is still a potential for change orders. He added that he anticipated the project could be completed in 2024.

Commissioner Davis spoke about project challenges since the pandemic and asked about the height of the fence.

Mr. Kochis stated that the challenges we faced getting materials and laborers have improved. He added that the fence would be 6 foot in height.

#### **Old Business**

Commissioner Davis spoke about presenting to the Indigent Defense Task Force and added that a commissioner from Allen County also made a presentation. The situations in Fairfield and Allen counties differ as Allen has had a substantial increase in Indigent Defense costs over the last decade, while Fairfield County has had a less than 2% increase in that same time. The Commissioner stated that there are counties who would benefit from a state takeover of indigent defense and those who would not. He urged the task force not to penalize counties whose systems are not in need of help. Commissioner Davis also had the opportunity to attend an event with Big Brothers Big Sisters.

#### New Business

City of Lancaster's Safety and Service Director, Carrie Woody, thanked Chasilyn Carter for all she has done to keep the Lancaster-Fairfield Public Transit drivers and passengers safe.

Commissioner Levacy thanked Ms. Woody and Ms. Carter for all their safety efforts.

Commissioner Davis spoke about driving an electric vehicle and added that he does not go long distances in the vehicle. He stated that the country's infrastructure is not equipped to push all drivers to electric vehicles, and that there is not the ability for electric vehicles to go long distances. The Commissioner also spoke about a note received from Ms. Pymer and added that he has reviewed the testimony from Issac Orr. He added there is a huge difference between removing power and adding power supply and that there is a push to subtract supply, which will drive energy costs up. He thanked Ms. Pymer for sharing the information.

Treasurer Bahnsen stated the Treasurer's Office has had a busy week and encouraged folks to contact his office with questions or concerns.

Commissioner Levacy asked if the Treasurer's drive up window option was being utilized.

Treasurer Bahnsen stated the drive up window gets a fair amount of use.

Auditor Brown stated her office has begun the process of communicating the second half tax bills to Lancaster residents and mortgage companies. She added that her office will issue an amended certificate in March to the City of Lancaster and that most of the questions received by her office are related to the Homestead exemption.

hereinafter referred to as the Lessee, all those premises known and described as:

#### Pickerington Deputy Registrar 12943 Stonecreek Drive Pickerington, Ohio 43147

The **Lessee**, does hereby rent and leases from Lessor, upon and subject to the terms and provisions of this lease, certain premises, such premises being the space consisting of approximately **1,586** rentable square feet of space and a minimum of 50 non-exclusive parking spaces with additional parking spaces, as near as possible to our customer entrance, properly marked that meet all ADA requirements.

II. TO HAVE AND TO HOLD the same with any appurtenances included, unto the said Lessee from the 1st day of September, 2023 for and during the term ending on the 30th day of June, 2024, with five (5) automatic renewals of two years at the agreed-upon rate shown below and subject to the same terms and conditions, contingent on appropriation of such funds by the Ohio General Assembly in accordance with Ohio Revised Code §126.07.

**Total annual rental cost through June 30, 2024, will be \$0.00**. The deputy registrar will only pay prorated utilities until July 1, 2024, at which time the base rental cost will be approximately **\$12.00 per square foot or \$19,032.00** annually, for the entire demised premises.

- IV. It is understood and agreed that the Lessee may SUBLEASE the demised premises to any successful proposer who is awarded the contract to operate as a Deputy Registrar at this location, a Driver Exam Station, or the Clerk of Courts for use as a Title Agency.
- V. It is agreed that this lease and any renewal thereof is subject to the appropriation and certification of **AVAILABLE FUNDS**, pursuant to Ohio Revised Code, section 126.07 and approval by the State Controlling Board if deemed applicable by the Director of Public Safety.
- VI. Lessee agrees to refrain from committing **WASTE** on said premises and to deliver possession thereof to the Lessor at the conclusion of this lease in substantially as good condition as at the commencement of this lease, damages arising from any circumstances beyond the control of the Lessee and normal wear and tear excepted. If such waste should occur, Lessee may be held responsible for damages.
- VII. Lessor covenants that it is in **RIGHTFUL POSSESSION** of the premises and that upon payment of the rental fee it will warrant and defend the title of the Lessee against any and all claims whatsoever, not arising out of this Lease. Lessor further warrants that the Lessee shall, at all times during the term of this Lease, peaceably and quietly have, hold and enjoy the premises.
- VIII. Lessor shall comply with all federal, state and local building codes, zoning codes, occupancy permits, fire codes applicable to this lease. Lessor shall during the term of this lease keep the premises in compliance with any and all **APPLICABLE STANDARDS** which have been or will be promulgated by the Federal Occupational Safety and Health

Administration pursuant to the Federal Safety and Health Act of 1970, 29 U.S.C. 651 to 678 (1970).

The Lessor shall comply with all applicable provisions of Ohio Revised Code Chapter 4115, entitled Wages and Hours on Public Works.

The Lessee encourages the Lessor and any of its subcontractors to purchase goods and services from certified Minority Business Enterprise (MBE) and Encouraging Diversity Growth and Equity (EDGE) vendors in fulfilling any of its responsibilities under this Agreement.

The Lessor shall maintain the premises in accordance with the Federal Americans with Disabilities Act of 1990, Public Law 101-336, 42 U.S.C. sections 12101 to 12213 (1990), as amended, and with all applicable regulations.

The Lessor shall comply with all applicable Affirmative Action and Equal Employment Opportunity laws, including: 29 U.S.C. Sections 621 to 634 (*The Age Discrimination in Employment Act of 1967*), 42 U.S.C. Sections 2000e to 2000e-17 (*Title VII of the Civil Rights Act of 1964*, as amended), Ohio Revised Code Chapter 4112 and Ohio Administrative Code 123:1-49.

- IX. SERVICES BY THE LESSOR. The Lessor agrees to perform all of the following functions at its own expense during the term of this lease or any renewal thereof:
  - A. Pre-occupancy services
    - 1. Replace any fixtures attached to the building such as doors, sinks, faucets, etc., which are not in good working order.
    - Lessor shall provide a finished architectural blueprint of the demised space (including casework) to the Lessee – Facility Management office, for review and approval before proceeding with the construction and buildout.
    - 3. The Lessor shall install all new major mechanicals, HVAC, sprinkler system, fire alarm, electrical, plumbing, etc., in the manner prescribed by law and ensure all systems are properly working.
    - 4. Lessor shall construct interior improvements depicted on the attached schematic, including perimeter and interior partitions, dry walled, taped, sanded, and painted with two coats of semi-gloss paint.
    - 5. Install new exterior doors, glass work, and windows in the office, as depicted on the schematic.
    - 6. Install interior doors and hardware, ADA compliant bathrooms to include dry walled ceilings, all plumbing and plumbing fixtures, break room counters/cabinets, the breakroom sink---including garbage disposal. Lessor will provide plumbing in the breakroom, all electric service in the leased space to include all wall receptacles and counter electric wiring and conduit with junction boxes for phone/data wiring (including pull strings) for all counter terminals (number to be confirmed), and DX testing kiosks, as depicted on the schematic, and per BMV specifications.
    - 7. Lessor will prepare, smooth and level all floors to have them ready for new flooring installation.
    - 8. Lessor will provide and install all restroom flooring.

- 9. Lessee will provide and have installed all other flooring at Lessee's expense (with carpeting and hard surface material to be confirmed) as designated by the Lessee and as shown on the floor plan.
- 10. Lessor will also install acoustic tile suspended ceiling, and 2 x 4 florescent light fixtures. Lessee will approve the color selections and all materials used.
- 11. Lessor will clean and remove all debris after the buildout is complete to make it final clean/move-in ready prior to Lessee occupying the premises.
- 12. Lessor will obtain all appropriate building permits and provide an occupancy permit for 49 occupants for the premise, upon completion of the services, as outlined in Article VIII above.
- 13. Lessor to install window and exterior signage.
- 14. Lessor will have thermostat installed in a separate zone for the deputy suite.
- B. Maintenance services
  - 1. Pay all taxes and assessments accruing against said premises.
  - 2. Maintain the premises including but not limited to roof, heating, air conditioning, electrical and plumbing facilities. Coordinate all such maintenance with the Lessee. Repair or replace any fixtures attached to the building such as doors, sinks, faucets, etc., if they fail to be in good working order.
  - 3. Assume liability for glass breakage, unless due to Lessee negligence.
  - 4. Provide and maintain HVAC capable of maintaining 68 to 74 degrees Fahrenheit throughout the premises regardless of outside temperatures.
  - 5. Provide hot and cold running water.
  - 6. Provide and maintain landscape service for all unpaved exterior areas, if applicable.
  - 7. Provide exterior lighting.
  - 8. Provide all exterior building maintenance.
  - 9. Provide minor, routine interior maintenance.
  - 10. Provide prompt removal of snow and ice from sidewalk(s), pathway(s) and parking area(s) and fully clear all handicapped parking areas and access ramps. Such removal to occur after cumulative snowfall of two (2) inches and/or before agency business hours in the event of overnight precipitation.
  - 11. Provide access to the premises to any third party service providers authorized by the Lessee, including but not limited to, cable, internet and telephone.
  - 12. Maintain parking lot and appropriate markings. Lessor will make all repairs to the parking lot, Cold patch repairs shall be made by the Lessor within ten (10) days of Lessee's notice, with permanent repairs made within four (4) months of said notice.
  - 13. Provide and maintain emergency exit lights and signs, and fire extinguishers, as required by law.
  - 14. Provide trash removal.
  - 15. Paint interior every five (5) years.
  - 16. Provide and replace light bulbs as needed.

- 17. Provide pest extermination services if an issue is identified by the Lessee.
- 18. Change or re-key exterior door locks and provide 2 keys for each lock each time a change in the Sublessee occurs.
- 19. Provide routine janitorial services in the customer waiting area and up to the deputy's counter.
- 20. Lessor will maintain an occupancy permit of 49 occupants for the office.
- C. Emergency repair or special circumstance services: if applicable

In the event Lessor fails to provide any services required of Lessor under this Lease, Lessee shall notify Lessor in writing of the service or services which are not being provided. If Lessor does not provide same within 10 days of the date of such notice, Lessee may provide the service and deduct the cost thereof from the rents reserved herein. In extreme cases of negligence, Lessee reserves the right to terminate this Lease by written notice of termination at any time after expiration of said 10 days.

#### X. LESSEE RESPONSIBILITIES:

- A. To cause payment to the Lessor of the rentals as they fall due.
- B. Abide by such reasonable rules and regulations required by the Lessor to assure proper operation of the premises, provided such rules and regulations are not inconsistent with the terms of this lease.
- C. Comply with any statutes, orders or regulations issued by the state, city, county or federal authorities that are applicable to the Lessee's use and occupancy of the premises.
- D. Pay for its own telecommunication services and installations.
- E. Provide right of access to the Lessor to do maintenance on space after prior approval of Lessee. Access shall not be unreasonably denied.
- F. Reimburse the Lessor for prorated electric, gas, water and sewage.
- G. Secure and pay for its own monthly monitoring service charge for its own alarm system, if applicable.
- H. Provide and pay for janitorial services behind the counter (in the employee work areas, deputy's office, storage area, and break room), and the storage closet located in the customer lobby area.
- I. Provide commercial grade rubber backed mats at the entrance to premises.
- J. BMV to have Excel install data lines on site to a sub Dmarc in the deputy registrar's storage room.
- XI. Lessee shall have the right, with approval of Lessor, to make **ALTERATIONS**, attach fixtures and erect additions, structures and signs in or upon the premises at its own expense. Any such structures whether during the period of this Lease or any renewal hereof, or under a previous Lease between the parties for these premises, shall be and remain the property of the Lessee and may be removed therefrom by the Lessee upon the termination of the Lease or any renewal hereof unless otherwise agreed by the Parties.

- XII. If the premises described in this Lease be destroyed by fire or other casualty, this Lease shall immediately terminate at the option of the Lessee. In case of partial damage or **DESTRUCTION** so as to render the premises untenable, the Lessee may terminate this Lease by giving written notice to the Lessor after the occurrence of said partial damage or destruction and effective upon Lessee vacating the premises.
- XIII. It is further agreed that the Lessee may, at its option, **HOLDOVER** after the expiration of the Lease or any renewal hereof, and such occupancy shall be regarded as a tenancy from month-to-month under these same conditions excepting as to term. Written notification of the Lessee(s)'s intention to holdover shall be given to the Lessor at his last known address, not less than 30 days before the expiration of the term of this Lease or any renewal hereof. Such holdover terminates at the end of the month in which Lessee vacates therefrom, but will not exceed six months unless otherwise agreed upon between the Lessor and Lessee.
- XIV. During the period of this lease or any renewal hereof, the same may be terminated by Lessee by written notice of **TERMINATION**, mailed to the Lessor at his last known address at least 90 days prior to the effective date of such termination. Notwithstanding the foregoing, 90 day notice is not required in the event of Lessor's failure to provide services as described in Section IX.
- XV. **SELF-INSURANCE**. Lessee represents to Lessor that it will be responsible in accordance with the same rules of law applicable to suits between private parties as provided by Ohio Revised Code Section 2743.02, other statutes, and case law. Lessee further represents that it does not have a liability insurance carrier, but that it has the resources and authority, subject to an appropriation by the Ohio General Assembly, to pay damages if liable.
- XVI. **OHIO ETHICS CLAUSE**: Per O.R.C. 102.04 (D): The Lessor affirms by his/her signature that he/she is not elected or appointed to an office of or employed by the General Assembly or any department, division, institution, instrumentality, board, commission, or bureau of the State, excluding the Courts,

Or

The Independent Contractor affirms by his/her signature that he/she is a public official appointed to a non-elective office or is a public employee, but, is exempt from the provisions of O.R.C. 102.04 (A) or (B) because,

- 1. The Lessor is supplying the good and/or services which are subject of the agreement to an agency other than the one with which he/she serves; AND
- 2. The Lessor has filed the required statements with the following agencies:
  - a. The appropriate ethics commission; AND
  - b. The public agency with which he/she serves; AND
  - c. The public agency to which the goods and/or services will be provided.

- XVII. In the event of sale of the property by Lessor, Lessor shall require the purchaser to take the property subject to Lessee's leasehold interests, require the purchaser to fulfill the obligations of the Lessor under this Lease, and to ensure the Lessee's right of possession and quiet enjoyment are not compromised.

- XIX. The words "Lessor" and "Lessee", wherever used in this Lease, shall include the successors and assigns of the Lessor and Lessee, respectively.
- XX. OHIO ELECTIONS LAW. Lessor affirms that, as applicable to it, no party listed in O.R.C. 3517.13 (I) or (J) (including an individual, partner, shareholder, administrator, executor, trustee, or owner of more than twenty percent of the corporation or business trust), nor the spouse of such party, has made, as an individual, within the two previous calendar years, one or more contributions totaling in excess of one thousand dollars (\$1,000.00) to the Governor or to the Governor's campaign committee, consistent with the restrictions under O.R.C. 3517.13 (I) and (J).
- XXI. **EXECUTIVE ORDER 2019-12D, BANNING THE EXPENDITURE OF PUBLIC FUNDS FOR OFFSHORE SERVICES:** The Lessor affirms to have read and understands Executive Order 2019-12D and shall abide by those requirements in the performance of this Contract, and shall perform no services required under this Contract outside of the United States.

The Lessor also affirms, understands, and agrees to immediately notify the State of any change or shift in the location(s) of services performed by the Lessor or its subcontractors under this Contract, and no services shall be changed or shifted to a location(s) that are outside of the United States.

A. Termination, Sanction, Damages:

If Lessor or any of its subcontractors perform services under this Contract outside of the United States, the performance of such services shall be treated as a material breach of the Contract. The State is not obligated to pay and shall not pay for such services. If Lessor or any of its subcontractors perform any such services, Lessor shall immediately return to the State all funds paid for those services. The State may also recover from the Lessor all costs associated with any corrective action the State may undertake, including but not limited to an audit or a risk analysis, as a result of the Lessor performing services outside the United States.

The State may, at any time after the breach, terminate the Contract, upon written notice to the Lessor. The State may recover all accounting, administrative, legal and other expenses reasonably necessary for the preparation of the termination of the Contract and costs associated with the acquisition of substitute services from a third party.

If the State determines that actual and direct damages are uncertain or difficult to ascertain, the State in its sole discretion may recover a payment of liquidated damages in the amount of one percent (1%) of the value of the Contract.

The State, in its sole discretion, may provide written notice to Lessor of a breach and permit the Lessor to cure the breach. Such cure period shall be no longer than twenty-one (21) calendar days. During the cure period, the State may buy substitute services from a third party and recover from the Lessor any costs associated with acquiring those substitute services.

Notwithstanding the State permitting a period of time to cure the breach or the Lessor's cure of the breach, the State does not waive any of its rights and remedies provided the State in this Contract, including but not limited to recovery of funds paid for services the Lessor performed outside of the United States, costs associated with corrective action, or liquidated damages.

B. Assignment / Delegation:

The Lessor will not assign any of its rights, nor delegate any of its duties and responsibilities under this Contract, without prior written consent of the State. Any assignment or delegation not consented to may be deemed void by the State.

XXII: This Lease shall be considered, interpreted, and the rights of the parties determined according to Ohio law. If any provision under this Agreement is later determined to be invalid or unenforceable, the remainder of this Lease shall not be affected by such determination.





This Agreement entered into this 12<sup>th</sup> day of February, 2024, by and between NLA Violet, LLC, a Texas limited liability company; (hereinafter called the "Owner") and the Board of Commissioners of Fairfield County, Ohio (hereinafter called the "County").

WITNESS WHEREAS, the Owner wishes to develop approximately 2.565 acres located at 9695 Basil Western Road, Canal Winchester, OH 43110 in Violet Township, Fairfield County, Ohio, along the Basil-Western Road Corridor (hereinafter called the "Project"), and

WHEREAS, "The Fairfield County Water, Drainage and Sewage Regulations," "The Fairfield County Construction and Material Specifications," and "The Fairfield County Subdivision Regulations" in force on the date of this agreement (hereinafter called the "County Regulations") state the requirements for developing within the County.

NOW THEREFORE, the Owner and the County, in consideration of the mutual covenants set forth herein, agree that:

- I. OWNER RESPONSIBILITIES: The Owner will:
  - 1.1 Develop or cause the development of the Project in accordance with the County Regulations and the construction drawings approved by the County.
  - 1.2 Unless specifically stated otherwise, be responsible for the entire cost associated with developing the Project, including providing the real estate, engineering, construction, fees and deposits.
  - 1.3 Provide the County with construction drawings, specifications and supporting data describing the improvements contained in the Project. The improvements to be provided will include:
    - a. Roads and parking areas, graded full width and paved including drainage structures and other improvements.
    - b. The County also anticipates the future construction of a pedestrian access pathway across the front of the Project immediately adjacent to Basil Western Road (the "PAP") within the County road right of way or immediately adjacent thereto, but which will not impede into Owner's improvements for such PAP, within three (3) business days after complete execution hereof, the Owner hereby agrees to provide the County with a Certified Check in the amount of \$10,220.00 for the estimated construction cost of said PAP, as shown on Exhibit "A". The Owner further authorizes the County to transfer said funds to the Fairfield County Transportation Improvement District. The Fairfield County Transportation Improvement District hereby agrees to utilize said funds

to construct said PAP as part of its Basil Western Road construction project.

- c. Monuments, stakes and all survey control required;
- d. All other improvements shown on the construction drawings as approved by the County. (Such as grading and seeding).
- 1.4 Await the County's approval of the construction drawings and specifications before beginning any construction work.
- 1.5 Give the County at least three days' notice prior to beginning any construction work and will keep the County advised of the work schedule throughout the development of the Project..
- 1.6 Remove or cause to be removed such dirt, debris, and foreign matter from all public rights-of-way, improvements and/or easements as were deposited, left or resulted from the construction of improvements or any nature within the development, within twenty-four (24) hours after being notified by the County that such work is required. Such removal shall be done to the satisfaction of the County Engineer.

#### II GENERAL TERMS:

- 2.1 When there appears to be, or there is in fact, a conflict between this Agreement and the County Regulations, the County Regulations shall govern.
- 2.2 No conveyance shall be made of any lot or parcel smaller in frontage or area than indicated on the plat except for the purpose of increasing the area of another lot.
- 2.3 The Owner shall indemnify and hold the County free and harmless from any and all claims for damage of every nature arising or growing out of the construction of improvements by Owner or resulting from improvements by Owner and shall defend, at their own cost and expense, any suit or action brought against the County.
- 2.4 By signing this Agreement, the Owner acknowledges possession of copies of the:
  - a. Fairfield County Water, Drainage and Sewage Regulations.
  - b. Fairfield County Construction and Material Specifications.

#### **RESOLUTION # 2024-02**

### RESOLUTION REQUESTING THAT THE BOARD OF COUNTY COMMISSIONERS OF FAIRFIELD COUNTY OHIO ADOPT A RESOLUTION PURSUANT TO OHIO REVISED CODE SECTION 303.58 PROHIBITING THE CONSTRUCTION OF ECONOMICALLY SIGNIFICANT WIND FARMS, LARGE SOLAR FACILITIES AND LARGE WIND FARMS FROM THE UNINCORPORATED AREA OF AMANDA TOWNSHIP.

**WHEREAS,** Ohio Revised Code Section 303.58 provided that a Board of County Commissioners may adopt a resolution designating all or part of the unincorporated area of a county as a restricted area, prohibiting construction of economically significant wind farms, large solar facilities and large wind farms; and,

**WHEREAS**, the Board of Township Trustees desires to ensure access to buildable land within the unincorporated area of Amanda Township for future growth in agriculture, residential and commercial sectors in areas with access to major transportation corridors; and

WHEREAS, the Board of Township Trustees has received input from its residents and the overwhelming consensus is that economically significant wind farms, large solar facilities and large wind farms are not compatible with the character or future economic growth and development, either agricultural, residential, or commercial of land in Amanda Township; and

**WHEREAS**, the Board of Township Trustees asserts the use of land in Amanda Township for economically significant wind farms, large solar facilities, and large wind farms is detrimental to the future development of Amanda Township and the well-being of the residents of Amanda Township Fairfield County Ohio.

**NOW THEREFORE**, be it resolved the Board of Township Trustees of Amanda Township Fairfield County State of Ohio, with at least two-thirds of all members concurring in accordance with the Revised Code as follows:

Section 1. That the Board of Amanda Township Trustees hereby respectfully requests that the Board of County Commissioners of Fairfield County, Ohio adopt a resolution pursuant to Ohio Revised Code Section 303.58 designating in the unincorporated area of Amanda Township as a restricted area, prohibiting the construction of any economically significant wind farms, large solar facilities, and large wind farms in the unincorporated area of Amanda Township.
