Review Meeting

The Commissioners met at 9:00 a.m. to review legal issues and pending or future action items and correspondence. Welcome

Commissioner Fix welcomed everyone to the meeting.

Listen & Learn – Human Resources Update

Deputy County Administrator, Jeff Porter, presented on the Fairfield County Wellness Program. Mr. Porter spoke about the Medical Clinic as a pilot program for benefits eligible employees and how it evolved to cover all individuals on the county's health insurance plans. Mr. Porter stated that one of the reasons the clinic was initially opened was due to feedback from staff, and that the clinic has evolved into a savings for the county of over a million dollars to date. Mr. Porter also stated that beyond the numbers, the overall health benefit has been significant, and the next step is for the clinic to address mental health issues. The clinic will now have Jackie Tripp, a counselor with over 20 years of experience, providing mental health care on Wednesdays and Fridays. Mr. Porter provided a handout with statistical data on the health and Wellness Clinic program (document attached).

Jackie Tripp joined the meeting virtually and stated that she was excited to join the county's endeavor. Ms. Tripp emphasized that healthy employees lead to healthy work environments, which lead to healthy communities. Ms. Tripp also stated that employees could meet with her virtually, by phone, or in person, and that she would also be assisting with referrals for family mental health issues.

Jeff Porter shared that the program would be a great addition to the health benefits program. He then introduced Cheryl Reeves, Ashley Lynch, and Lori Hawk, the county's Human Resources team.

Public Comments

Ray Stemen of Lancaster spoke about celebrating the birthdays of Presidents Washington and Lincoln. He also spoke about the first amendment and the First Presidential Thanksgiving Proclamation (amendment and proclamation outlined in handout provided by Judy Stemen).

Judy Stemen shared a handout (included as an attachment) and highlighted main points of said attachment.

Legal Update

Josh Horacek spoke on Senate Bill 52 which was signed into law on July 12, 2021, by Governor DeWine. The bill applies to large-scale wind and solar facilities. Attorney Horacek defined the facilities and outlined the provisions and restrictions for local authorities. Mr. Horacek also clarified the application process for building a large wind farm or solar facility (PowerPoint presentation attached).

County Administration Update

County Administrator Cordle then reviewed the following items from the "Week in Review" through the "Correspondence" received.

Week in Review

COVID-19 Update

Health Commissioner, Joe Ebel, shared that Fairfield County's reported COVID-19 cases have decreased by 35% over the past week. From 2/11/2022 through 2/17/2022 there have been 223 new COVID-19 cases reported, for a rate of 141.5 cases per week per 100,000 population (High Transmission). He also stated that he is hoping the numbers drop below the high transmission level by the end of this week.

There were thirteen new hospitalizations reported in the past week and four COVID-19 related deaths for Fairfield County. One additional death was reported for January for a total of forty-four Fairfield County resident deaths for the month of January and three COVID-19 related deaths have been reported so far for the month of February. Mr. Ebel shared that the Health Department would be closed 2/23/2022 for staff training.

ARP Update

There are multiple projects under review.

From the \$15,303,451.00 received as the first tranche of fiscal recovery funds. \$9.2M has been appropriated, \$2.8M expended, \$4.2M encumbered or obligated.

Idea Box

An employee was inquiring about an electronic billboard to share information such as ride share opportunities. There was something similar in the past that was not used frequently and required some effort of maintenance. Aundrea Cordle will be checking with IT to see if there is anything that would be free and easy to use and maintain.

Virtual Meetings- HB 51

On February 17, Governor Mike DeWine signed House Bill 51 into law. Among other provisions included in the bill is temporary authority for public bodies to conduct public meetings and hearings using virtual technology.

The legislation contains an emergency clause, making the bill effective immediately. This authority is temporary and will expire on June 30, 2022.

 - With three months of data, the average monthly receipts are \$2,436,923.47. Using that figure, the annual estimate would be \$29,243,082. The estimate in the planning tool is \$24,142,820. We continue to evaluate the monthly data but will revisit the planning estimates at the quarterly mark.

Bart Hampson stated that he expects first quarter 2022 sales receipts will be positive.

County Auditor, Carri Brown stated that quarterly revenues in all categories will be examined and that after the quarter is over the county will be able to adjust accordingly.
