Welcome

• COVID-19 Update

Jon Kochis, EMA Director, updated the Board of Commissioners on COVID-19 responses. Members of the Health Department were also present and provided general updates. Mr. Kochis reported the weekend case total was 27 cases. They continue to monitor the biggest testing organization, FMC. Mr. Hanna provided an update about the spike in viral load in the wastewater treatment plants.

Mr. Davis asked what the "color code" of the state's advisory system was currently for Fairfield County.

Mr. Kochis replied it was red and would be red until we have under 100 cases for two weeks in a row, averaging 22 cases a day.

Mr. Hanna provided an update on the number of vaccines distributed each week. When they move to the mall next week that number will go up significantly. With the increase in vaccines, they are seeing a need for more help in the call center.

Mr. Kochis provided more details on the mall location. They are preparing to distribute 1,200 vaccines a day at that location. This would classify the county as a Type 2 Pod nationally (just next to a metropolitan designation). The Commissioners are leading the charge on the location through the Stafford Act.

Mr. Kochis added there are approximately 9,000 individuals 65 and older who have signed up to be vaccinated but have not received the vaccine yet.

The review packet contained fact sheets and notices about the state town hall meetings about vaccinations. The fact sheets are on the state website and have been useful communication tools.

We are aware that banquet settings are permitted to hold events with reduced capacity. We reviewed some additional announcements from the Governor's press conference.

Soon, the vaccination clinics will be moving to the River Valley Mall. The lease has been executed for space from March 1, 2021, through August 30, 2021. Dr. Brown had already approved the lease, which is at a reasonable rate of \$1,000 monthly (lower than current costs).

Mr. Davis and Mr. Fix expressed concern on falling behind in registering people to get their vaccine once they have the option (it is their turn) and as supply exceeds demand.

Mr. Hanna reported that Ms. Krile is working on a campaign plan now. Mr. Hanna will provide the details of the plan as soon as available. He will provide that to Dr. Brown.

Mr. Kochis added that the hardest part of the response is to convince people that the vaccine is safe.

Mr. Kochis provided details on the needs at the call center and what specific qualifications the callers need to have. He and Dr. Brown will arrange for additional volunteers for Thursday clinics in March.

Dr. Varney provided a letter of encouragement for those who are offered the vaccination to take the vaccination. This letter can be used in a variety of communications.

On a related note, we have supported the Health Department on their posting of a Health Commissioner position by drafting a posting, adding graphics, posting with our systems, and paying for the Indeed costs. We will provide applicant information to the Department of Health.

Congratulations to Larry Hanna on his pending retirement. We are certain there will be a proper time to celebrate this occasion.

We have also supported the Health Department on their posting of an Environmental Health Director. Copies of the postings were in the review packet.

b. Highlights of Resolutions

Dr. Brown highlighted 24 resolutions for the voting meeting.

The County Engineer proposed awarding two contracts for bridge replacements (in Violet and Green Townships) and proposed advertising for crack sealing and pavement marking projects, as well as approval of drawings for Refugee Road improvements.

JFS proposed approval of a contract renewal for protective placement in network.

RPC proposed a resolution to approve the Violet Meadows Section 5 Phase 2 Final Plat.

We proposed a resolution to schedule the viewing and hearing for a petition to vacate four alleys in Havensport.

There were 16 financial and grant related resolutions to approve:

- Interest credits for various political subdivisions;
- Six resolutions for memo transactions, appropriations, and fund to fund transfers for Engineer projects;
- Account to account transfers of appropriations for EMA and FCFACF;
- Four reimbursements to the PA fund;
- A new advance for EMA (with appropriations)-and- the repayment of an advance by Juvenile Court; and
- An account-to-account transfer of appropriations for an IT emergency need of equipment (this does not increase the budget, but there could be increases in 2021 proposed based on short term needs of IT).

There were resolutions (and administrative approvals) in queue. For example, we will be proposing a resolution to approve the recommendation of the Fairfield County Revolving Loan Fund Loan Review Committee to fund Wolfe Brothers Diesel as an (RLF-EDA) Project.

Administrative Approvals and Updates

• Administrative Approvals

The review packet contained a list of *administrative approvals*. There were no questions.

• Idea for a Billboard for Ohio Means Jobs

After hearing (yet again) about the misunderstanding about available jobs in the county, Dr. Brown suggested a billboard for Ohio Means Jobs with a local message. There are available jobs in Fairfield County, and there are fewer applicants than there are jobs. If there is a need for financial support for this effort, Dr. Brown will report back.

Mr. Levacy and Mr. Fix were in support of the idea. Mr. Davis abstained from the discussion.

• Idea Box

Here is a summary for February 2021 for the Idea Box:

Idea 47

An employee suggested having the email display name (within an email address) include a middle initial as opposed to middle name for security reasons.

Response:

The County Auditor alerted payroll officers that going forward they can input only the middle initial for formal records. (The email display is a function of the payroll record.)

If there are employees who would like a change in their existing displayed name, they can alert their payroll officer who can make that change working with the County Auditor's Office. Thanks for the idea!

Idea 48:

There was an idea for an additional coat rack at the fitness center (at the Records Center on Chestnut Street) based on increasing usage.

Response

HR will order a mobile coat rack for the lobby and will send some friendly reminders to employees, too, regarding the use of the fitness equipment. Thanks for the idea.

Idea 49:

In general, can the Commission target a 5:30 am deadline for closing buildings due to weather as some people arrive at work at 7 am?

Response:

Yes, the Commission can target a 5:30 am deadline for closing building due to weather, although there could be circumstances to arise that would require a later closing. It is a good opportunity to remind everyone that the EMA Emergency Notification System will be utilized to communicate any closure information. This system utilizes the most up to date employee contact information that is captured in the MUNIS system. This includes cell phones and home phones. Notifications will also be made in the media and on the website. Please also stay in touch with your supervisor.

49 ideas have been received in the electronic idea box. 48 of those ideas have been implemented and/or addressed in detail. An idea under review with IT: A recommendation from January 2020 was presented to IT and to the Data Board, as well. This is under review. It related to password processes. IT is reviewing options and is not ready for the funding of this effort.

Technology Strategic Planning

The first *IT strategic planning work group meeting* yielded some initial summaries regarding mid-term needs for supplemental reporting, conference room upgrades, a court case management system, a public safety system, phone upgrades, and infrastructure needs.

Some infrastructure needs were immediate (hence a resolution for an account-to-account transfer of appropriations for an unanticipated emergency). There may be additional resolutions this year for maintenance type projects. There were other infrastructure needs, but those were not as much of an emergency. The 2021 budget for IT did not include the emergency needs recently discovered as managers were staying within parameters during the pandemic.

Outside of this specific need, the work group will be identifying the costs anticipated over a four-year period. It is reasonable to think of the first year to be about \$3M, with the ensuring three years about \$2M, but the research is very much in its initial stages with only one work group meeting.

There will be at least some support from other funds, outside of the general fund, such as with the 911 related equipment.

Dr. Brown thanked the members of the work group: Dan Neeley, Mark Conrad, Jay Matlin, and LeAnna Schaffer. There may be others to join the work group.

• Records Center Work Group Meeting

The Records Center Work Group met last week and focused on ways to encourage compliance with procedures in the future. A project-based contract for services is possible in the future to help further this effort, creating a manual and offering training.

Letter of Support Provided

Upon request, a letter of support was provided to Ms. Teri Mecionis regarding the naming of a section of highway SR 158 in memory of Sgt. Joseph Collette. The letter was in the review packet.

Budget Update

- There are no recommendations for changes to the 2021 estimates. A letter describing *parameters for 2022* is in progress.
- We are monitoring the federal legislation for pandemic *relief funds* for local governments. There is no additional news to report.
- We are aware of the efforts to *increase the future reimbursement percentage* to counties for indigent defense. We are monitoring state legislation.
- We are also aware of the state's effort to improve *broadband access* in general, but we need more information about how there could be impact to Fairfield County. There have been a few calls and emails about Internet access lacking (or being very slow) in pockets of Fairfield County.

d. BRAVOs

At last count, the HVAC training at the Workforce Center was up to 11, a great outcome for this initial training!

Following the approval of the appropriations dedicated for the feasibility study for the City of Pickerington project, there were a few phone calls/email contacts about the effort. It was reiterated that there was a request from the City of Pickerington for \$25,000 (1/3 of a share of a study that costs \$70,000 + \$5,000 in expenses) for the City of Pickerington to contract for a market analysis, planning session, detailed financial forecast, economic impact analysis, and feasibility report for a project the City of Pickerington is leading for the creation of a sports, fitness, civic, recreation, and entertainment destination in Pickerington, Ohio.

The county resolution was solely for new appropriations for an allocation to the City of Pickerington to support a feasibility study.

Mr. Fix commented that the project was one that is not publicly funded for construction.

Mr. Fix provided an update on his meeting with State Representative Marilyn John who is supportive of CCAO.

Mr. Fix commented on the enthusiasm for a new government services center in the Pickerington/Violet Township area.

Mr. Davis provided an update on the CCAO Tax Policy Committee meeting from last week.

Dr. Brown stated that Mr. Janoso would be meeting at JFS. The meeting would be taped and shared with individuals as part of the educational effort.

Mr. Stemen expressed his concern that a lot of things are being done out of fear. A lot of this is being put on everyone with COVID-19 - such as masking and how it is responded to, in his opinion. He realizes COVID-19 is dangerous, but the statistics he sees, there have not been flu deaths over the year (from his perspective), but the CDC is now redoing the numbers to show more deaths (in his opinion). Mr. Stemen was concerned there is too much shooting from the hip.

Mr. Davis replied that he appreciated Mr. Stemen's thoughts. He has talked to many who have opinions on the virus either way, but the bridge for a small business owner is to understand how the other half is viewing the situation if they want them to be a continuing part of the operations. As a Commissioner, he believes we are much better off getting the economy back on track to be a part of that bridge.

Mr. Levacy expressed his desire to get through the pandemic and then evaluate the conspiracy theories and other theories to see what was correct and what could have been done better. He commented has had friends pass away from this, and it is a very serious disease.
