Review

Legal Update

Mr. Dolin provided an update on the Bloom to Lithopolis Annexation Petition. The petition had several legal deficiencies such as a failure to obtain signatures of all land owners. These are significant, and the petition has been returned to Mr. Matt LaBuhn for corrections.


Administration and Budget Update/Carri's List

a. Debriefing of Sunshine Week

Ms. Brown reported on Sunshine Week activities.

Last week, there was a proclamation to declare the week Sunshine Week. Throughout the year, we work diligently to enhance the public's access to government records and information, to increase information provided electronically and online, and to ensure that all meetings of deliberative bodies under its jurisdiction are properly noticed and open to the public. We continue to encourage members of the public to visit the county website at co.fairfield.oh.us.

Press releases were issued regarding Commissioners attending Ohio EPA training; Sunshine Week; Economic Development and the Workforce Innovation Opportunity Act; customer service efforts at the Dog Adoption Center and Shelter; virtual services for Medicaid applications at JFS; and the State of the County Address (April 19 at Liberty Center).



In addition, Fairfield County was selected by the Auditor of State as an entity included in a test for compliance with Sunshine Laws. The Auditor of State requested a copy of the county policy for public records requests and a list of the requests made. A copy of the county policy and the log maintained by the Board of County Commissioners were provided to the Auditor of State on the same day requested. Other materials have been provided as requested. There are no outstanding questions for the Commissioners or departments under the Commissioners.

We in the Commissioners' Office will offer support and training to any other department who would like it relating to public records from an operational basis. Rachel Elsea volunteered to log items for others if desired.

Regarding the transparency effort, the 2015 accounts payable data will soon be available with the Open.Gov option. There will be a press release when the website is updated. We thank all of the department heads and the elected officials for their support in the transparency effort.

b. Highlights of Resolutions

Ms. Brown provided highlights of resolutions.

The County Engineer proposed approval of the contract and notice of commencement for the Milnor Road project.

There were financial resolutions to approve, such as:

- A fund to fund transfer for the Major Crimes Unit;
- An account to account transfer of appropriations for Meals on Wheels;
- Appropriations from unappropriated funds for the DR Court (Special Projects); and
- The traditional bill list and/or "then and now" related approvals.

c. Administrative Approvals & Budget Update

The review packet contained a list of administrative approvals for the week. There were no questions posed about the administrative approvals.

Ms. Brown reported that the draft parameters letter for the 2017 budget cycle was in the review packet. The plan is to provide the letter to all elected officials, department heads, and financial officers on April 6. The parameters are consistent with the budget meetings, quarterly reviews, and the overview from last week.

The Commissioners were supportive of the parameters letter.

Further, conduit debt has been proposed for Lifeline Ohio Organ Procurement, Inc., a non-profit organization that works with Fairfield Medical Center and other hospitals. The counsel for the conduit debt issuance is Attorney Kamer, a colleague of Attorney Schwallie. Fairfield County was sought out as the county entity for the conduit debt, which means that the debt is "pass through debt" with no liability to the county. Fairfield County has issued conduit debt in the past and qualifies as a "small issuer" in this case.

The fee schedule the Board of Commissioners approved in 2014 would apply to this issue. The fee in this scenario would result in \$2500 as an administrative fee for the general fund.

Please see the letter from Attorney Kamer (in the review packet). This letter outlines the advantages for citizens. We recommend that we issue the conduit debt for 2016, and the county administrator will serve as the point of contact with Attorney Kamer, who will work with the agreements involving Franklin County.

The Commissioners were supportive of the conduit debt.


Regarding sales tax revenues, information from the state website indicates the March numbers are up 12 % as compared to the previous year, bringing the year to date total to about 7%. We will continue to monitor this revenue source, of course.

In addition, we are preparing the accounting structure for the WIOA roles that the economic development department will be performing in the future. In the future, there will be a new fund resolution for WIOA.

d. Jail and Public Safety facility Update

As noted last week, there was an administrative approval for the contract amendment to align the architect deliverables with the construction manager at risk model of service delivery for the jail and public safety facility. This was approved to form and did not involve any changes in expected expenditures.

Mr. Keller holds regular meetings with Granger, and Granger continues to progress very well. We continue to monitor the project. There are no problems to report with the project. There have been reports in the media demonstrating appropriate action is being taken relating to the water supply.



Further, Carri Brown and Dennis Keller will meet with Sheriff's Office leadership to continue planning for furniture, fixtures, and equipment for the project. These will be expenditures in 2017.

The jail population is now 216.

Mr. Keller stated that they had hit a milestone in the construction. Today half of the first floor slab in phase D is being poured with the second half being poured next Tuesday.

Mr. Levacy stated the article in the Eagle Gazette over the weekend was very well done and commended Ms. Remoquillo. He added it should bring the residents' concerns down.

Mr. Davis added that both papers are doing a great job reporting the facts and that he appreciates their reporting.

Mr. Martin stated he was happy with the articles and was glad to hear the water is safe. It is great to hear the concrete is being poured.

Mr. Kiger added that Mike Nixon is doing a great job with the water quality management.

Mr. Slater also asked about the dredging.



d. Allen Road Waterline

The public meeting was held on March 16, 2016 - Of 83 property owners, 38 owners attended the public meeting for information. Others can obtain information from the meeting at the website or by calling the office.

Relating to the project, Commissioners Levacy and Commissioner Davis recently attended technical training for utility management and financial capacity. Leaders of the Ohio Rural Community Assistance Program developed the training, which covered technical, managerial, and financial aspects of utility operations and management. A requirement for participation in certain state funding programs, the training furthers the project for the water line along Allen Road. Additional training will be conducted in April of 2016.

For the project, Fairfield County is seeking a loan through Ohio EPA to construct a water line along Allen Road toward the Fairfield County Developmental Disabilities location in Pickerington. The \$4,100,000 million project qualifies for 50% principal forgiveness, with the balance being financed with low interest.




