Administration and Budget Update/Carri's List

a. Highlights of Resolutions

Ms. Brown provided highlights of resolutions.

We had a proclamation to declare April *National County Government Awareness* Month. We have a calendar of events for April. The state of the county address is April 19th. In addition, there was a press release ready for this awareness.

There were several resolutions for the viewings of April. We have the viewing and hearing day for multiple cases set for April 26 from 10:30 am – 4 pm. This is an efficient way to manage multiple projects and to bring awareness to the process during the month of April, National County Government Month.

Regional Planning proposed the approval of an agreement with MI homes for the payment of specific improvements at Refugee Road, the development agreement relating to Herron crossing, and the supplemental easement and final acceptance for Tollgate school. All resolutions were previously discussed and approved at the Regional Planning Commission.

The Major Crimes Unit proposed approval of a lease, as approved to form by the County Prosecutor.

Fairfield County Family Adult and Children First proposed a grant agreement for approval.

c. Jail and Public Safety facility Update

Mr. Keller holds regular meetings with Granger, and Granger continues to progress very well. We continue to monitor the project. There were no problems to report with the project.

There was a picture from a drone to show the progress of the construction.

The jail population is now 235.

d. Bravos

Old Business

a. Buckeye Lake State Park Dam

Mr. Levacy reported that the third machine should put the project back on schedule to hit the target June 1 completion date for the installation of the seepage barrier.

b. ESC, Fast Forward Project

Ms. Brown provided highlights from an administrative meeting about the Fast Forward project (the proposal is to build a Success Center with grant funds near the Forest Rose School). The meeting was held on March 29th. There were multiple action steps from the meeting; however, those action steps are no longer relevant. The project has not been approved. We have reached out to Marie Ward to see if we can be helpful in any other way.

Mr. Levacy added the Commission would be as helpful as they can.

New Business

a. Security Check-In Unit and Software for the Hall of Justice

Ms. Brown reported that at the Hall of Justice we recently installed the new x-ray security machine at the entrance to the building. This new machine cost was an investment of \$30,000, and it replaced an old, fully depreciated machine. We were fortunate that the old machine lasted as long as it did, and the new machine is a necessity – not a luxury. The machine comes with software which supports law enforcement officers in identifying potential security risks. Working with the recommendations of the security committee, we have also updated the doors at the Hall of Justice and have upgraded cameras inside and around the Hall of Justice and other county buildings.
