Legal Update

Mr. Dolin stated he did not have a legal update.

Administration and Budget Update/Carri's List

a. Highlights of Resolutions

Ms. Brown provided highlights of resolutions.

A Workforce Innovation Opportunity Act workforce investment board member from the Opportunities for Ohioans with Disabilities was proposed and presented for approval as the Board of Commissioners serve as administrative agent.

There was a resolution to formally rescind resolution 2016-02.02.j as the memorandum of understanding as originally approved was not needed. This relates to the Southeastern Ohio Transformation Partners with JFS, which is a project continuing under a separate agreement.

The Sheriff recommended and we collectively proposed to name two members of the Volunteer Peace Officers Dependents Fund Board. The Sheriff will manage the next steps in communicating with the Ohio Department of Commerce.

The Soil and Water Conservation (on behalf of the Commissioners) proposed the approval of an amendment for the Farmland Preservation cooperative agreement. This was an amendment to update the expiration date of the contract and the availability of funds.

There was a resolution to add for an amendment to the Bennett and Williams contract for environmental investigation of the Baldwin building.

There were financial resolutions to approve, such as:

- Appropriations from unappropriated funds for the Family, Adult, and Children First Council; Adult Probation; EMA; and the Engineer within special revenue funds;
- Fund to fund transfers for the Engineer;
- An advance and draw for the Community Housing Improvement Project; and
- The traditional bill list and/or "then and now" related approvals.
- b. Administrative Approvals & Budget Update

The review packet contained a list of administrative approvals for the week. One approval was to further the Carroll CDBG project. Others were for the payment of bills. Ms. Brown asked if there were questions, and none were posed.

Ms. Brown reported that the letter about the budget parameters was emailed to all on Wednesday, April 6. The voluntary budget hearings with the Board of Commissioners are scheduled.

c. Jail and Public Safety facility Update

Granger continues to progress very well. We continue to monitor the project. There are no problems to report with the project. We are on track with all deadlines, even ahead of schedule. There is an administrative meeting scheduled this week to review the furniture and fixtures needed in 2017. The jail population is now 227.

Mr. Keller reported that construction was going well. Cement block wall construction has started in Phase D. Area C floor slab should be poured next week. They are working in a reverse order: Phase D, Phase C, Phase B, and Phase A. They are still a month ahead of schedule and are seeing more reduction in change orders, as opposed to increases in change orders.

The Commissioners expressed their appreciation for Mr. Keller's work.

d. State of the County Address

The State of the County Address is April 19th, during County Awareness Month. The theme is "Safe and Secure Fairfield County" which highlights Fairfield County as our home. There is a video in progress to include with the address.

The State of the County Address will be at Liberty Center.

We will have displays for the new county logo, which will be introduced during the meeting with Mr. Martin Barker later today.
