# County Administration Update

County Administrator Cordle reviewed the Week in Review, Highlights of Resolutions, the Budget Review, Recognitions, and the Jail Population, as follows.

# Week in Review

COVID-19 Update

Fairfield County reported COVID-19 cases have increased by 18% over the past week. From 4/1/2022 through 4/7/2022 and there have been fifty-nine new COVID-19 cases for a rate of 37.4 cases per week per 100,000 population (Low Community Levels). Three new hospitalizations were reported in the past week and one additional COVID-19 related death was reported for March, for a total of three COVID-19 related deaths reported so far for the month of March.

Joe Ebel spoke about new cases of COVID-19 along the east coast and how the number of cases remain low in most areas. He also stated that the Health Department has home tests available.

### ARP Update

There are multiple projects under review.

From the \$15,303,451.00 received as the first tranche of fiscal recovery funds. \$9.3M has been appropriated, \$2.9M expended, \$4.2M encumbered or obligated.

### Career Expo

The Career Expo was attended by 228 students last week. This was a great event for high school students who are seeking employment as well as trying to identify career options. Karie Stone and Mary Rawlins shared some statistics on the successful event.

Karie Stone stated that 228 students from several schools attended the Career Expo that had 34 businesses represented. Ten additional business agreed to join the expo next year. Great feedback was received from the businesses that attended. Businesses in attendance included the USPS, real estate companies, carpentry, and mechanical business, and more.

Mary Rawlins stated emails were sent to teachers regarding speaking with senior high students, and there are plans to speak with Juniors to recruit a higher population to the Career Center. Ms. Rawlins stated the students seemed visibly happy with the expo and had the chance to get experience and job opportunities.

Karie Stone added that they will add jobs and descriptions to the website so students can research outside of the Career Expo.

Commissioner Levacy added the program has been very successful and that he had a chance to talk with students at the expo and they were very excited for the opportunities and resources being provided to them.

Commissioner Fix added he attended early in the morning and had a chance to walk around the room and speak with some of the businesses. He stated he was shocked by some of the numbers these employers need for their workforce and how it speaks to how badly workers are needed. Commissioner Fix added that the Career Center is making a big difference in the lives of students and future workers and asked how we can track who gets jobs.

Ms. Stone stated that she reaches out to students and businesses to get feedback and that students that receive jobs will have the opportunity to attend a signing day in May.

County Administrator Cordle stated she had the chance to attend as an aunt of a student and that many students walked away with a better knowledge of future opportunities.

Director of Economic Development, Rick Szabrak, stated via GoToMeeting that he feels the students are ahead of the curve and that their partnership with the schools means all the difference for the students who are participating.

### Child Abuse Prevention Month Breakfast

Wear blue 4/13/22 in recognition of National Child Abuse Prevention Month, and Job and Family Services is hosting an awareness event at Life Church at 8:00 am.

Corey Clark, Director of Job and Family Services (JFS) added that the breakfast would be a great event and that JFS would like employees to forward individual and group pictures in their blue attire.

### Building Resilience Training

The FACFC Building Trauma Informed Systems (BTIS) has a training scheduled for May 6th, 8:30-4:30pm. The training is being conducted by the Franklin County Building Better Lives Initiative and will focus on the teachings of Dr. Bruce Perry. There is a special registration code for County employees who have received supervisor permission to attend the training.

Raz Sabaiduc, Director of Family Adult, and Children First Council said the training was a great training that Franklin County has utilized and that the training will give those participating a greater understanding of what it means to serve.

### Second Primary Election

With early voting starting last week for the May 3rd primary, Ohio will officially have a split primary election. The date of the second primary, featuring state legislative and state central committee races, remains undetermined, but most signs point to August 2nd as the likely date.

Quality Based Selection (QBS) process for Pre-Qualification of design professionals

Under ORC Section 153.71(A), if the professional design fee is estimated to be less than \$50,000, and the public authority maintains a file with current qualifications (the qualifications must have been submitted within the immediately preceding year), the public authority may select a design professional or firm determined to be most qualified to provide the required services from the qualifications in the file

Facilities Manager, Dennis Keller, worked with the Prosecutor's Office about a process for RFQ's to annually advertise pre-qualifications where the fees are under \$50,000. They will submit statements of qualifications and if they meet the requirements they are added to a list. They have not had this process previously.

# **NFP Insurance Update**

Jeff Porter began by introducing Jim Dustin and Kate Hubben from NFP.

Mr. Dustin gave a presentation (slides included in Minutes) on an internal stop loss pool that allows you to stabilize and lower stop loss, while giving the county premium and long-term savings.

Mr. Dustin began by explaining how the internal stop loss pool allows the county to raise its current stop loss level from \$250,000, thereby decreasing cost of insurance and the basis at which it increases. This allows the county to self-insure the difference between the current level and the new level.

Commissioner Davis inquired about increases associated with stop loss insurance and industry used terminology.

Mr. Dustin explained that stop loss purchased on the market is cost driven and readily controlled. By creating an internal stop loss pool, Fairfield County can increase the level at which stop-loss attaches to a particular claim, potentially moving from the current \$250,000 limit to something higher like \$350,000 to \$400,000. By doing so, the health benefit program sets a premium for the new layer, typically lower than what a traditional insurer would charge. The premium and a portion of the reserve are ceded to a new stop loss fund to pay claims up to the new limit of \$350,000 to \$400,000.

Commissioner Levacy asked if there was an ability to move money back and forth.

Mr. Dustin confirmed that the county can move funds any time there is an imbalance.

Kate Hubben added that Fairfield County had a great year in 2021 and still had an increase in its stop loss.

Jeff Porter stated the county would be marketing and setting rates internally instead of going out into the market, and that he had looked back a couple years on the stop loss insurance.

Mr. Dustin said organizations will not always have successful years and that 20-30% increases are normal, but if the county were to raise its stop loss level, it would have a runway to be able to manage it more efficiently.

Mr. Porter added stop loss is a little different and is one of the areas that is the highest variable cost year after year.

Mr. Dustin showed a slide from Summit County which is approximately twice the size of Fairfield County. He explained that Summit County lowered their stop loss premium significantly, and NFP kept Summit at their renewal rate and have been tracking savings from that process. He added that when NFP built this savings model, they used the averages through 2021.

Commissioner Davis asked what PEPM stood for.

Ms. Hubben stated it stood for Per Employee Per Month.

Commissioner Fix asked about potential downsides.

Mr. Dustin stated there really are no downsides, however, it is possible funds would have to be moved around.

Commissioner Davis asked if many claims landed in that higher range in a year, would it affect the pool negatively.

Mr. Dustin said yes and that this is more of an accounting method with money that is already going to be spent and that the county would be simply peeling out the margin it would give the insurance company.

Commissioner Fix asked how NFP gets paid.

Mr. Dustin said they charge consulting fees.

Ms. Hubben stated she has been working with Fairfield County and that the county would not have to expand it to other entities, and that the sheet provided shows all the different entities that have become a part of Summit County.

Commissioner Davis stated the county was advised to self-insure due to its number of employees and asked if there are other entities of similar size that are doing the same thing.

Mr. Dustin said if the county had under 500 employees, he would not suggest this, but that Fairfield is a good size for it to be worth the energy. He added that it's important to find the sweet spot in the market and for the county to decide if it is comfortable with the risk.

Ms. Hubben said they will always look to see if this would be a loss or if it to be worth it and would adjust the number of claims to find the sweet spot.

Commissioner Davis asked about the deadline for this project.

Mr. Dustin said they are focused on creating the report for the county, and the deadline would be December 31<sup>st</sup>. He continued that it is about control of costs that become more expensive over time and asked the Commissioners when it would be appropriate to have the next discussion. He added that he will consult with the analysts and look at it within 30-60 days.

Mr. Porter stated he would be happy to reconvene with NFP for an update.

Commissioner Fix stated the Commissioners are interested and would like to hear more in June. Commissioner Davis added that he is very interested in the analysis and is very encouraged by the work of Jeff Porter and that if one looked back at the last few years, the county was not in as good of a spot and is very impressed with what is happening with the county's health insurance.

Ms. Hubben added that Jeff Porter pushed them to bring the best options to the county and that many entities have good money saving ideas but can't communicate them.

County Administrator Cordle added that Mr. Dustin recognizes the importance of what the county is doing for insurance.
