Mr. Davis stated he appreciates the Lancaster-Fairfield County and Pickerington Chambers of Commerce for their work in promoting the State of the County. This is the largest State of the County he's seen as a Commissioner.

#### b. Highlights of Resolutions

Dr. Brown highlighted 19 resolutions for the voting agenda.

We had a proclamation to honor Earth Day. Members of the environmental work group, led by Dennis Keller, and students of Forest Rose will be available to receive the proclamation. We will also have opportunity to rededicate the banner for environmental stewardship, all during the voting meeting.

The County Engineer proposed an agreement with the Board of Education of the Lancaster City School District.

RPC proposed the participation agreement for CDBG with Meals on Wheels.

We proposed the final change order (minor) for the Chestnut Street Records Center project.

There were financial resolutions to approve, such as:

- CDBG and HOME draws;
- Approval of the 2019 JAG grant for Major Crimes Unit;
- Account to account transfers of appropriations for JFS;
- Reimbursements to the PA fund for JFS grants (three resolutions);
- Appropriations from unappropriated funds for County Engineer, CDBG, and JFS (four resolutions);
- Memo expenditures for the administrative fee for the health benefits plan;
- Second half allocations for the Soil and Water Conservation District; and
- Interest credits for the Health Department and Parks District.

In progress, we have a resolution for appropriations from unappropriated funds (under \$10K) for the general fund for computer equipment needed for updates to Windows 10. IT is working on a chart to help us determine what more might be needed.

# Administrative Update

### **Budget Update**

We are aligning our county budget with goals. With the implementation of the 20 recommendations for recruitment and retention of employees, there is an opportunity for merit based increases. To participate in merit based increases, departments must use the county performance assessment tools and comply with the county compensation plan.

From a local perspective, casino revenues for two quarters of the year were \$916,977, or 53.8% of estimates. We were a little farther ahead than budgeted with this revenue source (and above last year's actual receipts).

Level 1 budget entry for 2020 closes on April 29.

From a *state perspective*, we remain hopeful about the work conducted to support reimbursements for indigent attorney fees.

#### d. BRAVOs

Thank you to the offices of the County Commissioners, Probate Court, and County Auditor for shifting plans to quickly draft a check for the Lighthouse.

Thanks to Donna Stalter with JFS for supporting us with the creation of a fact sheet from voluminous materials. She and others from JFS joined the efforts of the administrative team in creating packets.

Special thanks to the maintenance crew for replacing the motor on a cooling tower at the Hall of Justice. BRAVO to Ted Schmelzer with the Utilities Department for sharing his expertise to further the project.

BRAVO to the AHA museum for receiving the Ohio Museum Association Institution of the year award for 2019. We send a note of congratulations.

Commissioner Levacy asked for more information about the Lighthouse. Dr. Brown stated that court fees, a portion of marriage license and a portion of dissolution, divorce and annulment fees, are provided to support sheltering from domestic violence. The amounts are set by the General Assembly. The county forwards the amounts to the Lighthouse, and the Lighthouse needed amounts forwarded quickly last week to meet their operational needs. Dr. Brown and Susan Nixon Stoughton will meet on Thursday of this week.

#### Old Business

The viewing and hearing for this vacation petition has been scheduled for Tuesday, May 14<sup>th</sup> at 8:00 a.m. and 12:30 p.m. respectively. Fairfield County will host the hearing. The joint board requires four Commissioners for a quorum and we are waiting on information from the Hocking County Prosecutor regarding how the voting for the resolution will take place.
