The Commissioners briefly discussed projects for payroll support for the Sheriff's Office and Job and Family Services.

Job and Family Services (JFS) funding was discussed and the grant monies that would end in 2024. Heather O'Keefe, Director of Child Protective Services (CPS) with JFS stated that ninety-one case workers are needed in CPS and that they are close to having those positions filled.

Commissioner Davis began the next topic by stating he would first be interested in discussing housing projects and would like additional feedback from Habitat for Humanity. The Commissioners stated their appreciativeness for Habitat for Humanity and their concerns related to the extensiveness of their plans.

Administrator Cordle stated that the Habitat project would be a subgrant and that the county could be appropriating certain amounts and it would be on a reimbursing basis.

ADAMH Director, Marcy Fields stated that ADAMH had merged their multiple housing projects. Ms. Fields spoke about ADAMH's concern regarding reaching the homeless, and mental health and substance abuse among the homeless. Ms. Fields spoke about plans to add 12 beds to the shelter, and 24 supportive housing apartments. Ms. Fields stated that the agency is waiting to hear from the state regarding a grant for 1.9 million and that the total planned projects would cost close to 7 million.

Commissioner Davis stated he would like the support of the Housing Coalition and asked about the Homeless Summit. He also stated his concern that the homeless population in the county may continue to grow and supported working on solutions.

Judge Terre Vandervoort stated Juvenile and Probate Courts proposal for the Community Based Truancy Program and emphasized that there has been a 121% increase in truancy since 2018. Judge Vandervoort added that COVID changed the dynamic in Fairfield County and that in the last two years trauma and mental health issues increased and proposed the addition of 3 case managers for community based truancy case management.

Heather O'Keefe affirmed that CPS has seen an increase in the volume of truancy, and the Commissioners asked questions regarding long term funding needs and truancy statistics prior to COVID.

Auditor Brown presented the Tyler Enterprise EPR Project and stated that the project would help with continuity of operations, and reduced cybersecurity issues and system downtime. She added that she would like to be on Tyler's schedule for June and that the completion of the project would take three months.

The Commissioners inquired as to the yearly costs involved with the project.

Dr. Brown confirmed there would be yearly contractual costs and stated that there is also a need for additional equipment for staff.

Commissioner Fix announced that the ARP Update Meeting would continue in two weeks, on Tuesday, May 10, 2022.

#### ARP Update

The Commissioners reconvened at 12:30 p.m. in the Commissioners' Hearing Room of the Historic Courthouse on 210 E Main St., Lancaster, OH. Commissioner Fix called the meeting to order with the following Commissioners present: Steve Davis, Dave Levacy, and Jeff Fix. Also present: Aunie Cordle, Jeff Porter, Bennett Niceswanger, Rochelle Menningen, Bart Hampson, Corey Clark, Tony Vogel, Dan Neeley, Jon Kochis, Terre Vandervoort, Heather O'Keefe, Dennis Keller, Rick Szabrak, Marcy Fields, Calvin Robinson, and Dr. Carri Brown.

Commissioner Fix began by stating the purpose of the meeting was to have a conversation about the ARP funding and that the meeting is for county officials to gather information for making funding decisions later.

All three commissioners asked questions about the Review Sheet, the figures contained within (Review Sheet provided in the April 26, 2022, Minutes) and appropriations, and County Administrator Cordle stated that the team of people present in the meeting could assist with the conversation.

The Commissioners asked about the Greenfield project and the problems that the Utility Department would like to solve in that area. They also asked about sewer rates and if the project would separate the county from the city, and if the projected cost for the project was an accurate number considering rising construction costs.

Utilities Director, Tony Vogel, stated that a lift station would pump the waste to the county's facility and that Lancaster sewage rates were currently higher. He further added that the rate structure had to remain the same and that the county has water in the project area, and this would separate the county for sewer.

Next, the Commissioners spoke about the MECC joining the system. They added that the broadband project would aid the Sheriff's Office's communications network and spoke about the MARCS tower project and the attractiveness of the project to the State. Mr. Kochis also presented a visual showing where there is a need in the county for a MARCS communication tower and spoke about how the tower enables first responders to interact broadly instead of over radios. The Commissioners and Mr. Kochis also spoke about dispatching and the MECC Council of Governments system, and how dispatch systems effect the Fairfield County Sheriff's Office.

Emergency Management Director, Jon Kochis, and a representative from the Sheriff's Office spoke about the Sheriff's Office's dispatching system and their proposal regarding dispatching consoles.

The Commissioners discussed the Walnut Township project, ODNR, flooding, and water dumping into Buckeye Lake

Jon Kochis stated they have done bids and are planning to name the contractor for the project. He added that the Engineer's Office created 30 substructures to the plan to empty water in the entire area once it's built.

#### Welcome

Commissioner Fix opened the meeting by welcoming everyone in attendance.

#### Listen & Learn, Juvenile and Probate Court

Judge Terre Vandervoort and Fairfield County Youth Counselor, Keith Tremblay, presented on methods of intervention being used by Juvenile and Probate Court to assist youth who have experienced trauma. The presenters spoke on the Juvenile Detention Alternative Initiative, the Strategic Pillars of the court which include youth voice, support, and ideas, the production of a video regarding the youth voice pillar, trauma and resiliency, improved safety for youth involved with the Court, and reducing youth school truancy. A visual presentation was provided and is attached to these (April 26, 2022) minutes.

Keith Tremblay shared thoughts on resiliency and trauma and stated that statistics show that 90% of youth involved with juvenile court have been exposed to trauma, and that to assist these youth, we must recognize how trauma exists, how the brain works, and must look at survival and interventions. Mr. Tremblay stated that looking at these things will help us in making strong members of the community instead of traumatized individuals, and that the more types of trauma experiences by a child, the higher the likelihood the child will have significant struggles with violence, school, and even suicide. He added that trauma changes your body, changes your brain, changes the way you interact, and impacts the rest of your life, and furthermore trauma effects the way your brain responds to stress and the ability to deal with stressful situations. Mr. Tremblay stated that positive youth development can transpire when we create positive relationships and gave the following quote (author unknown), "The child who is not embraced by the village, will burn it down to feel its warmth." Mr. Tremblay explained the brain's resilient zone and stated that trauma throws an individual out of the zone, which keeps them from coregulating, calming down and slowing down. Mr. Tremblay also stated that adolescent brains do not do well with a lot of punishment but do respond to small rewards.

Commissioner Levacy asked for a deeper and complete definition of trauma.

Mr. Tremblay explained that we have an ability to cope, but trauma, especially constant or multiple traumas, keep the brain and body from coping with situations. And that children who grow up with chaos and violence, have brains that think they can never relax.

Judge Vandervoort stated that a brain MRI of youth that have experienced trauma will look very different from that of a brain that has not. She further stated that your brain becomes rewired when you grow up with trauma. Judge Vandervoort also stated that Court staff is trained to
