The City of Lancaster is looking to provide some level of assistance to two non-profit organizations in Lancaster and the County has already completed a subgrant agreement with the Lighthouse that provides support with ARP funds.

Commissioner Fix called a 25-minute recess at 12:35 p.m.

ARP Work Session

Commissioner Fix called the ARP meeting to order at 1:00 p.m. with the following Commissioners present: Steve Davis, Dave Levacy, and Jeff Fix. Also present: Aunie Cordle, Jeff Porter, Rochelle Menningen, Bennett Niceswanger, Dr. Carri Brown, Rachel Elsea, Branden Meyer, Tony Vogel, Jon Kochis, Dan Neeley, Corey Clark, Rick Szabrak, Bart Hampson, Calvin Robinson, Dennis Keller, Marcy Fields, Wayne Chester, Ken Culver, Bryan DeMichael, Marjory Trishman, Bob Heath, Joey Little, Teri Wise, Michael Betts, Josh Weidner, and Bill Vance.

Fairfield County Recorder, Lisa McKenzie, spoke about the Recorder's Office Scanning Project and the project allowing for the recording of documents from 1980 -1996, which would then allow for greater public access and preservation of records. She stated that her office went paperless in 2006.

Commissioner Davis asked about the searchability of records and the interface with the current system.

Ms. McKenzie stated that the systems would be sperate but that the new system would be searchable and added that the actual number for the project is \$384,685.

Fairfield County Clerk of Courts, Branden Meyer, stated that they are requesting \$374,708 to update the court case management system. He is hoping that the system will eliminate the need to replace staff, as staff retires.

Salvation Army Captain, Bryan DeMichael, spoke about the Salvation Army's adult day care program and that due to the pandemic, the adult day care lost \$201,000. He added that they have purchased a facility on Slocum Avenue and that the plans for the facility are to expand the adult day care and food services, and to give teens a place to go. The Salvation Army provided a handout (contained in minutes) and referenced the seven points on the document provided.

Commissioner Davis conveyed his respect for the Salvation Army board and the entire organization and asked if potential monies provided by the county would allow for flexibility in budgeting.

Captain DeMichael responded that it would allow for budgeting flexibility.

Commissioner Levacy asked for an explanation of plans regarding the Slocum Avenue facility.

Captain DeMichael stated that the adult day care would be able to grow from the thirty it currently serves, and that the facility would have a commercial kitchen and a gymnasium. He stated that the current food pantry is 150 square feet and that donations are often received by Meijer and that the pantry does not have refrigeration space to store the donations. He further added that there are plans for showers and that they hope to drive down drug exposure in teens. He said they want a site for basketball and a study area for kids and that the Salvation Army is doing a six million capital campaign to raise funds.

Commissioner Levacy added that Pathway of Hope is a case management program that works with individuals facing homelessness.

Commissioner Fix stated that he appreciated Captain DeMichael and the Salvation Army board and asked if their clients came from different areas in the county.

Captain DeMichael stated that clients are coming from every zip code in the county for either food or the adult day care program.

Bob Heath from the Salvation Army stated that the state limit for the current adult day care is thirty individuals and that over 80% of participants are picked up and dropped off in a Salvation Army van.

Stephanie Taylor from Habitat for Humanity spoke about seven planned home builds, home build sites, partnering with the Land Bank, critical home repair programs, and working with the Workforce Center to build the homes.

Commissioner Davis asked about a completion date for the seven homes that are to be built.

Ms. Taylor stated that the funding for the homes must be used by the end of 2026 and therefore the seven homes would be complete by that time. She also stated that Habitat for Humanity hoped to build on donated land possibly from the land Bank, but that land could be purchased if necessary.

Commissioner Levacy added that many of the lots from the Land Bank had homes that have been demolished.

Ms. Taylor also stated that the home recently built in Pleasantville was larger than typical homes built by Habitat for Humanity and had a cost of \$120,000, and the home currently being built in

Lancaster will total \$100,000. She added that most of the labor is completed by volunteers and that any monies received through county ARP monies would stay in Fairfield County.

Ms. Taylor and Commissioner Davis completed the Habitat for Humanity discussion by publicly thanking Lowes, 84 Lumber, and Carter Lumber for their donations that helped make building the homes possible.

Bill Vance, a local government consultant, presented on the Pleasantville Water Project and the Walnut Creek Sewer District Project. He spoke about the fiscal stress on the communities involved and stated that the Village of Pleasantville had received \$100,000 in ARP money. He added that the Pleasantville Water Project included maintenance of two water tanks and a water sewage upgrade, and that Pleasantville and Thurston are interconnected with water and that they use the same sewage.

Jack Widener talked about the need to update the water plant due to the current development on State Route 37.

Baltimore Village Administrator, Teri Wise, spoke about continued water leaks in the Village of Baltimore's Water distribution System and the quality of the water. She added that her goal as administrator is not to fiscally burden the residents.

Commissioner Levacy asked if the plans included redoing the water lines and if they had steel points.

Ms. Wise confirmed plans for the water lines and stated that most of the points were cast iron.

Calvin Robinson from Fairfield County ADAMH added to the presentation from the first ARP work session and stated that ADAMH is partnering with Lutheran Social Services on their Supportive Housing and Homeless Prevention Project.

Commissioners Fix, Davis, and Levacy thanked the presenters for their time and for the detail in their presentations.

With no further business, on the motion of Steve Davis and a second of Dave Levacy, the Board of Commissioners voted to adjourn at 2:53 p.m.
