Welcome

Commissioner Davis announced Commissioner Fix's birthday and asked Dennis Keller to lead those in attendance in a birthday celebratory song. Commissioner Fix then officially opened the meeting by welcoming everyone in attendance.

Listen & Learn, Severe Weather and Warning

Garrett Blevins, Operations Manager, from the Fairfield County Emergency Management Agency, spoke about severe weather, how to prepare, and how to survive severe storms. Mr. Blevins gave a presentation which included a PowerPoint that is included in the minutes.

Commissioner Davis asked about the response time for getting residents into disaster shelters and about recommendations for residents without access to reinforced areas.

Mr. Blevins explained that shelter doors are programmed to open immediately when sirens are sounded and that the center of the house is typically the safest and strongest. He added that you should stay away from windows and that it is important to practice a preparedness plan in the event of a disaster. Mr. Blevins further explained that there are resources online to help prepare an emergency kit and that social media, news outlets and the National Weather Service are great resources for staying up to date during weather emergencies. He added that Fairfield County has 47 sirens in various locations and that residents should have warning systems inside their homes as well.

Commissioner Fix asked about siren quadrants within the county and Mr. Blevins explained that there are 4 sections of the county, and that the outdoor warning system only alerts the quadrant(s) affected by severe weather conditions.

County Administration Update

ARP Update

There are multiple projects under review.

From the \$15,303,451.00 received as the first tranche of fiscal recovery funds. \$9.7M has been appropriated, \$3.1M expended, \$4.4M encumbered or obligated.

Welcome to Katie Gold, Intern with Economic and Workforce Development

Ms. Gold is attending OU and is currently completing an internship through MORPC and is assigned to our Economic and Workforce Development team.

ODJFS Best Practice Accomplishment for CPS Intake Processing

FCJFS achieved 95% timely completion of all aspects of intakes (screened timely, timely safety assessment, timely family assessment, and case closure within 60 days). This resulted in receiving approximately \$45,000 in incentive funding.

Retiring Veterans Service Commissioner

Commissioner Levacy presented retiring Veterans Service Commissioner Kenneth Gregg an award for 35 years of service to the veteran's community.

Legislation to fund electronic pollbook replacement introduced

Last week, House Bill 673 was introduced on a bipartisan basis and would make available \$7.5 million in state funding for county boards of elections to purchase new or upgrade current electronic pollbooks. The legislation aims to cover 85 percent of the costs, with counties picking up the remaining 15 percent.

Due to aging technology and state security directives, many existing electronic pollbook systems will need to be updated to remain in compliance with state regulations.

We currently have \$68,248 budgeted for this purpose.

Bill regarding local mental health, addiction and recovery boards receives second hearing

House Bill 523 received its second hearing in the House Behavioral Health and Recovery Supports Committee this week.

The committee adopted a substitute bill that makes several changes to the introduced version. Sub. House Bill 523 would allow the board of county commissioners to change the size of the local mental health, addiction, and recovery board. Under current law, a local board may only have 18 or 14 members. Sub. House Bill 523 would allow for 18, 15, 14, 12, or 9 member boards. If a board of commissioners does not wish to change the size of its local board, it does not have to. The bill also allows commissioners to make a size determination for the board once every 4 years.

Additionally, Sub. House Bill 523 would require the board of commissioners to appoint two-thirds of the local mental health, addiction, and recovery board members. The Ohio Department of Mental Health and Addiction Services would appoint the other one-third. The bill also alters the categorical appointment requirements for local boards. One-half of the board members would be required to be any of the following:

- A person who has received or is receiving mental health services or who is a parent or relative of such a person.
- A person who has received or is receiving addiction services or who is a parent or relative of such a person.

Fairfield County Airport Update

The Commissioners met at 10:10 a.m. in the Commissioners' Hearing Room of the Historic Courthouse on 210 E Main St., Lancaster, OH. Commissioner Fix called the meeting to order with the following Commissioners present: Steve Davis, Dave Levacy, and Jeff Fix. Also present: Aunie Cordle, Jeff Porter, Rochelle Menningen, Bennett Niceswanger, Jon Kochis, Bart Hampson, Dennis Keller, Tony Vogel, Rick Szabrak, Staci Knisley, Ray Stemen, Judy Stemen, intern,

Attending virtually: James Bahnsen, Jeremiah Upp, Lori Hawk, and Jeff Camechis.

EMA Director, Jon Kochis, gave an update on the airport project and provided a PowerPoint that is attached to the minutes. Mr. Kochis stated that there is a waitlist of over twenty renters for hangar space rental and options on how to manage the revenue coming into the airport through the hangar rentals. He added that new leases could have longer terms and suggested five-year leases. Mr. Kochis also stated that a new T hangar would pay itself back in the twenty-second year. Mr. Kochis also added that airport tenants pay their own utilities, and that Fairfield County is the only airport outside of CMH in Central Ohio that has a repair component for the occupants.

Commissioner Davis stated that he would be encouraged by a 2% ROI (return on investment) and asked if Mr. Kochis' numbers presented in the PowerPoint were based on 100% occupancy of the hangars and Mr. Kochis confirmed that they were.

Rick Szabrak stated that he spoke with Delaware County and that the last time they built corporate hangars they filled them immediately. He added that Delaware County also stated that their NetJets traffic has expanded, and that they wished they could accommodate more airport tenants.

Commissioner Davis asked if there was a way for the airport to fund the project without borrowing the money and added that a conservative approach would not estimate at a 100% occupancy rate.

Commissioner Fix stated that there would be interest in funding the project if it would not impact the financials of the county. Mr. Fix added that the county has had to be reactive in the past and that he sees this project as being proactive.

Commissioner Davis said he would like to see a more in-depth occupancy estimate and would like to close the loops on funding options available to the county.

Mr. Kochis added that the airport will see additional revenue from fuel costs, renters' fees, and other avenues.

Commissioner Levacy stated that he appreciated the analysis the analysis provided by the board.

Commissioner Fix asked that the investment advisory board, legal counsel, and the Auditor's office be involved in future discussions regarding the airport and asked for an added work session to the agenda. He added that he believes the county is approaching the project in the right way and stated that he does not want airport management questions to hold the county back from expanding into more options. He also added that he is excited that the airport board is projecting out and is pleased with what has been presented to date.

Commissioner Fix called a recess until 1:00 p.m. at 10:52 a.m.

American Rescue Plan Work Session

Utilities Director, Tony Vogel, spoke about two projects, the Greenfield Lift Station Project, and the SR 188 Waterline Project, and provided a PowerPoint presentation that is included in the minutes.

Commissioner Fix asked if there had been consideration regarding having the developers pay for a portion of the work for the Greenfield Lift Station Project.

Mr. Vogel spoke about the approximately 1400 acres and stated that there would have to be improvements on the land before the developers would consider the land. He added that the project benefits would include better rate control and cost savings and additional service provided for US 33 and Coonpath Rd.

The commissioners asked questions about Greenfield area's current rates from the City of Lancaster.

Rick Szabrak added that there is opportunity for development along the corridor.

Deputy County Administrator Jeff Porter asked how much of the area would be available for residential development.

Mr. Vogel added that most of the area could be residential and that at some point the project should be considered because it would be more cost effective for the county to have a lift station in this location, and it would help control the rates and service in the area. He also added that the project would help with future development.

Mr. Vogel stated that the SR 188 Waterline project would be dependent on the City of Lancaster and that the project would involve running a 10-inch water line along Coonpath Rd. He added that most residents are currently on wells and that a memorandum of understanding would need to be developed with the City of Lancaster for water quantity, connection fees, and rates. Commissioner Fix asked there was any reason to believe the county might not receive the second tranche of funding and Mr. Porter stated that there was not.

Jon Kochis spoke briefly about the MARCS tower project and stated that the City of Lancaster gave a verbal agreement to share costs for the project. Mr. Kochis also added that there had been a final discussion with the vendor.

Commissioner Davis asked if any portion of the 2022 General Fund was allocated for the Fairfield Center

Mr. Porter responded by stating how the Fairfield Center aligns with the Federal Government's required use of ARP funds.

The Commissioners spoke about the project requests, totals of the project requested, and the available funds.

Commissioner Fix suggested that the outside entities that submitted project proposals return for a final discussion

County Administrator Cordle spoke about the management and oversight of ARP monies.

Commissioner Davis added that his support for the ADAMH and Habitat for Humanity projects. He added that he believes homelessness and affordable housing issues will get increasingly worse, and that both issues need addressed.

Commissioner Fix added would like the county to be helpful to everyone who presented a project and believes that every project can be connected to one of the six pillars of the county's Strategic Plan.
