Welcoming Back Employees to the Lancaster Downtown

Along with Human Resources and Destination Downtown, we are welcoming many employees back to the office. The review packet contained a draft email for communication to employees. The Commissioners were happy with the communication.

Strategic Planning

In June and July, we will be providing highlights of our vision to engage multiple stakeholder groups in strategic planning, informing use of ARP fiscal recovery funds and other Commission decisions. The purpose of the strategic planning with a third-party vendor will be to obtain input and feedback about longer term goals from community and key stakeholder perspectives. We will be using the Fairfield Forward theme for the planning.

We anticipate catalytic uses of the ARP fiscal recovery funds for the majority of the ARP expenditures. As we think about those catalytic changes, there are two main uses of the ARP fiscal recovery uses that stand out to us:

- 1. Responding to the public health emergency with respect to the COVID19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
- 2. Making necessary investments in water, sewer, or broadband infrastructure.

Mr. Levacy stated that focusing on Fairfield County is the Commission's job and where the Commission can most affect change. Fairfield County is first.

Mr. Davis stated that he and Dr. Brown would be having a discussion with the Fair Board tomorrow to discuss the 2021 Fairfield County Fair.

National Association of Counties Achievement Awards for Fairfield County in 2021

In recent years, Fairfield County has earned 16 NACo Achievement Awards. This year, NACo presented five awards, a record number in a single year:

Achievement Award Category: Human Services
Sustaining & Improving Guardianship-Giving Marginalized Citizens Voice

Achievement Award Category: County Administration & Management Improving County Services During a National Crisis

Achievement Award Category: Arts, Culture, and Historic Preservation Inspiring Placemaking with Mural Art

Achievement Award Category: Personnel Management and Training **Speed Mentoring with Follow-on Coaching**

Achievement Award Category: County Administration & Management Ongoing Preparation for Bond Rating Presentations

We reviewed the attached slide show.

NACo recognized a total of 844 awards in 28 states this year. Franklin County had one top award in Human Services.

Mr. Fix commented that Fairfield County has led the way among larger counties in the state and thanked Dr. Brown for her leadership.

Mr. Davis shared a conversation he had with Dr. Brown regarding the application for the awards and the material provided by the other departments to make the applications possible. He spoke to the transformation that has taken place under Judge Vandervoort and commended her for the great work at Juvenile/Probate Court.

Mr. Levacy commented on how Fairfield County is a mid-size county in terms of population but is at the top for leadership, including how Fairfield County is there to help other entities. He mentioned the importance of technology improvements, as well.

Dr. Brown reported the IT technology work group is meeting this week. A template was designed to help prepare departments for requests for funding for technology improvements.

b. Highlights of Resolutions

Dr. Brown highlighted nine resolutions for the voting meeting.

We proposed rescinding the state of emergency and associated resolutions from 2020 based on the public discussion last week.

Mr. Davis stated he was ready for this resolution more than any other resolution.

JFS proposed a contract for the Summer Youth program with BSSI. We are encouraged to see the Summer Youth employment program available this year.

Mr. Clark provided an update on the Summer Youth program which is now back after several years of not being able to be conducted. Orientation starts this week. He hopes to get at least 25 participants. Employers will likely be more inclined to participate with "traditional employment" as there are opening available in the market with some advertised as being available to teens.

Mr. Levacy commented that he had heard there were three jobs available for every person who is unemployed. Mr. Clark commented that the agency was ready to help those seeking work and that he was aware of local employers seeking employees.

There were seven financial and grant related resolutions to approve:

- A grant agreement (renewal) for Common Pleas Court;
- Appropriations from unappropriated funds for JFS, Clerk of Courts, and County Engineer (and memo transaction for the County Engineer - five resolutions); and
- Stafford Act reimbursements (grant transactions processed by EMA.

On June 8th, we expect the resolution for the enterprise zone agreement for Blue Label.

There were additional financial and contracting resolutions (and administrative approvals) in queue.

For example, we believe RPC will be proposing a resolution to approve the development agreement for the Estates at Lake Forest Subdivision.

Electronic Idea Box

Here is the summary for May 2021

Idea 54: An employee offered a suggestion for a change to a table of organization for an appointing authority.

Response: We thanked the employee for the submission and offered encouragement for it to be shared with the employee's supervisor or appointing authority. Otherwise, we will know there is an employee's support for this idea as it may come up in discussions with the appointing authority. The Commission will continue to provide guidance for budget requests and will evaluate all requests. (The employee followed up and was thankful for the guidance about approaching the supervisor or appointing authority.)

Idea 55: An employee offered an idea for a waiver of the employee share of health benefits costs during the month of December 2021, with connections to achieving health goals.

Response: Thanks for the idea! We will review the possibilities for a waiver of the employee share of the costs of health benefits during the month of December 2021. This was done similarly in 2020. We will also review ways to help employees meet health goals. Again, thank you for your idea.

Idea 56: An employee offered an idea to use "COVID funds" for bonuses.

Response: While CARES Act funds were used by the end of 2020, American Rescue Plan fiscal recovery funds are now being evaluated for use. Everyone is very appreciative of the hard work of the essential employees of Fairfield County. We are evaluating all potential uses and will keep everyone informed. One thing to keep in mind is that as we think about catalytic changes, there are two main uses of the ARP fiscal recovery uses that stand out to us:

- 1. Responding to the public health emergency with respect to the COVID19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
- 2. Making necessary investments in water, sewer, or broadband infrastructure.

There will be a strategic planning process engaged for the use of American Rescue Plan fiscal recovery funds. Thank you for your idea.

An idea under review with IT:

 A recommendation from January 2020 was presented to IT and to the Data Board, as well. This is still under review with IT. The recommendation related to password management.

Mr. Davis stated the ARP was designed to spend money and show nothing for it. He stated whatever Dr. Brown and Ms. Cordle can do to frustrate that intent is appreciated.

Dr. Brown added the county focus is to spend money on items that are catalytic or more long term in nature.

Budget Update

The sales tax estimate for 2021 in Fairfield County is \$23.6 M, or 3% above the sales tax revenues of 2020.

On June 15th, level 2 data entry ends for the tax budget.

Old Business

a. COVID 19 Update

Mr. Kochis added that they will start to transition away from the clinic at the mall and move the clinic to the Health Department. Mr. Kochis reported that EMA protocol was prepared for the major disasters and in the "gray area" of the COVID19 emergency, there were many lessons learned that will help with future responses. He went on to report that the clinic is being moved away from the mall based upon current needs.

Dr. Brown reported we are moving ahead with the amendment to the lease for the Health Department, allowing the move of the clinic from the mall to the Health Department.

Mr. Fix thanked Mr. Kochis and his team for the work they conducted to keep the county safe over the past 15 months. He also thanked the team at the Board of Health.

Mr. Ebel reported that the numbers for May are continuing to trend down. They do expect small waves again in the fall as kids return to school.

Dr. Brown added on May 27th, Fairfield County moved from "red" to "orange" in the state health advisory system, and those maps were retired by the state on the same day.
