- **Welcome**

Commissioner Levacy welcomed everyone to the meetings. He commented on the 4<sup>th</sup> of July weekend and its importance.

- **Fairfield Forward**

Dr. Brown stated how appreciative the county is for the parks and 4<sup>th</sup> of July committee for the events held over the weekend.

Mr. Davis spoke to his experience at the fireworks on Monday night and thanked the Sheriff's Office for their presence at the event.

**Special Events**

The review packet contained a flier about Fairfield Forward events.

**Strategic Planning**

We will continue to use the Fairfield Forward theme for strategic planning. We anticipate catalytic uses of the ARP fiscal recovery funds.

There are two main uses that stand out to us:

1. Responding to the public health emergency with respect to the COVID19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
2. Making necessary investments in water, sewer, or broadband infrastructure.

As we think about the first purpose, we will need to:

- Identify a need or negative impact of the public health emergency,
- Identify how the county investment would specifically address that need, and
- Readily explain how the investment helps the county respond to the disease or the harmful economic consequences of the economic disruption.

We are envisioning a questionnaire or one-page evaluation for the two purposes and the bulleted statements for the first purpose. This could help stakeholders plan for the strategic planning.

July 27 marks the community strategic planning kick-off. The purpose of this kick-off meeting is to introduce the process and expectations for strategic planning to elected officials and department heads.

We hope to have timeline envisioned for the strategic planning, to share the list of stakeholder groups, and to generally become acquainted with RAMA, the vendor supporting the stakeholder group effort.

The meeting is envisioned as an in-person meeting but there will be a "Go to Meeting" option available for convenience.

Today, at 11:30 am, Commissioner Davis and Dr. Brown are connecting with members of the Fair Board to review potential options to help with the County Fair as we come out of the pandemic and address its effects.

- b. Highlights of Resolutions

Dr. Brown highlighted 14 resolutions for the voting meeting.

We had a resolution authorizing the approval of a construction agreement and bid award for the Sheriff's Office shooting/training range, following the competitive bidding process and as discussed earlier.

Jeff Barron from the Lancaster Eagle Gazette was participating virtually and indicated he would connect with Chief Collins about the shooting range.

We had a resolution to approve a contract with the Village of Pleasantville for nonresidential building inspection services.

We had a resolution to set a hearing date of August 24, 2021, at 11:30 a.m. for a drainage improvement project for the Rushcreek Estates Drainage Maintenance District. The review packet will contract fact sheets, a letter, and a spreadsheet.

The purpose of the hearing is to communicate about the needs for the DMD so that there will be available resources to maintain the DMD properly. We will obtain a little more information from the County Auditor to help with the written communication that will be sent to the property owners.

There were 11 *financial and grant related resolutions* to approve:

- An updated policy statement about the purchase of de minimis food (with an effective date of June 22, 2021, and including notations about community engagement and documentation needed for such engagement, relative to the purchase of food or refreshments in a de minimis manner, when any of the food or refreshment expenditures are made from public monies);
- An account-to-account transfer of appropriations for Common Pleas Court;
- A resolution to approve a reimbursement from DD for share of costs for liability insurance paid to CORSA as a memo expenditure for fund# 2060;
- Planned allocations for multiple departments (four resolutions);
- Appropriations from unappropriated funds for FCFACF (three resolutions);
- A resolution approving authorized use, memo transactions, and appropriations from unappropriated funds into major expenditure object categories, relating to the American Rescue Plan (ARP) Fiscal Recovery Fund# 2876 , for leasing and adapting space for the Board of Health as a COVID-19 response, mitigation, and prevention activity.

There were additional financial and contracting resolutions in queue.

For example, in queue, we had a resolution authorizing the SFY 2022 Help Me Grow Early Intervention service agreement between the Fairfield County Commissioners, as administrative agent of the Fairfield County Family, Adult and Children First Council and the Lancaster-Fairfield Community Action Agency. This is a renewal of an agreement.

- Leadership Academy – Going Strong

We continue to encourage the leadership academy training and have had several employees sign up for the next session with NACo.

- Competitive Bidding for the Baldwin Paving Concluded

Following a competitive bidding process, we had a good bid on the Baldwin parking lot project, just under \$160 K, the Engineer's estimate. Spires Paving was the winning bid. We will likely see a contract for approval at the July 13th Commission Meeting. Dennis Keller stated he was eager to put the final touch on the Baldwin project.

#### Budget Update

The sales tax estimate for 2021 in Fairfield County is \$23.6 M, or 3% above the sales tax revenues of 2020. We are tracking ahead of that estimate, but we have not changed the projection or planning tool.

On July 7<sup>th</sup>, there is a tax budget public hearing. It has been advertised in the media.

On July 27<sup>th</sup>, there will be an additional mid-year review of the budget.

#### d. BRAVOS

Congratulations to Chris Wagner with the County Auditor's Office and all of Fairfield County for issuing the CAFR one day early! Thanks to Chris Wagner and Josh Crawford (with JFS) for demonstrating extra effort to help ensure there are no late ACH pay-ins, too.

BRAVO to the Real Estate Assessment front line staff for their exceptional customer service. Dr. Brown received a call of thanks for their attention to detail and polite, courteous service.

#### a. Commissioner Communications

We continue to appreciate the CCAO engagement with the state budget process.

Indigent defense is budgeted at 100% reimbursement for counties. We will monitor the reimbursements. Dr. Brown reported a recoupment plan would need to be filed, and she will review the requirements.

We will keep our eyes on the new process for approvals of wind and solar energy sites.

The Governor vetoed the ADAMH Board composition changes, which maintains the current process where Board members are appointed by both the state and County Commissioners, with a broad range of perspectives provided by the board members.

State Senator Tim Schaffer reported on \$350 M in the state budget for brownfield renovation, with \$1M allocated to each county (at least).

### Don't Fall for the Hard-Sell on COVID Jab

The American Medical Association (AMA) claims that 96% of doctors are themselves fully vaccinated. So, if 9.6 out of 10 — not a mere four out of five doctors recommend something, it must be "right for you."

The Association of American Physicians and Surgeons (AAPS) decided to check out the AMA's 96 percent claim.

It turns out that the AMA's 300 survey respondents were not inclusive of all doctors. In the AAPS survey, nearly 60% of some 700 respondents said they were *not* "fully vaccinated."

Of these, 80% said "I believe risk of shots outweighs risk of disease."

Both physicians and nonphysicians were invited to submit comments about side effects in patients that they were aware of. More than 2,500 did so, and these are available just as entered — no screening, editing, or fact-checking.
