#### **Review Meeting**

The Commissioners met at 9:00 a.m. at the Historic Courthouse on 210 E. Main St., Lancaster, OH. #### Welcome

Commissioner Fix opened the meeting by welcoming everyone in attendance. He spoke about the success of the Lancaster Festival and thanked everyone involved in the preparation for their hard work.

### <u>Listen and Learn - Family, Adult and Children First Council</u>

Executive Director of Family, Adult and Children First Council (FACFC), Raz Sabaiduc, provided a Listen and Learn. He began by giving a brief history on FACFC and their purpose within the community. Mr. Sabaiduc stated that the council has areas of focus which include: the Help Me Grow Program – Early Intervention, Service Coordination, Community Needs Assessment/Gap Analysis, and Interagency process to identify local indicators for child well-being. One of the strengths of the council is the willingness of Fairfield County to collaborate, which enhances the services being provided to families. FACFC actively looks to identify resources to fill gaps. He added that FACFC communicates with different agencies to distribute resources out to families and individuals. One such resource is the distribution of car seats where in previous years there was no program like it. FACFC has different sources of funding to support their programs around the county. He also stated that there are also funding partnerships at the state level to fill other gaps. Mr. Sabaiduc went on to speak about some of the different initiatives and committees FACFC heads and added that the Multi-System Youth Program provides and monitors a service coordination system to multi-system children and youth.

Commissioner Fix asked Mr. Sabaiduc if he knew how many children in Fairfield County were born with substance abuse problems.

County Administrator, Aundrea Cordle, later provided there were 146 babies born with confirmed substance abuse in Fairfield County in 2021.

Mr. Sabaiduc added that the Community School Attendance Program is a new program that addresses the truancy problem seen among some students in the county, and that many times, these students are experiencing issues at home. As a result, FACFC has partnered with Juvenile Court and Job and Family Services, Child Protective Services to support these students.

Commissioner Levacy stated his admiration for the level of collaboration among the different agencies and organizations in Fairfield County to provide care and services to these families.

Commissioner Fix stated he is grateful for the work of FACFC.

#### **Public Comments**

Ray Stemen of Lancaster spoke about the programs presented by Mr. Sabaiduc and how historically churches had provided this type of assistance. Mr. Stemen concluded his comments by saying a prayer for all those in attendance.

Judy Stemen of Lancaster read highlights from a handout she presented to the commissioners. The handout is provided in these minutes.

Steve Clapper from the Historical Aircraft Squadron spoke about an airshow event that he would like to bring back to the community and added that proceeds from the airshow would go back into the community.

## Legal Update

County Administrator, Aundrea Cordle, spoke about a scheduled closing for the purchase of the Fairfield Center in Pickerington.

## **County Administration Update**

ARP Update

From the \$30,607,546.77 received as the first and second tranche of fiscal recovery funds. \$15.7M has been appropriated, \$4.4M expended, \$7.0M encumbered or obligated.

Workforce Center Summer Camps

Rick Szabrak provided a recap of the junior high summer camps that just completed at the Workforce Center. He stated that it was successful, and they had a high turnout. He also added that students had the chance to get hands-on experience in different professions and that parents were invited to see what the students were working on and received lots of positive feedback.

One Columbus Board Meeting

Rick Szabrak has been appointed to the One Columbus Board and is the only non-Franklin County member. Ms. Cordle stated that Mr. Szabrak does a great job representing Fairfield County.

RFP for the development of the 2022 Economic Development Strategic Plan Including Updating the 2018 Comprehensive Land Use Plan

This RFP was released on August 1 with an anticipated award date of September 26. This will allow for interviews and meetings to begin upon award in late September through Thanksgiving and then plan work will take place in December and January with an expected roll out in February.

Wear Green for Child Support Awareness

Everyone is encouraged to wear green to recognize Child Support Awareness month tomorrow, August 3. One in three children are impacted by the child support program.

#### Fairfield Center

Notice has been received from Ohio University that a closing date has been scheduled for August 15. # NFP Stop Loss Evaluation Discussion

Jim Dustin, Managing Director with NFP, and Kate Hubben, Vice President of NFP, presented information about the Fairfield County Stop Loss Pool, and provided statistical data that is provided later in these minutes.

Ms. Hubben briefly explained the county's current insurance stop loss program and stated that there was not an internal stop loss pool proposal prior to 2020 because the data did not quantify an analysis.

Mr. Dustin stated NFP wanted to be conservative in their approach of an internal stop loss pool and that NFP's position is to reassure the difference between the current and proposed programs. The concept of the county paying itself through an internal stop loss pool was explained as Mr. Dustin stated the savings would have been over \$500,000, had the county used this approach in 2021. Mr. Dustin added that the county paid Stop Loss premiums of \$927,811 in 2021 and that spending would be significantly less with an internal Stop Loss program.

Commissioner Fix stated this would be a huge savings for the county and the Commissioners are very appreciative of NFP's efforts and will look for a recommendation from Deputy County Administrator, Jeff Porter.
