Strategic Planning

*Main Uses of the ARP Fiscal Recovery Funds*

We will continue using the Fairfield Forward theme for strategic planning. We had fact sheets on the table to show how we anticipate catalytic uses of the ARP fiscal recovery funds. There are two main uses for us:

1. Responding to the public health emergency with respect to the COVID19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
2. Making necessary investments in water, sewer, or broadband infrastructure.

As we think about the first purpose, we will need to:

- Identify a need or negative impact of the public health emergency,
- Identify how the county investment would specifically address that need, and
- Readily explain how the investment helps the county respond to the disease or the harmful economic consequences of the economic disruption.

Last week, Dr. Brown reported the state announced it will issue infrastructure grants for water and sewer projects. The County Engineer will prepare a list of prioritized projects. Subdivisions may apply for these grants, and there was a memo shared about the opportunity.

From a Fairfield County perspective, on July 27<sup>th</sup>, we held a kick-off meeting for the strategic visioning process and will continue to report on the strategic visioning process. There is positive energy surrounding this effort.

In addition, there is a lot of positive feedback about the support of the Fairfield County Fair and tourism. See the article and positive reports in the review packet. Carri Brown and Aunie Cordle met with representatives of the Fairfield County Agricultural Society on July 29<sup>th</sup> to begin outlining procedures for the subgrant award and its monitoring.

Also, there were a lot of ideas about how we can be good ongoing communication partners to support the Fair and the tourism related events at the fairgrounds.

Carri Brown and Aunie Cordle also met with Joe Ebel and Jamie Ehorn with the Board of Health to help further the process for subgrant awards for them. These subgrant awards will support a clinic and public health efforts, as well as two staff members for recovery.

See the review packet for a summary of the ARP expenditures, encumbrances, and appropriations (along with a system generated balance sheet) as of July 31, 2021. There will need to be a lot of thought and effort put into the federal reporting.

As a side note, the CARES Act audit with the State Auditor went very well. There are no issues at all to report. Fairfield County appropriately used its CARES Act funding within the original deadline and has documented its expenditures and processes.

Commissioner Levacy commented that the CARES Act and the current ARP funds are being used in the most appropriate ways. He was glad to hear that the State Audit went well. He thanked Dr. Brown and Ms. Cordle for the great job they are doing.

b. Highlights of Resolutions

Dr. Brown highlighted 14 resolutions for the voting meeting.

We had a resolution to approve the 2022 holiday schedule to reflect Juneteenth for communication purposes, and to reflect the anticipated Fair Day.

We had a resolution authorizing the approval of a service agreement by and between Fairfield County Sheriff's Office and the Lancaster Board of Education for school security (as normal procedures).

There were 12 *financial and grant related resolutions* to approve:

- Approval of two new funds for the energy conservation project;

Commissioner Levacy commented about the new energy conservation project. He remembered the Moody's presentations for the jail project. He added that Dr. Brown led the new Moody's presentations with great efficiency. The county bond rating remains a Aa2 credit rating. The most recent debt issue resulted in an interest rate of 1.58%. In addition, the energy conservation project will have a good return on investment.

Mr. Keller commented that it has been about seven years since the last energy conservation project. We have saved about \$500,000 in utility costs alone.

Dr. Brown reported that the 1.58% all in rate is the lowest rate the county has seen for any issuance. The first debt payment of \$450,000 for the new debt is due in 2022. The project includes HVAC improvements, sandstone wall improvements, windows at the Hall of Justice, a solar array and more.

- A fund-to-fund transfer of appropriations for the FCFACF, as well as two resolutions for appropriations for FCFACF; and

- The payment of bills over \$100,000.

*Administrative Approvals*

*Administrative Meeting Held at Coyote Run*

On July 27, the Fairfield County Executive Team (consisting of Commission Department Heads) visited Coyote Run. Coyote Run is a working farm and private conservation project located in Pickerington and Violet Township. Coyote Run Farm owners David Hague and Tammy Miller are restoring nearly 900 acres of land to its natural state.

The review packet included a press release and pictures. We sent a nice note of thanks to Mr. Hague for his hospitality for meeting us so early in the day of our business meeting.

*Administrative Approvals*

The review packet contained a list of administrative approvals. There were no questions posed.

*Data Board Projects*

Carri Brown now chairs the Data Board, and Branden Meyer is vice-chair. The County Auditor designee (Dan Neeley) is the secretary of the Data Board. This executive committee will be meeting more regularly than the board has been meeting in order to move some of the strategic IT projects forward. The Executive Board will be meeting this week.

*Invitation to Bid Announced*

The county website includes an invitation to bid for entry plaza and sidewalk improvements (as well as bollards) for Liberty Center. The bids are due August 11. The Engineer's estimate is \$79K for the project. This is one of the projects delayed based on the uncertainty of the pandemic, and we are eager for the improvements the project will provide.

*Sales Tax Holiday*

From 12 p.m. Friday, Aug. 6 through 11:59 p.m. Sunday, Aug. 8, the state of Ohio will charge no sales tax on several items. The following items are exempt from sales and use tax:

- Clothing priced at \$75 per item or less
- School supplies priced at \$20 per item or less
- School instructional material priced at \$20 per item or less

Budget Update

*Ongoing Sales Tax Review & Budget Review*

The sales tax estimate for 2021 in Fairfield County is \$23.6 M, or 3% above the sales tax revenues of 2020. We are tracking ahead of that estimate, but we have not changed the projection or planning tool.

Casino revenues are \$1.55 M year to date, and we have estimated \$1.75 M for the year, with one more quarter remaining to be paid to the county treasury in November. The deposit in August for the May-June period was \$610 K, above an average of about \$475 K. The next deposit is for the activities of July – September. The estimated \$1.75 M for the annual period is likely lower than the actual will be; there is no recommended change, though to the estimate.

At mid-year, all revenue categories increased except for interest income, which is expected based on the drop in the interest rates. At mid -year, revenues are up 14.55%, and expenditures are about flat. We expect increases in expenditures based on negotiated agreements and projects that are beginning to take off.

There is a Budget Commission hearing on August 9<sup>th</sup>.

Budget entry for level three has been extended to September 9 (instead of September 2).

d. BRAVOS

Last week, we discussed the good news about the refunding of bonds (a savings of more than \$2M in debt service) and the issuance of new bonds for the energy conservation project (at an all-in rate of 1.58%).

There was a lot of work going on behind the scenes to make that process run smoothly, and there have been two reviews from Moody's in the past half year, with each review resulting in a Aa2 bond rating, an exceptional credit rating for a county. Now, there is a lot of additional accounting that will occur to accommodate the refunding and new debt (with about a \$450K payment annually for the energy conservation project outlined in the posters in the hallway of the Administrative Courthouse).

*Thanks to Staci Knisley* for making the adjustments needed for the accounting and for working with representatives of the State Auditor's Office to help with note disclosure. Thanks to Staci Knisley for covering for Rachel Elsea while Rachel is out of the office. We love the teamwork in the Commission's Office.

*Thanks to the team for setting up a radio tower for EMA*, saving the county about \$10,000! Tammy Smith, Adam Barker, Charlie Barker, Brad Berry, Tod Noland, Garrett Blevins, Tony Vogel, Josh Anders, and Jon Kochis assisted in the tower install.

Also, thank you to the *Facilities Team* for their work with the Recorder's Office and the other adjustments to the second floor of the Administrative Courthouse.

Mr. Kochis thanked Utilities and Facilities again for their work. He also thanked the Lancaster Parks for their help. The Parks dug a hole for the tower. Dr. Brown stated that the Commission would send a note of thanks to the Lancaster Parks District.

Mr. Slater added that Facilities was working on renovations on the 2<sup>nd</sup> floor of the Administrative Courthouse, and he was very pleased with the outcomes.

The Festival leadership featured a video about the festival and its activities over the last 35 years. He stated Ms. Cordle did an excellent job with her part of the video. He asked Ms. Cordle if her video was unscripted. Ms. Cordle responded that the video was unscripted. Commissioner Davis also stated Bob Competti did a good job with his portion of the video.

*Leadership Academy*

Commissioner Fix stated he is now attending the NACo Leadership Academy. There were about 10 other people from Fairfield County participating in his cohort. He was glad to see the participation.

*Communication with State Officials*

Commissioner Davis reported that he spoke with Lt. Governor Husted. Mandates and lockdowns are not forth coming.

Dr. Brown added that county officials have had communication with state agency leadership, and that is the general theme: There are no plans for lockdowns relating to COVID-19. The health department still has availability of the vaccination, which continues to be a promoted method of safeguarding. The Health Department continues to communicate about the available vaccination clinics and to provide health education.

*Sports Complex Study*

Dr. Brown reported The study from the City of Pickerington for the sports complex analysis and evaluation is due soon. The City of Pickerington leadership will reach out to us to schedule a time to connect about the study. Commissioner Fix added that he spoke with Greg Butcher recently. The report for the sports complex analysis will be completed late this week or next week. Mr. Butcher will reach out to Dr. Brown once the report is received.




