**Review**

The Commissioners met at 9:01 a.m. to review legal issues and pending or future action items and correspondence. Commissioner Davis called the meeting to order with the following Commissioners present: Steve Davis, Dave Levacy, and Mike Kiger. Also present were Carri Brown, Staci Knisley, Amy Brown-Thompson, Joshua Horacek, Michael Kaper, Tony Vogel, Jeff Porter, Ray Stemen, Dennis Keller, Spencer Remoquillo, Loudan Klein, and Rick Szabrak.

- Legal Update

Mr. Horacek stated that he had no legal update to report.

- Administration and Budget Update/Carri's List

- a. Announcements and Date Reminders

- Cybersecurity training sponsored by the State Auditor is September 13 at the new jail. Ms. Brown will attend; there are some vacant spots available for registration.
    - United Way Day is September 14. (Thank you to Branden Meyer and his staff for their leadership. There is a flier in the review packet. Thank you to Commissioner Levacy for his leadership in serving as the campaign chair.)

- b. Highlights of Resolutions

Ms. Brown provided highlights of resolutions proposed for the voting agenda.

We proposed two resolutions relating to the ditch petition for Ballard Lane. The first resolution was to accept the petition and document the additional steps in the process. The second resolution was a required financial transaction transferring 25% of the preliminary estimate of the project from the general fund to the ditch maintenance fund. There were copies of the resolutions for review.

There were financial resolutions proposed, such as:

- Appropriations from unappropriated funds for the FCFACF Council (two resolutions), EMA, and the County Engineer (three resolutions), all non-general fund adjustments;
- Account to account transfers of appropriations for the County Sheriff to properly classify expenditures; and
- The payment of bills (including the UHC payment for the health benefit plan & approval and payment of then and now certifications or substitute then and now certifications, as needed).

Next week or soon thereafter, we are aware that Job and Family Services plans to propose three transportation contracts for approval. One is with Creative Coach; one is with Carealot; and the other is with the Center for Disabilities.

The review packet contained a list of administrative approvals for the week. Ms. Brown stated that the Darktrace agreement was also approved and added to the list. This agreement authorized Information Technology to purchase a security appliance known as Darktrace. The purpose of the appliance is to improve security.

*Jail Population*

The most recent report on the jail population shows the population is 334.

Commissioner Davis asked Assistant Prosecuting Attorney Joshua Horacek to research why the number has increased so dramatically, surmising the holiday weekend contributed to the increase.

*Schedule for Review of Agricultural Security Area Application*

Ms. Brown reported that Jonathan Febrache sent a schedule for review of an agricultural security area application, and a packet was in the review packet. The Board of Commissioners' hearing is October 24.

Mr. Vogel stated that the security area is not in the right of way of the Ohio Department of Transportation (ODOT). There were previous problems with Millersport extending utilities to the area.

Mr. Horacek provided clarification. The phrasing of the relevant statutes indicates roads and their rights-of-way are intended to be viewed as "within the area" for purposes of the ASA. If the Board were to ultimately approve an ASA that includes St. Rt. 37, the Board would have to

commit not to initiate, approve, or finance any water and sewer lines, including their installation along the portion St. Rt. 37 included in the ASA for a period of 10 years.

Ms. Brown reported that we inquired if the timeframe could be shortened, and it cannot.

Commissioner Davis stated that the Commission will continue to work with Mr. Ferbrache and others and will take appropriate action when additional information has been received.

*Prosecutor's Annual Report as to Criminal Prosecutions*

Ms. Brown reported that the Prosecutor's Annual Report as to Criminal Prosecutions has been received and will be added to the minutes.

Commissioner Davis stated at 9:20 a.m. that the Commission will be in recess until the 9:30 a.m. meeting regarding the CFLP application.

**Meeting regarding the CFLP Grant application review**

The Commissioners met at 9:31 a.m. with CFLP grant application partners Jennifer Valentine, Deputy Gary Hummel, Elisa Dowdy, and Chad Reed. Commissioner Davis called the meeting to order with the following Commissioners present: Steve Davis, Dave Levacy and Mike Kiger. Also present were Staci Knisley, Carri Brown, Joshua Horacek, Amy Brown-Thompson, Tony Vogel, Spencer Remoquillo, Jeff Porter, Jon Slater, Jr., and Jon Kochis.

Ms. Valentine from the County Health Department reported that the partners met about a week ago to discuss their funding applications. The Health Department asked for \$27,246.60, which is about 40 % of Ms. Valentine's salary.

Ms. Dowdy with the Sheriff's office reported that their request was for \$94,378.97, which is 100% funding for the litter control officer. It is approximately \$1,500 over 2017's award.

Mr. Reed reported that Community Action's request for the education portion of the grant was for \$160,149, an approximate increase of \$5,000. The litter collection request is for \$1,303.55 and the Residential Recycling request is for \$440,542, approximately a \$9,000 increase over 2017's award. This increase is due to the out of state waste revenue that has increased in Perry County.

Commissioner Davis stated that in the past there were discussions of how funding might be reduced, but now there is an incredibly strong carryover of funds for future grants. He looks favorably on the applications and thanked everyone for their collaboration.

Ms. Brown asked Mr. Reed for a list of the Adopt a Road volunteers in the Amanda area.

Ms. Brown reported that she and Chad Reed will meet on September 13<sup>th</sup> to review locations for recycling trailers as there is a need for a new location. Hunter Trace is no longer a location due to problems with illegal dumping.

Mr. Reed also reported that the Lancaster City Parks would like all trailers to be removed.

Commissioner Davis stated that the Commission will be helpful in finding locations for the trailers.

Commissioner Kiger stated that the new trailers look nice.

Mr. Reed stated that he is trying to phase out the old trailers and hopes to get all new trailers.

Mr. Reed stated that the applications are due by September 29<sup>th</sup>.





Hello Kyle and Lynette:

It is okay to file this file this report by email (for efficiency).

I have returned a copy to document receipt by this email.

The Board monitors fines with the budgeting process (and this report is part of that evaluation, although a minor part of the evaluation).

The Clerk of Courts records might be sufficient in this regard.

We understand the hierarchy of payments, where fines are paid following payment of court costs and restitution. This hierarchy of payments results in a relatively incidence of fines paid as they are assessed.

As for this specific report, the Ohio Revised Code requires it and provides for penalties.

(There are some processes which the ORC has allowed for alternate processes for efficiency, such as with the Budget Commission processes.)

Further, in certain circumstances, we see new legislation introduced for modernization.

If the Prosecutor's association were to pursue changes to the statute for efficiency relating to this reporting process, we would be interested in helping with that process.

In this particular report, I notice trends discussed in multiple venues and specific cases, as well.

I also note that 410 cases are included.

408 defendants are noted on the final page, but there appears to be duplicated names that would account for fewer defendants. I am not sure if that is important to you, or if your report is used for other purposes. Therefore, I am mentioning this observation.

For example, I am aware the County Auditor reflects an operating indicator of criminal cases within the statistical section of the CAFR. (I do not see other operating indicators for reporting purposes that might be connected to this report. I copied Jon on this email, as you copied your report, as well.)

The number of criminal cases (as an operating indicator) reported in the CAFR for 2016 was 2,416. That number is obviously not derivative of this particular report.

However, that same indicator in 2007, 2008, 2009, and 2010 seems similar to the figures of this report. Therefore, this report may have once been the source of that indicator.

The purposes of my email are to 1.) document receipt of the required report, 2.) offer support with modernization of the ORC if desired, and 3.) share observations from the report.

309.16 Annual report to board of county commissioners - transmission of information to state fire marshal.

(A) On the first Monday of September in each year, each prosecuting attorney shall make a certified statement to the board of county commissioners specifying:

(1) The number of criminal prosecutions pursued to final conviction and sentence under his official care, during the year next preceding the time of making such statement. In such statement the prosecuting attorney shall name the parties to each prosecution, the amount of fine assessed in each case, the number of recognizances forfeited, and the amount of money collected in each case.

(2) With respect to the offenses set forth in sections 2909.02 and 2909.03 of the Revised Code, such statement shall also include the following information:

(a) The number of fires occurring in the county for which the state fire marshal or an assistant state fire marshal has determined there was evidence sufficient to charge a person with aggravated arson or arson;

(b) The number of cases under sections 2909.02 and 2909.03 of the Revised Code presented by the prosecuting attorney to the grand jury for indictment;

(c) The number of indictments under such sections returned by the grand jury;

(d) The number of cases under such sections prosecuted either by indictment or by information by the prosecuting attorney;

(e) The number of cases under such sections resulting in final conviction and sentence and the number of cases resulting in acquittals;

(f) The number of cases under such sections dismissed or terminated without a final adjudication as to guilt or innocence.

(B) The prosecuting attorney shall also transmit to the state fire marshal on or before the first Monday of September in each year all information relative to the crimes under such sections required to be reported to the board of county commissioners pursuant to division (A)(2) of this section.

(C) For purposes of divisions (A)(2) and (B) of this section, sections 2909.02 and 2909.03 of the Revised Code include a conspiracy or attempt to commit, or complicity in the commission of, arson or aggravated arson under sections 2923.01 to 2923.03 of the Revised Code.

(D) If the prosecuting attorney fails to make reports at the time and in the manner required by this section, he shall forfeit and pay not less than one hundred nor more than five hundred dollars, to be recovered in a civil action in the name of the board.
