Commissioner Davis asked everyone to rise as able, and he led the Pledge of Allegiance.

Announcements

Commissioner Davis asked Ms. Elsea if there were any announcements. Ms. Elsea stated there were no announcements

Approval of the Commissioners' Office resolutions

On the motion of Dave Levacy and the second of Steve Davis, the Board of Commissioners voted to approve the Commissioners' Office resolution to approve the appointment of President of the Board of Commissioners; see resolution 2014-01.13.a.

Discussion: Mr. Kiger asked if this was the same individual from last year. Ms. Brown stated it was not, but the appointment was a recommendation from last year's apiary inspector. This individual will receive the same rate as last year.
