Public Viewing - Prime Avenue Culvert

The Commissioners met at 2:30 p.m. for a Public Viewing on Prime Avenue. Commissioner Davis called the meeting to order with the following Commissioners present: Steve Davis and Dave Levacy. Also present was Eric McCrady, Ronnie Lewis, and Chris Lortz.

Mr. McCrady reviewed the project.

Public Hearing on Eleven Viewings

The Commissioners met at 3:30 p.m. for a Public Hearing on the eleven viewings conducted earlier in the day. Commissioner Davis called the meeting to order with the following Commissioners present: Steve Davis and Dave Levacy. Also present was Eric McCrady, Rachel Elsea, Carri Brown, and Bob Myers.

Mr. McCrady reviewed the projects. The Wilson Road culvert is east of Wiley Road and is a corrugated metal pipe that needs replaced. Additional right of way may be required. The Coonpath Road culvert is east of Carroll Southern Road and is a corrugated metal pipe that needs replaced. Additional right of way may be required. They will need to widen the shoulders for this project as well. West Bowling Green Lane is a joint project with the Bloom Township Trustees. An easement will be required. This is also a corrugated metal pipe needing replaced. The BLO-35 bridge replacement project off Winchester Road may require additional right of way. The WAL-38 bridge replacement project is on South Bank Road near Brooks Park. The current structure is steel beam and the new structure has not yet been determined. The RIC-13 bridge on Gun Barrel Road is a truss bridge which will require additional right of way. Coonpath Road culvert 13.543 in a corrugated metal pipe between Richland Road and US 22. The culvert will be lengthened and shoulder will be widened. They may also need additional right of way. Lake Road culvert 6.830 south of Coonpath is also a corrugated metal pipe and may require additional right of way. The Lake Road culvert 5.669 is in the same condition and requires the same changes. The Coonpath guardrail at PLE-09 west of Darfus Road will be replaced. The ditch will be moved back due to the inadequate support structure. The culvert on Prime Avenue in Pleasant Township is a joint project with the Pleasant Township Trustees. This is not located within a drainage easement. Such easement will need to be acquired.

Mr. Robert Myers of 3427 South Bank Road in Millersport spoke regarding the WAL-38 bridge. He is concerned with the alignment. The current bridge is narrow and low. He also thinks the approaches need straightened out. Mr. Myers believes the wider and higher the new bridge is, the better. He would like it improved instead of just being replaced.

Mr. Davis asked that additional time be allotted for the viewings next year.

Mr. McCrady replied the Engineer's office would make sure to do that.
