Review

The Commissioners met at 9:03 a.m. to review legal issues and pending or future action items and correspondence. Commissioner Davis called the meeting to order with the following Commissioners present: Steve Davis, Jeff Fix, and Dave Levacy. Also present were Carri Brown, Rachel Elsea, Chief Lape, Jeff Porter, Joshua Horacek, Tom Lininger, Susan Nixon-Stoughton, and Jon Slater. Welcome

Commissioner Davis welcomed everyone to the meeting.

COVID-19 Update

Jon Kochis, EMA Director, and others provided an update on the COVID-19 responses.

Mr. Kochis reported that last week's numbers did escalate a bit. There is not a specific event associated with that escalation. The county is not in danger of going to the red level, but yellow is not in the future. Central Ohio ICU and hospital bed averages are about 140-150. There are issues for ICU use bringing the overall use up. There is no new information on PPE distribution for Central Ohio. Today, EMA will pick up supplies for the school districts and will start that distribution, all masks, tomorrow. Mr. Kochis urged everyone to continue with their protective measures, keeping distances, and mask wearing.

Mr. Levacy asked if the increase in numbers were expected due to the weather.

Mr. Kochis replied they would see increases and decreases and that the virus is consistently in the community.

Mr. Fix asked if there was any news on the timing of the vaccine campaign.

Mr. Kochis replied that the CDC has urged planning for distribution for long term care prior to November 1. He believes this is a good sign. He focuses on the indicators on preparedness.

Mr. Fix asked if there was an update on the schools.

Mr. Kochis replied he thinks today's PPE pick up will help keep numbers low.

Dr. Brown suggested she and Mr. Kochis connect later in the day regarding additional equipment purchases with CARES Act resources, such as for support of vaccine distribution.

The Halloween fact sheet from the state of Ohio was in the review packet.

We in Fairfield County continue to remind employees and members of the public about how important safeguarding measures (of wearing masks, maintaining distance, washing hands, and monitoring symptoms) are to our ability to stay well and maintain services.

We have stepped up sanitation efforts in high traffic building, such as the Hall of Justice.

Any department official can request extra sanitation efforts anytime by contacting Carri Brown, Jon Kochis, Dennis Keller, or Jeff Porter. They may also place a ticket into the maintenance system.

Ms. Fyffe reported there has not been a lot of change. They continue to work with schools and have seen a slight uptick in cases in schools. October 21st is the date for a flu

clinic for the community. They will have high dose and low dose vaccines. This will be a trial for the COVID vaccine campaign.

Mr. Fix asked if there was a specific school with an outbreak.

Ms. Fyffe replied that she needed to verify the numbers prior to saying which school was affected.

Legal Update

Mr. Horacek did not have a legal update. An executive session is planned for 9:30 a.m.

CARES Act Funds

HB 614 was signed, and Commissioner Fix attended the virtual signing along with CCAO representatives.

We have ordered COVID-19 compliant transport vehicles and cruisers for the Sheriff, and the vendor expects to deliver them by December 30, 2020. The DAS bid package does not require delivery by that date, and the vendor cannot guarantee it although they will strive for it. If we do not receive the vehicles by December 30, 2020, we will likely need to make an adjustment and use non-CARES Act related resources.

We are proceeding with the purchase, though, out of necessity.

We are in the process of adjusting as more information is known.

We are likely over-documented for public safety payroll support purposes, based on guidance from the US Treasury.

We have detailed documentation relating to definitions of substantially dedicated personnel and substantially different duties.

For public safety employees, the US Treasury has indicated no documentation is needed based on the presumption they are permitting.

The review packet contained a summary of the CARES Act sources and uses as of September 30, 2020.

The Commissioners reviewed the packet and indicated approval of the report and its content.

Mr. Davis provided an update on the conversations he had with Governor DeWine and Lt. Gov. Husted.

Mr. Levacy stated he thought the equipment to support FMC was a good thing.

Mr. Davis stated he had had good communications with Jack Janoso the last few days and would be meeting with Senator Portman and Jack Janoso on October 14th.

Mr. Davis stated it was difficult to imagine where the County would be without Dr. Brown's good work.

b. Highlights of Resolutions

Dr. Brown highlighted the approval of the agreement with Fairfield Medical Center to fund the Guardianship Services Board with \$44,000 annually, as discussed at the Commission meeting last week.

She also referred to the approval for the purchase of "COVID-19" vehicles, as discussed earlier.

In addition, there was a flier in the review packet to highlight the approved agreement for free legal clinic services to be provided by the Southeastern Ohio Legal Services through December 29 at Municipal Court to assist with issues surrounding eviction, taxation, or unemployment claims. SEOLS will also provide a CLE session for the local bar. Judge Fields has been supportive of this effort for pro bono legal services.

Thanks to Donna Stalter for preparing the SEOLS flier, which has been provided to all employees, the courts, 211, and JFS for referral purposes.

Budget Update

Budget hearings begin on October 13.

The Board of Elections had requested this first spot, and they have also been invited to attend the press conference on October 13.

Thanks to Magistrate Boone for recording a training session with GoToMeeting for law enforcement. The collaboration with the Courts and the Sheriff's Office is very helpful to the residents of Fairfield County. (If anyone would like to try the recording of GoToMeeting for a training tool, Magistrate Boone, Rachel Elsea, and others are available to help.)

This past week, CCAO referred our website (specifically, the agenda, minutes, and FAQs) for an interested party in Darke County who was seeking a good example of agenda, minutes, and FAQs. There was terrific feedback about the through and well-done website materials. Our meetings continue to have GoToMeeting invitations posted for the public and others to use.

We now have at least 21 people interested in registering for the NACO High Performance Leadership Academy in 2021. At least 21 in 21! We will purchase the registrations centrally at a discount, and each person will have several options to choose from as far as the dates to select for the courses.

There was a nice article in the Eagle Gazette about the Patriotic Mural @ Amstutz. Thanks for that! People continue to make positive comments about this.

Coming soon, you will be seeing some amazing videos to promote foster parenting for teens. Aunie Cordle coined the phrase "foster the future"- and that phrase is catching on with the education and outreach effort on a statewide basis. You will also be seeing Fairfield County families being featured at the state level. We continue to connect with Kristi Burre in her role leading the state's transformational efforts. Ms. Burre can always count on Fairfield County to be exceptional partners. Also, we may soon hear more about a visit from federal officials who are interested in the special projects at Protective Services. Congratulations to Aunie Cordle, JFS Director, and Heather O'Keefe, Deputy Director of Protective Services, for their collaborations. At the end of the month, we will present a proclamation to honor adoption, will view the "foster the future" videos, and present some ideas for the next educational mural promoting the "foster the future" effort.

JFS recently hosted a combined flu shot event (with FMC) and a United Way event, raising more than \$1,700 for United Way. FYI - Employees are now able to sign up for payroll deduction for United Way contributions.

Congratulations to the many employees who have completed the required county training: ethics, unlawful harassment, and cyber security.

We appreciate the collective leadership in adjusting the employee share for insurance (November and December waivers) and restoring merit-based increases for those who follow the compensation schedule and conduct performance assessments.
