#### b. Highlights of Resolutions

Ms. Brown provided highlights of resolutions for the voting session.

The County Engineer proposed approval and commencement of a contract with KMX to paint a Rushcreek Bridge.

The Airport proposed disposal of obsolete vending machines through govdeal.com.

The Commissioners (through Community Action) proposed the release of two mortgage liens in accordance with grant terms and conditions.

There were financial resolutions proposed, such as:

- The resolution for the creation of a new fund to account for the MCO transition (as previously discussed although the County Auditor changed its draft classification from special revenue fund to an agency fund, which means appropriations are not needed for the transfer of funds):
- Fourth quarter allocations for JFS, MCJDC, and MSY;
- Account to account transfers of appropriations to properly classify expenditures for the Human Resources department, Commissioners, and Common Pleas Court;
- Appropriations from unappropriated funds for the Sheriff (two resolutions), Engineer, and FCFACF Council (two resolutions), the County Auditor, (non-general fund activity);
- The payment of bills (including the UHC payment for the health benefit plan & approval and payment of then and now certifications or substitute then and now certifications, as needed).

In the future, we will see two agreements relating to Violet Township and the Village of Lithopolis and the comprehensive, continuing, and cooperative

transportation planning process, connected with MORPC (acting as the Metropolitan Planning Organization).

These agreements are continuation of existing arrangements and update the MORPC files. (Thanks to Loudan Klein for researching these agreements.)

### c. Administrative Approvals & Budget Update

Ms. Brown stated the review packet contained a list of administrative approvals for the week and asked if there were any comments or questions. There were none.

Departmental budget hearing dates have been scheduled. The schedule was in the review packet.

Ms. Brown also reviewed the 3<sup>rd</sup> quarter budget update which included an update on public records requests, general fund revenues, items to watch, sales tax rate, expenditures, and a review of appropriations changes.

#### d. Bravos

Thank you to the Visitors and Convention Bureau for the updated website for the promotion of Buckeye Lake.

Thank you to everyone who has completed cyber security training. Phishing occurrences are down from 28% to 8%.

### Old Business

#### a. Buckeye Lake State Park Dam Drainage Issues

We now have a summary of a collaborative approach addressing drainage solutions and protection of public health, safety, and welfare for landowners, residents, and visitors of the Buckeye Lake West Bank area. The collaborative approach includes the Ohio Department of Natural Resources (ODNR) and the Fairfield County Commissioners, Engineer, and Soil and Water Conservation District.

All entities have worked hard to identify and engineer drainage solutions relating to the Buckeye Lake West Bank pumps (including Ballard Lane, Parrish Farms, and the West Bank Homeowners' Association).

After analysis and evaluation, ODNR has agreed to:

- A limited time delay in disconnection of the three pumps noted above, if continuous engineering progress is being made toward implementation of a solution that coincides with the dam construction schedule.
- Make temporary accommodations at the discharge points of the three pumps, allowing dam construction to remain on schedule.
- Schedule regular briefings between Fairfield County entities and ODNR while we work toward a schedule of implementation of drainage north to Lateral A Ditch or south to the Feeder Canal.

We appreciate this positive approach and look forward to additional collaboration.

A letter was sent to appropriate stakeholders: former ditch petition signers & interested parties, Mr. Parrish, and the West Bank Homeowners' Association. (This letter was in the review packet.)

Mr. Levacy reviewed how the flooding of that area effects the road and property owners. He met with ODNR, TransCanada (formerly Columbia Gas), and the

engineer a few weeks ago. TransCanada is now in agreement to allow discharge into the feeder canal, he believes. They have specifications as to how close the discharge pipe can be to the gas line. Mr. Levacy appreciates their willingness to be helpful and cooperation.

### b. Protective Services Levy

Mr. Levacy asked how the education and outreach for the protective services levy was progressing. Ms. Cordle reported they are working to spread the word regarding the levy in November. The committee members are willing to share information with any groups that will have them. For some, there was confusion as to where money goes. It is only allowed to go towards abused and neglected children and elderly. So far, they have received positive feedback.

### New Business

## a. Escape to Buckeye Lake website

Jonette Haber field provided an update of the Visitors and Convention Bureau activities, including a web page to promote Buckeye Lake. This was a collaboration between Licking, Perry, and Fairfield Counties. They met with the Buckeye Lake 2030 group to make sure the page aligned with their goals. The promotion is a result of the Perry County related grant for services. Jeff Porter is the Commissioners' appointee to the VCB, and he has supported the marketing materials for the community. # b. MUNIS related group & travel planned

Members of HR, Commissioners, the County Auditor, and other departments will be obtaining training in Maine to improve MUNIS, especially relating to HR and Payroll functions. There have been no updates to MUNIS for a decade relating to payroll. This training is the beginning of a super MUNIS users' group which will serve as subject matter experts to further county objectives. (All employees travelling have received instruction about county policy on travel reimbursements, as well, especially given out of state travel is rare. There are no other options for

the travel because of how Tyler Technology, the company in charge of MUNIS, operates.)

Due to the integrated approach that will be a part of the MUNIS analytical review, core functional subject matter experts need to be involved in the training and every aspect of the analysis. The work product of the analysis will be recommendations for improvement, because of the MUNIS assessment and review.

Mr. Slater stated that those attending the conference will be able to speak with developers face to face to address any issues.

Mr. Porter stated that an onsite assessment will begin Wednesday. The county will receive feedback from Tyler for improvements to utilize MUNIS to its full potential.

We are aware of the City's plan to light Mount Pleasant for a limited time during the fair. Ms. Brown indicated she believed this was an excellent idea to demonstrate how lighting would bring more awareness to the beauty of Mt. Pleasant.
