Welcome

Commissioner Fix opened the meeting by welcoming everyone in attendance and presenting a proclamation for Accounting Appreciation Month.

Listen and Learn - Developmental Disabilities

Mr. Pekar provided a PowerPoint presentation (contained in the minutes) and spoke about the mission of DD and how Ohio established local boards of DD with taxing authority. He added that the three key components of DD are the vibrant DD community, and the importance of members leading fulfilling lives and making meaningful contributions. Mr. Pekar spoke about the vision of DD and the independence, respect, resiliency, and sustainability of the Board of DD and all individuals involved.

Mr. Pekar continued by speaking on funding, Fairfield County DD locations, and the inception of Art and Clay. He also spoke about program enrollment, and the importance of early intervention. Mr. Pekar continued by speaking on the Forest Rose School and the philosophy of integration in classrooms.

Service Coordination, including housing, healthcare, employment, assistive technology, and the person-centered plan were all touched on by Mr. Pekar. He also spoke on outreach and partnership programs and concluded his presentation by speaking about the Staff of DD, which currently encompasses 153 full-time staff.

Commissioner Davis provided accolades to Mr. Pekar for his accomplishments.

Commissioner Levacy spoke about his appreciation for the meaningful accomplishments of Mr. Pekar and his staff.

Mr. Pekar thanked Rick Szabrak for Economic Development the Workforce Center's' support for DD work programs.

Commissioner Fix spoke about relational experiences with developmental disabilities and the great accomplishments of some of those individuals and their families.

Mr. Pekar stated how much he has appreciated the cooperation of the current Board of Commissioners with the Board of Developmental Disabilities.
