Grant Meeting with Townships, Villages, and Cities

Mr. Szabrak provided an update on the meeting. Around 16 people (representing 10-11 municipalities) attended. Hicks will meet with each interested municipality to see what resources they can provide.

Main Uses of the ARP Fiscal Recovery Funds

We discussed how there are two main uses of ARP fiscal recovery funds for us:

- 1. Responding to the public health emergency with respect to the COVID19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
- 2. Making necessary investments in water, sewer, or broadband infrastructure.

As we think about the first purpose, we will need to:

- Identify a need or negative impact of the public health emergency,
- Identify how the county investment would specifically address that need, and
- Readily explain how the investment helps the county respond to the disease or the harmful economic consequences of the economic disruption.

With the ARP fiscal recovery funds, \$1.4 M has been spent; \$4 M is encumbered, and \$7.9 M has been authorized for use.

For the voting agenda, there will be a resolution to approve an authorized use and appropriate from unappropriated funds for the County ARP fiscal recovery fund, #2876, for a broadband infrastructure purpose, pledging support to broadband providers participating in the State of Ohio

Residential Broadband Expansion Program and benefitting Fairfield County residents when certain criteria are met.

There is an administrative meeting to review the subgrant agreement with Walnut Township, now in draft form. The review packet contained a draft.

There are multiple projects under review. We continue to connect partners and stakeholders to research affordable housing and various factors connected to antecedents of those in unsheltered situations.

Planning sessions with RAMA and the planning team are scheduled for November and December.

We are still on target for a draft report from RAMA by the year end.

COVID 19 Update

Mr. Ebel reported they have seen a decline in COVID cases with cases leveling out to roughly 38 cases a day. Hospitalizations are down. There were 12 deaths reported so far for October. Those numbers run a few weeks behind and will probably increase.

They hope to start vaccinating the younger age group starting next week. It will be two doses and will take roughly 5 weeks to be fully vaccinated. About 45% of eligible students are vaccinated. They plan to see similar numbers in the younger age group as well. The schools just finished up their first week of the new masking policy "Mask to Stay, Mask to Play." Mr. Ebel encouraged those who have not had the flu shot to get one.

Mr. Kochis added that the workplace guidance is still the same and that will be emailed out today.

Simplifile

The Fairfield County Auditor's Office is excited to announce the availability of new technology for the public. With e-recordings, or Simplifile, there is now an additional ability to submit, receive, and process documents for recording through the Internet.

Traditionally, documents are sent to the office for recording by a runner, express mail, or courier service. This new electronic option will help businesses save money by reducing the amount of time they spend recording documents and by reducing costs of postage and supplies.

A press release was in the review packet.

Dr. Brown reported there were already 10 recordings filed using this method.

ADAMH Board Position

We continue to accept applicants for the ADAMH Board position. ADAMH has a desire for financial and/or legal experience. Interviews will not be scheduled until November.

Solar Farm Discussion

An administrative meeting was held with members of Soil and Water Conservation District, Economic Development, Regional Planning, Auditor's Office, and the Prosecutor's office to discuss Solar Farm considerations. The group will learn more and reconvene in the 1st quarter of 2022.

SWCD is not necessarily opposed to the project but wants to be engaged in the process and involved in conversations as they have concerns about drainage, pipelines, topsoil protection, and road erosion.

RPC will invite Geenex to an RPC meeting.

We will continue to hold work group meetings. Currently, there are no recommendations except to continue to gather information.

During the meeting, several documents and bulletins were shared.

October Idea Box Update

Two additional ideas were received and addressed.

Idea 71: An employee wondered about the possibility of putting up some blinds or curtains on the flex room windows (the windows in the exercise room). The employee thought this would make things a little more comfortable.

Response: We checked out putting some blinds or curtains in that area making sure that Facilities is okay with the approach, given the windows are aluminum. Ultimately, the windows need to be exposed for safety advantages.

Idea 72: Generally, an employee suggested a reminder for department heads and supervisors to communicate about changes in procedures or policies. The employee suggested email communication whenever there was a departmental procedure change.

Response: In response to the idea box submission, we reminded department heads and supervisors about the importance of communication in general. Some will communicate often with multiple methods; some might use email.

We also encourage employees to share ideas in a kind, open way with supervisors for practical reasons. We encourage open communication to build trust.

Being able to communicate effectively is one of the most important life skills to learn. We in Fairfield County have some great training tools to help with that, too. HR can provide more information about Service Skills and the High-Performance Leadership Academy.
