Welcome

Commissioner Fix opened the meeting by welcoming everyone in attendance and briefly talked about the county having a successful year that was quickly ending.

Airport Board Appointment Interview

Tom Brennan spoke about his wish to contribute additionally to the county. Mr. Brennan spoke about his career path and how it involves aviation and life science businesses he has started. He also spoke about his pilot license and where that has led him.

Commissioner Fix asked about Mr. Brennan's knowledge of the Fairfield County Airport.

Mr. Brennan stated that our location in reference to Columbus is an asset and that the ability to lease hangars and sell fuel are an asset to Fairfield County.

Commissioner Davis welcomed Mr. Brennan and thanked him for his interest to serve on the Board.

Jon Kochis, EMA and Facilities Director, and Rick Szabrak, Economic and Workforce Development Director, both spoke about the functions and importance of the Airport Board.

Commissioner Davis asked to have the Board of Commissioners vote on the appointment of Mr. Brennan.

Regular Meeting #54 - 2022 - December 13, 2022

Presentation - Building Imaging

Mr. Jon Kochis presented on the geospatial modeling of the courthouse, along with Garrett Blevins. They provided that the project provides mapping of the rooms in 3-D with accurate measurements and spacing and allows for mapping the building in a way that allows them to maintain and preserve it more efficiently. Every item on the map marked with a dot has been identified as a critical structure and the project allows them to upload the map to the county website and give the public access to the building without being physically present. Accurate measurements up to a 16th of an inch can be taken, and the Facilities Department will have the ability to print a 2-D fire map. The program also has the capability to be compatible with virtual reality headsets. Mr. Kochis also stated that the project was completed by a company in the local community.

Information Technology Director, Dan Neeley, stated the Schneider Geospatial team identified wireless access points in the building which will help with coverage needs. He added that they also included items like fire extinguishers and that keeping track of that type of information will prove quite useful. Mr. Neeley stated that changes can be easily added to the existing environment.

Commissioner Fix asked if the plan was to do this for all county buildings.

Mr. Kochis stated they would like to because it has been proven very effective.

Facilities Director, Dennis Keller, stated this would be very helpful for buildings without an accessible current floor plan.

Commissioner Fix asked the presenters to identify the most helpful aspect of the information.

Mr. Kochis stated it would be most useful in inventorying items.

Mr. Neeley stated he thought it would be helpful for training new staff to familiarize themselves with county facilities.

Mr. Kochis added that pictures can be blurred for privacy purposes.

Commissioner Davis asked if there are external views of the Administrative Courthouse.

Mr. Kochis stated there will eventually be an outside view of the building taken via drone and that the map will be made available once final updates are complete.

Public Comments

Ray Stemen of Lancaster spoke about the debates in this country around gun ownership and provided a prayer for all those making leadership decisions.

Judy Stemen of Lancaster provided a handout that is available in these minutes and read highlights from the handout.

Steve Feeney of Lancaster spoke about his opposition to utility solar plants in Fairfield County and spoke about public awareness of solar energy. Mr. Feeney stated that the earth has an essential need for carbon dioxide and wished everyone a blessed Christmas.

Stephanie Taylor spoke about Habitat for Humanity's partnerships with career centers in Fairfield and surrounding counties and the six homes that were built, two of which were in Fairfield County. She also spoke about community projects and upgrades, including project playhouse events. She added that playhouses went to organizations such as the Lighthouse and closed by stating she is excited about the impact Habitat for Humanity will have in 2023.

Jail Population

• Ms. Cordle stated that the jail population for December 6, 2022, was 267 with 32 of those being contracted placements, and for December 13, 2022, was 249 with 16 of those being contracted placements. The Sheriff reports that this is typical of the drop that is seen nearing the holiday season. The Sheriff also shared that Gallia County is nearing completion of their new jail and their contract for housing prisoners will not be continued. Gallia County has averaged 10-13 contracted placements. The Sheriff is evaluating contracts with other counties that would allow for additional contracted placements.

Old Business

Commissioner Davis stated he and Administrator Cordle met with ODOT on transportation concerns and he believes the county is a few months away from receiving grant funding to address some of these concerns. He added that in that conversation he requested to conduct a study that would involve transferring Lancaster Fairfield Public Transit from the City of Lancaster to Fairfield County. He stated he also had a conversation with Mayor Scheffler regarding the transportation study.

Commissioner Levacy stated he attended the 33 Alliance meeting the previous week at Blue Label Packaging and was very impressed by the facility and its capabilities.
