“We have a renovated barn (The Tabernacle) that we use for public gatherings so that is an ideal place to meet. We thought the team would consider using the Tabernacle for one of their regular business meetings, after which they could walk around the property a bit,” stated David Hague, owner.

“Coyote Run has dedicated a portion of their property as the 140<sup>th</sup> State Nature Preserve. It was a terrific opportunity to celebrate that dedication and to hold a business meeting at their location, following up on a presentation Mr. Hague gave to the Commission previously,” added Carri Brown, County Administrator.
