I have served as co-counsel in at least 2 jury trials within the past 6 years.

**1st and 2nd Degree Felonies**

I have obtained at least 12 hours of CLE in criminal practice/procedure within the past 2 years;  
AND

I have at least 3 years' experience in criminal law; AND

Within the past 10 years, I have served as lead counsel in 2 criminal jury trials, at least 1 of them  
involving felony charges; OR

Within the past 10 years, I have served as lead counsel in 1 felony jury trial and as co-counsel in  
at least 2 additional jury trials.

**Life-Sentence Cases**

- I have obtained at least 12 hours of CLE in criminal practice/procedure within the past 2 years; AND
- I have at least 5 years experience in criminal law; AND
- Within the past 10 years, I have served as lead counsel in 5 felony jury trials, at least 3 of which involved felony charges of the 1st or 2nd degree; OR
- Within the past 10 years, I have served as lead counsel in 3 jury trials, at least 1 of which was a 3rd degree felony AND as co-counsel in 5 additional jury trials, at least 3 of which were 1st or 2nd degree felonies.
