Fairfield County Auditor's Office Completes National Association of Counties High Performance Leadership Academy

Lancaster, Ohio – Fairfield County Auditor Carri Brown is pleased to announce the completion of the National Association of Counties (NACO) High Performance Leadership Academy by 100% of Auditor's Office 31 employees. The office is the first in the country to have 100% of employees graduate from the program.

The High-Performance Leadership Academy is a 12-week course focused on equipping government officials at every level of service with practical leadership skills. General Colin Powell was a leader in creating the curriculum for the program. Weekly topics focused on leadership mindset and positive engagement; leading effective change; communication and collaboration; and leading high-performance teams.

Dr. Carri Brown, one of the first in Fairfield County to complete the program in 2019, stated, "Leadership is found at all levels of an organization. We are appreciative of how the Fairfield County Commissioners have supported this learning opportunity. The foundation of leadership skills creates a culture that encourages innovation, expression, organization, and accountability to benefit the public."

Luke Afeman, Senior Director of Enrollment for the Academy, added, "Fairfield County, Ohio, has been a consistent leader in completing the 12-week course, and it is encouraging to see how the County Auditor's Office has supported all of its employees in developing leadership skills."
