- B. Whereas, the Port Authority has the authority to issue bonds under Section 4582.31 (7) of the Ohio Revised Code; and
- C. Whereas, the Basil Western Road Realignment Project promotes economic development activity by expanding transportation capacities along portions of Basil Western Road.
- D. Whereas, additional funding may be needed to complete the Basil Western Road Realignment Project; and
- E. Whereas, the Fairfield County Port Authority intends to issue bonds for unfunded portions of the Basil Western Road Realignment project and that all bonds will be fully backed by the Fairfield County Commissioners.
