The county will be using the theme of Fairfield Forward for strategic planning. There are two main uses that stand out for Fairfield County's fiscal recovery:

1. Responding to the public health emergency with respect to the COVID19 or its negative economic impacts, including assistance to households, small businesses, and nonprofits, or aid to impacted industries such as tourism, travel, and hospitality.
2. Making necessary investments in water, sewer, or broadband infrastructure.

As we think about the first purpose, we are required to:

- Identify a need or negative impact of the public health emergency,
- Identify how the county investment would specifically address that need, and
- Readily explain how the investment helps the county respond to the disease or the harmful economic consequences of the economic disruption.

**Project Description** – This project is to support leasing additional space (and related adaptations) for the Board of Health. It is a type of COVID-19 response, mitigation, and prevention activity: The Health Commissioner certified the new space (and adapting and implementing the new space) with a lease amendment was a type of COVID-19 response, mitigation, and prevention activity. A broad range of services are needed to contain COVID-19, including the conduct of vaccination programs; medical care; testing; contact tracing; support for isolation or quarantine; supports for vulnerable populations to access medical or public health services; public health surveillance (e.g., monitoring case trends, genomic sequencing for variants); enforcement of public health orders; public communication efforts; enhancement of public health data systems; and other public health responses which directly or indirectly support the fight against COVID-19. For example, vaccinations for other diseases will help keep the public healthy and promote stronger immunity systems to fight the disease. The Health Department needed to move the vaccination clinic from the fairgrounds and mall to the Health Department offices. The additional space is being used in part for the clinic and in part for activities that are connected to public health which were displaced due to the need of the space for the clinic. The space changes were needed because of the move of the clinic. Also, adaptations (such as

wiring, flooring, and furniture, fixtures, and equipment) for the leased public space are included for COVID-19 mitigation tactics.

room equipment and *key technology* and software purchases for multiple public departments to allow for improved response, public safety, safeguarding, electronic filing, searching, communications and essential services. The category also includes building improvements and the purchase of general assets for facilities (such as a tent) and minor improvements for facilities to allow for safeguarding measures, such as distancing or the provision of services in outdoor spaces.

**Project Name** – Public Health, Capital Investment for Air Quality Improvements

**Project Identification Number** – R17c

**Expenditure Category** – 1.7

**Project Description** – This project addresses the need to improve air disinfection in public buildings, specifically in the buildings of Utilities and Developmental Disabilities, which have not yet received air disinfection equipment (as other buildings received from the CARES Act purchases) and have a need to improve air quality. Improvements in air quality management have been shown to be helpful in the measures to combat the spread of COVID19 and other diseases that are caused by airborne viruses; the county issued a request for proposals to survey the current market for appropriate methods, and records of the request for proposal are filed with the Facilities Management Department; the investment for the winning proposal was \$56,674, with such investment addresses the specific need as the county will be more prepared to improve air quality with the equipment; the investment helps the county respond to the disease by allowing for improved safeguarding measures.

**Project Name** – Public Health, Capital Investment for Health Equipment, a Mobile Morgue

**Project Identification Number** – R17d

**Project Description** – The American Rescue Plan fiscal recovery funds are permitted to be used to respond to the public health emergency with respect to COVID19; one lesson from the pandemic was how there is an impact to the health system when there is an increased number of decedents; in 2020, EMA documented two reported instances where morgue capacity in the county was critically low; funeral home services were often backlogged and not able to take any decedents to alleviate room in the morgues, and funeral homes have indicated they would not be able to decedents in the future; the need for a mobile morgue exists as a direct result of the public health emergency; county EMA will research available mobile morgue units and evaluate costs from quotes obtained; such investment addresses the specific need as the county will have a mobile morgue and will be more prepared to address a potential increase in the number of decedents; the investment helps the county respond to the disease by allowing for improved response measures.

The new supervisor position and vehicle will be directly focused on advancing community policing and law enforcement strategies in the northwestern portion of the county, where an increase in gun violence has been experienced.

Beginning February 2020, and running through August 2021, in-shelter client numbers dropped dramatically. The number of clients per month dropped to just under four from 17. Since September 2021, the Fairfield County Lighthouse has experienced an increase of 75.6% in its caseload, consistent with trends reported throughout Ohio. This year, the Lighthouse lost \$44,500 based on reduced contributions to the United Way. organization, they rely on charitable giving and fundraising events in the community. In 2020 and 2021, FAIRHOPE could not host their annual fundraising events due to the pandemic. With the cancellation of these events, they experienced decreased fundraising dollars. From 2020 through 2022 they averaged \$21,851 in charitable funding compared to \$76,415 in 2019 and 2023. The combined decrease in fundraising totaled \$163,692 for the three-year period. Despite these challenges, FAIRHOPE has remained steadfast in their commitment to employees, patients, and community. No patient has ever been turned away from services for their inability to pay. FAIRHOPE employees showed dedication to their mission throughout the pandemic, even in the face of uncertainty. To this day, increased wages and inflation continue to threaten non-profit organizations.

events is lower than pre-pandemic as the public has been slow to return to in-person events. The cost of hiring artists has also increased dramatically during this period. All these factors have left the Lancaster Festival with an economic loss of \$239,000 for the 2024 season. ARP funds have the potential to significantly benefit the Lancaster Festival as they strive to recover from the pandemic's far-reaching consequences.

In a study from the US Department of Agriculture in May of 2021, there was evidence that there were economic disruptions for agri-food products, with meat products and seafood being most severely impacted by the pandemic (Arita, Grant, Sydow, & Beckman, May 2021). Arita, et al. (May 2021) concluded there was a high degree of uncertainty in the

agricultural industry based on the impact of the pandemic; reporting in the media shows uncertainty and disruptions in the agricultural industry; the Fairfield County agricultural industry faces challenges in identifying long-term needs and in examining how their businesses will emerge from the coronavirus pandemic. *Fairfield Growing*, is a local food council spearheaded by the Regional Planning Commission; the community would benefit from a long-term *Fairfield Growing* plan establishing strategies to support growers coming out of the pandemic and supporting the overall agricultural economy; professional consulting services will provide researched recommendations for improvements and stabilization as the industry comes out of the pandemic; the project addresses harm by identifying research, needs for improvements, and support for grant opportunities, which in turn supports the overall economy.

A county investment in providing legal and related services would help the county respond to the

harmful economic consequences of the economic disruption by supporting residents who are evicted, on the brink of eviction, in need of unemployment, or in need of help with filing taxes or addressing a legal matter that has arisen during the pandemic. These uses are part of the public health response because the legal services are imperative to fiscal recovery for residents; A main part of this project is for the purchase of services to include pro bono legal services for those facing eviction or dealing with potential eviction of tenants; services to help navigate unemployment claims or appeals; services relating to filing federal, state, or local taxes; and any legal matter to be of support as response to the pandemic. Another example is for supplies and storage

services (and a vehicle with safeguarding measures) to support wards of the Probate Court who are facing eviction or are unsheltered based on effects of the pandemic and mental health concerns. Related services might be included as identified.

There will be a contract for services to support the Housing Coalition in the strategic planning process.

into the current recorder management system and improves the ability for document searchers to conduct effective searches.

During the Covid pandemic access to paper records in our office was limited, as the Recorder's office was deemed essential. Due to the lack of imaged documents to continue to stay safe and operational, appointments had to be made to search for real estate records in our records room. This in-turn slowed the process of providing timely information to title companies and lenders for real estate closings. It also added to the at-risk factor of catching the virus through contact. Should we have the type of situation we encountered with Covid in 2019 & 2020 it would further delay timely processing of crucial documents title companies and lenders need to advance their businesses as well as subject our staff to potential virus exposure.

This need arises from the public health emergency because there is desire to socially distance and safeguard the public and employees during the pandemic and to plan for periods of time with there may be resurgences.

The COVID-19 pandemic has highlighted and emphasized the important role technology plays in ensuring an accessible, efficient, and effective justice system. While some other departments and business models have the option of temporarily suspending operations during a pandemic or other emergency, the court system does not. Individuals remain in jail on charges of which they have not been convicted. Others are in dire need of protection from abusers in the form of court-issued protection orders. Probationers with substance abuse issues rely on the accountability and structure of community control supervision. Citizens need the ability to petition the court for emergency child custody actions and stays of foreclosure and eviction actions. The doors of the Court and Clerk's Office must remain open—if not literally, then figuratively. In addition, there are some populations who remain compromised during the public health emergency and need to practice social distancing on an ongoing basis. Electronic processes provide practical, safe access to the court services.

### **The COVID-19 Pandemic identified the need to implement a case management system to include e-filing for the public to remedy the following deficiencies:**

The public can currently search cases online, but a true e-filing system is not in place. During the pandemic, we made allowances to accept filings via email and fax, which was not ideal, but was a quick remedy to cater to the needs of our customers by being able to electronically receive pleadings without having people come into the office. Had the technology solution been identified in 2020, the project could have been evaluated for the use of CARES Act funds. But because there was a need to examine alternatives and evaluate them, there was not enough time to use the CARES Act resources. Given the need to socially distance and work remotely, the American Rescue Plan Act fiscal recovery funds are proposed to support the project.

### **The County investment in an upgraded case management system would specifically address the deficiencies of the current case management software by:**

Increasing access to justice for attorneys and pro-se litigants to have e-filing capabilities. It removes barriers such as transportation, especially here in Fairfield County, where many litigants live in rural areas without the benefit of public transit. For individuals suffering financial fall-out from COVID-19, it also eliminates the need for gas money and/or other costs associated with transportation and in-person filing. It will further assist out-of-town attorneys in reducing drive time and, in turn, will reduce the expenses passed on to their clients. Perhaps most importantly, though, it will reduce foot traffic in the Court and Clerk's Office—protecting our staff and the health of immuno-compromised attorneys and litigants alike.

Moreover, an easily accessible web-based portal will allow staff to easily work-from-home when health, childcare, or other environmental concerns pose a barrier to working in the office. As articulated above, it is imperative for Court and Clerk's Office operations to seamlessly proceed no matter the circumstance, while ensuring that our staff, including our probation officers and Judges, have full access to (and the ability to sign, approve, and file) court orders, which will promote the timely resolution of pending cases and the effective administration of justice.

In addition to protect constitutional, statutory, and basic human rights, the Court and Clerk's Office must also protect its most valuable asset: its employees. COVID-19 has undoubtedly challenged the balancing of the two. It has also shown that the key to balancing those interests lies in technological improvements, such as upgrading our case management system to allow for e-filing, e-signatures, an easy-to-navigate web-based portal, and a cloud-based server. COVID-19 has prompted the Courts and Clerk's Office to prioritize upgrading its current case management system because of these needs.

**This investment helps the county respond to the disease or the harmful economic consequences of the economic disruption by:**

Because of the public health emergency there is a need to update court case management to allow for electronic filing and evidence-based case management activities to be facilitated in remote environments. Such electronic filings and remote case management activities allow for social distancing and a continuity of services if there is a resurgence of the COVID-19 disease and allow for effective service delivery for all populations, including those that continue to have compromised immunity systems or other health concerns that prevent them from in-person contact. Electronic processes are practical responses as opposed to slowing the essential services (by allowing only appointments) or building larger spaces for more social distancing. The county recognizes the immediate need to be more prepared for ongoing and future public health emergencies.

It is for these reasons that the Court and Clerk's Office seek to upgrade its current case management system. These upgrades are necessary in light of the three tenets COVID-19 has prompted us by providing interrupted access to justice, protect the health and safety of our staff and litigants, and disaster preparedness.

On September 10, 2020, Chief Justice Maureen O'Connor established the *Improving Court Operations Using Remote Technology Task Force* (iCourt) to study how courts have used technology during the coronavirus pandemic and to make recommendations to allow for the continuing use of technology in the future to improve access to justice and modernize court operations (See Addendum). The iCourt Task Force was tasked with identifying court rules that may need to be updated and modernized. One recommendation of the iCourt Task Force is to modify the Ohio Rules of Civil Procedure to require Courts to provide for the filing of documents by electronic means. Upgrading to Courtview 3.0 will greatly improve Fairfield County's ability to meet this need. A copy of the Memorandum from the iCourt Task Force to the Commission of Rules of Practice & Procedure in Ohio Courts dated April 20, 2021, is attached hereto.

Lastly, transitioning our case management system to a cloud-based server (rather than a county-hosted server) will further the county's disaster preparedness. The cloud-based server has multiple layers of protection and security that our current county-based server does not. Therefore, in the event of a catastrophe, the server—and all the court's records—will be protected.
