RE: 2021 appropriations for compensation of elected officials

Dear Dr. Brown:

At your request, this office has reviewed the statutorily required compensation for elected officials, and hereby advises that the following sums should be appropriated for the compensation of elected officials for the 2021 calendar year. Senate Bill 296 became effective on December 27, 2018, which affects compensation of elected officials. However, SB 296 is not applicable to an elected official until that official completes the term they were in when the bill took effect. Because of the timing of SB 296, the compensation of the Clerk of Courts, two County Commissioners, the County Coroner, the County Engineer, the County Prosecuting Attorney, and the County Sheriff needs to be prorated based on when the start date of each term occurs in 2021. I have attached additional information on this proration as Appendix A.
