RE: 2022 appropriations for compensation of elected officials

Dear Dr. Brown:

This office has reviewed the statutorily required compensation for elected officials, and hereby advises that the following sums should be appropriated for the compensation of elected officials for the 2022 calendar year. This letter is based upon a total county population of 158,921 as indicated in the 2020 federal census delivered to the State of Ohio on August 12, 2021. This letter modifies and supersedes the opinion letter issued on this subject on April 28, 2021 (though the only difference is the sum to be paid to the members of the Board of Elections). This letter does not account for certain sums that may be paid directly to elected officials by the State of Ohio. At this time, all elected officials receive the benefit of SB 296, and therefore, the County should appropriate the following sums for the respective elected officials:
