RE: 2023 appropriations for compensation of elected officials

Dear Ms. Cordle:

At your request, this office has reviewed the statutorily required compensation for elected officials, and hereby advises that the following sums should be appropriated for the compensation of elected officials for the 2023 calendar year. This letter does not account for certain sums paid to elected officials by the State of Ohio. At this time, all elected officials receive the benefit of SB 296, and therefore, the County should appropriate the following sums for the respective elected officials:

County Recorder	\$73,282
County Sheriff	\$110,121 ⁴

1 The County Auditor is also entitled to an additional \$3,000, which is paid from the undivided estate tax fund or from the county real estate assessment fund pursuant to R.C. 5731.41.

2 The Fairfield County Engineer does not engage in a private practice.

3 The Fairfield County Prosecuting Attorney does not engage in a private practice.

4 This sum presumes an appropriation is made by the General Assembly pursuant to R.C. 325.06(B), in which case, the County will be reimbursed \$12,236 by the State.



⁵ The 2020 federal census established the population of Fairfield County as 158,921, thus the salary is calculated as $(111.69 \times 100) + (53.21 \times 58) = 14255.18$
