# **Fairfield County Records Commission**

#### October 4, 2022

#### **Review**

The Records Commission met at 8:00 a.m. in the Commissioners' Hearing Room located at 210 E. Main Street in Lancaster, OH to review material related to records retention and disposition. Commissioner Jeff Fix called the meeting to order with the following members present: Amy Brown-Thompson, Lisa McKenzie, Rachel Elsea and Bennett Niceswanger. Also in attendance were Dan Neeley and Steven Darnell.

#### Welcome

Commissioner Fix welcomed everyone to the meeting of the Records Commission.

#### Roll Call

Commissioner Fix asked Records Commission Secretary, Bennett Niceswanger, to take roll call.

Bennett Niceswanger took roll call of the voting members and/or their designees. Clerk of Courts, Branden Meyer, was not in attendance.

#### **Old Business**

Bennett Niceswanger stated that he had received the approved RC-1 for the ADAMH Board by the Ohio History Connection. ADAMH was informed of the approval and was provided a copy.

#### Review of RC-1

Bennett Niceswanger explained the difference between an RC-1 and an RC-3.

On the motion of Amy Brown-Thompson and seconded by Rachel Elsea, the Records Commission voted to approve the following:

Upon a voice vote, the motion was approved with 4 in favor, 0 opposed, and 1 absent.

#### Review of RC-2's

Bennett Niceswanger stated that the proposed RC-2 from the Board of Elections reflected the most recent suggested retention periods which is published by the Ohio Secretary of State.

Bennett Niceswanger also noted that the proposed RC-2 from the Sheriff's Office contains updates to records titles and descriptions, as well as retention periods.

On the motion of Rachel Elsea and seconded by Amy Brown-Thompson, the Records Commission voted to approve the following:

- Fairfield County Board of Elections RC-2
- Fairfield County Sheriff's Office RC-2

Upon a voice vote, the motion was approved with 4 in favor, 0 opposed, and 1 absent.

#### Review of RC-3's

Bennett Niceswanger stated that all RC-3's for review before the Records Commission today had been reviewed and compared with each department's current RC-2 by himself prior to the meeting, and all appeared to comply with current retention schedules.

Bennett added that one of the RC-3's from the Board of Elections contained documents that were past their retention. A recent statewide public records request had placed the records on litigation hold. The Board of Elections is requesting the document be approved so the records may be destroyed once the litigation hold is lifted.

Amy Brown-Thompson stated that many municipalities have similar holds on their records and added that they are not sufficient requests. The Board of Elections will issue a response back and does not anticipate a follow-up request.
