MEETING NOTES

1. Kent Huston called the meeting to order at 2:30 PM. A motion was made by Jonathan Ferbrache and seconded by Ira Weiss to approve the minutes of the June 21, 2021 meeting minutes.
2. Chairman's Report
Kent Huston welcomed everyone and introductions of the attendees was made.
3. Subdivision Review
 - Heron Crossing West Subdivision Section 2 Final Plat Mr. Mako gave an overview of the Heron Crossing West Section 2 final plat. The Subdivision is located in Violet Township east of Pickerington Road. The subdivision has several issues that need to be worked out before RPC can move forward. The plat is showing a 10' multi use path along Pickerington Road and a 8' multi use path within a reserve.
 - Soring Creek Section 3 Phase 3A Subdivision Final Plat Mr. Mako gave an overview of the Spring Creek Section 3 Phase 3A final plat. The Subdivision is located in Violet Township west of Pickerington Road. This development will include a 8' multi use path along the south and east portion of the subdivision and will connect to Pickerington Road.
 - Mr. Mako gave an overview of the Meadow Moore Reserve Section 2 Phases 1 & 2 final plat. The Subdivision is located in Violet Township east of Pickerington Road. The subdivision has several issues that need to be worked out before RPC can move forward. The plat is Mr. Mako gave an overview of the Heron Crossing West Section 2 final plat. The Subdivision is located in Violet Township south of Blacklick-Eastern Road, west of Ault Road. The subdivision will still need to have construction drawings submitted before it can go forward. The subdivision will have 5' sidewalks throughout both phases of the development.
 - Mr. Mako also gave an update on the proposed Hagy Subdivision in Licking County and how it ties into New England Acres in Violet Township.

4. Membership Update- Mr. Mako updated the committee on the full RPC taking action to approve Terry and Jonett as full members of the Active Transportation Subcommittee. Robin Duffee will be on the agenda for RPC's next monthly meeting to officially become a member of the Active Transportation Committee.

5. Other Business

Mr. Mako mentioned that there will be an update to the Fairfield Growing Plan. Mr. Mako also mentioned that there have been discussions with the developer of the South Hampton Subdivision and the developer has indicated that they will incorporate the recommendations of the ATC into their preliminary plan.
