After completing my first year as President of the Fairfield County Regional Planning Commission (RPC), I am pleased to present the 2012 Annual Report. This report outlines the RPC's 2012 services and accomplishments.

In 2012, Fairfield County was awarded a Neighborhood Revitalization Program Grant in the amount of \$300,000 that will be applied towards public improvements in the Village of Pleasantville. The RPC staff successfully completed this grant application and will also provide administrative services for this grant on behalf of the County Commissioners.


The RPC continued to coordinate the meetings for the Fairfield County Local Food Council. This Council emerged from the Fairfield Growing Plan, which was prepared by the Regional Planning Commission. The Local Food Council has been successful in connecting many existing food related businesses in Fairfield County.

The RPC Active Transportation Sub-Committee also continued to meet in 2012. This Committee established Share the Road sign criteria, which has been incorporated into the County Engineer's Highway Signing Policy. In 2012, Share the Road signs were installed on various county roads that meet these criteria.

The RPC also continued to assist several of our communities in zoning code updates and continued its daily community development activities for the county.
