**ITEM 4a. SUBDIVISION:** Violet Meadows- Section 3 – Replat of lots 83 and 84.

**OWNER/DEVELOPER:** Violet Meadows, Inc.

SURVEYOR/ENGINEER: J & J Surveying, c/o John Wetherill

**LOCATION AND DECRIPTION:** The Violet Meadows subdivision is located on the north side of SR 204 in Sections 23 and 24, Township 16, Range 20 of Violet Township. The section 3 Final Plat was approved by the Regional Planning Commission on September 2, 2003 and recorded on May 18, 2004. Central water and sewer services are provided by the Fairfield County Utilities Department.

**SUBDIVISION REGULATIONS COMMITTEE RECOMMENDATION:** The Subdivision Regulations Committee recommends approval of the Violet Meadows, Section 3, Re-Plat of Lots 83 and 84, subject to complying with the requirements of the County Engineer's Office, County Sanitary Engineer, Soil and Water Conservation District, Fairfield County GIS, and Violet Township Zoning. Sidewalks must be constructed across lots 83 and 84 as required by the construction drawings.
