

## Fairfield County Utilities 2026 Water/Wastewater System Line Charges

Line Charges cover the user's portion of the installation cost of the water mains and storage tanks plus annual interest charges from the date of installation, in accordance with County Utilities Policy. The purpose of Line Charges is to establish equitable charges to non-participating properties for County financed main line water installations.
